A Resolution praising the life and public career of the late State Senator Walt Allen; extending sincere and heartfelt condolences to his family; and directing distribution.

WHEREAS, Walt Allen was born in Marlow, Oklahoma, on December 4, 1911. He attended Central State College and graduated from George Washington School of Law; and

WHEREAS, Walt Allen married Lela Fae Zachary on June 20, 1936, in Marlow, Oklahoma. The couple had two sons; and

WHEREAS, Walt Allen was an Army colonel during World War II and was involved in the International War Crime trials in Japan in 1945 and 1946; and

WHEREAS, Walt Allen was an active supporter of Congressman Jed Johnson, Sr., and served as an auditor for the U.S. Treasury Department; and

WHEREAS, Walt Allen served in the Oklahoma State Senate from 1950 until 1964. While in the Oklahoma State Senate, Walt Allen served on a number of standing committees including Agriculture; Appropriations; Constitutional Amendments; County Government; Education; Higher Education; Initiative and Referendum and Code Revision; Roads and Highways and Public Safety; Revenue and Taxation; Rules and Committees; and Social Welfare. Senator Allen also served as Vice Chair of the Public Safety Committee and Chair of Business and Industry; Employment and Printing; Game and Fish; and Public Service Corporations; and

WHEREAS, Walt Allen served on the Board of Regents of the University of Science and Arts of Oklahoma and the Oklahoma State Personnel Board; and

WHEREAS, Walt Allen was a farmer and rancher who was named Chickasha's Outstanding Citizen in 1957; and

WHEREAS, Walt Allen was active in a number of civic and service organizations including Kiwanis, Lions, Chamber of Commerce, Disabled American Veterans, Veterans of Foreign Wars, and American Legion; and

WHEREAS, Walt Allen died September 6, 1996. He is survived by his wife, Constance; two sons, Don and Richard; four grandsons; and three great granddaughters.

NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE 1ST SESSION OF THE 46TH OKLAHOMA LEGISLATURE:
