AS INTRODUCED

An Act relating to business regulatory entities;  
making appropriation to the State Department of  
Agriculture; stating purpose; making appropriation  
to the Insurance Department; stating purpose;  
making appropriation to the Department of Labor;  
stating purpose; making appropriation to the Board  
of Private Vocational Schools; stating purpose;  
making appropriation to the Horse Racing  
Commission; stating purpose; providing a lapse  
date; providing an effective date; and declaring an  
emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. There is hereby appropriated to the State Department  
of Agriculture from any monies not otherwise appropriated from the  
General Revenue Fund of the State Treasury for the fiscal year  
ending June 30, 1998, the sum of \_\_\_\_\_ Dollars (\$0.00) or so  
much thereof as may be necessary to perform the duties imposed upon  
the State Department of Agriculture by law.

SECTION 2. There is hereby appropriated to the Insurance Department from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1998, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary to perform the duties imposed upon the Insurance Department by law.

SECTION 3. There is hereby appropriated to the Department of Labor from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1998, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Labor by law.

SECTION 4. There is hereby appropriated to the Board of Private Vocational Schools from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1998, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary to perform the duties imposed upon the Board of Private Vocational Schools by law.

SECTION 5. There is hereby appropriated to the Horse Racing Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1998, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary to perform the duties imposed upon the Horse Racing Commission by law.

SECTION 6. The appropriations made by Sections 1, 2, 3, 4, and 5 of this act shall be subject to fiscal year limitations and may be encumbered through June 30, 1998. Any unexpected funds remaining after November 15, 1998, shall lapse and be transferred to the credit of the proper fund for the then current fiscal year.

SECTION 7. This act shall become effective July 1, 1997.

SECTION 8. It being immediately necessary for the preservation of the public peace, health and safety, an emergency is hereby

declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.
