AS INTRODUCED

An Act relating to various health services agencies;
making appropriations to the State Department of
Health, the Oklahoma Health Care Authority, the
J.D. McCarty Center for Children with Developmental
Disabilities, the Department of Mental Health and
Substance Abuse Services, the University Hospitals
Authority, and the Department of Veterans Affairs;
making certain appropriations subject to fiscal
year limitations; providing lapse date; providing
an effective date; and declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

STATE DEPARTMENT OF HEALTH

SECTION 1. There is hereby appropriated to the State Department
of Health from any monies not otherwise appropriated from the
General Revenue Fund of the State Treasury for the fiscal year
ending June 30, 1998, the sum of ____ Dollars (\$0.00) or so much

thereof as may be necessary to perform the duties imposed upon the State Department of Health by law.

OKLAHOMA HEALTH CARE AUTHORITY

SECTION 2. There is hereby appropriated to the Oklahoma Health Care Authority from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1998, the sum of _____ Dollars (\$0.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Health Care Authority by law.

J.D. MCCARTY CENTER FOR CHILDREN WITH DEVELOPMENTAL DISABILITIES

SECTION 3. There is hereby appropriated to the J.D. McCarty Center for Children with Developmental Disabilities from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1998, the sum of _____ Dollars (\$0.00) or so much thereof as may be necessary to perform the duties imposed upon the J.D. McCarty Center for Children with Developmental Disabilities by law.

DEPARTMENT OF MENTAL HEALTH AND SUBSTANCE ABUSE SERVICES

SECTION 4. There is hereby appropriated to the Department of Mental Health and Substance Abuse Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1998, the sum of _____ Dollars (\$0.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Mental Health and Substance Abuse Services by law.

UNIVERSITY HOSPITALS AUTHORITY

SECTION 5. There is hereby appropriated to the University Hospitals Authority from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1998, the sum of _____ Dollars (\$0.00) or so much thereof as may be necessary to perform the duties imposed upon the University Hospitals Authority by law.

DEPARTMENT OF VETERANS AFFAIRS

SECTION 6. There is hereby appropriated to the Department of Veterans Affairs from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1998, the sum of ____ Dollars (\$0.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Veterans Affairs by law.

SECTION 7. The appropriations made by Sections 1, 2, 3, 4, 5, and 6 of this act shall be subject to fiscal year limitations and may be encumbered through June 30, 1998. Any unexpended funds remaining after November 15, 1998, shall lapse and be transferred to the credit of the proper fund for the then current fiscal year.

SECTION 8. This act shall become effective July 1, 1997.

SECTION 9. It being immediately necessary for the preservation of the public peace, health and safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.
