AS INTRODUCED

An Act relating to defunct entities; repealing Section 1, Chapter 78, O.S.L. 1995, which relates to the Charter Schools Task Force; repealing Section 20, Chapter 346, O.S.L. 1995, which relates to the Joint Legislative Committee to Study the Feasibility of Child Support Enforcement and Collection Through Private Contractors; repealing Section 1, p. 2129, of Senate Joint Resolution No. 29 of the 1st Session of the 45th Oklahoma Legislature, which relates to the Electric Utility Task Force; repealing Section 2, Chapter 157, O.S.L. 1996, which relates to the Task Force to Study the Feasibility for Developing Levels of Certification for Home Health Aides; repealing Section 15, Chapter 301, O.S.L. 1996, which relates to the Task Force to Study Fees for Indigent Legal Services; repealing Section 1, Chapter 312, O.S.L. 1995, which relates to the Public Health Insurance Plan Reserves Task Force; repealing Sections 1, 2, 3 and 4, p. 1872, of Senate Joint Resolution No. 34 of the 2nd Session of the 45th Oklahoma Legislature, which relate to the Jails Task Force; repealing Section 1, Chapter 295, O.S.L. 1994, which relates to the Task Force on State Agency

Legal Services; repealing Section 6, Chapter 323, O.S.L. 1996, which relates to the Joint Legislative Oversight Committee on Local Government Finance and Accountability; repealing Section 5, Chapter 319, O.S.L. 1996, which relates to the Residency Funding Task Force; repealing Section 7, Chapter 346, O.S.L. 1995, which relates to the Joint Legislative Task Force to Study Welfare Self-Sufficiency Issues; repealing Section 21, Chapter 340, O.S.L. 1995, which relates to the Worker Training Development and Loan Financing Advisory Task Force; repealing Section 38, Chapter 1, 2nd Extraordinary Session, O.S.L. 1994 (85 O.S. Supp. 1996, Section 113), which relates to the Advisory Committee on Workers' Compensation; repealing Section 1, Chapter 113, O.S.L. 1995, and Section 2, Chapter 113, O.S.L. 1995, as amended by Section 4, Chapter 350, O.S.L. 1995 (63 O.S. Supp. 1996, Sections 2818.2 and 2818.3), which relate to the Statewide Emergency 911 Advisory Committee; and declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. REPEALER Section 1, Chapter 78, O.S.L. 1995, is hereby repealed.

SECTION 2. REPEALER Section 20, Chapter 346, O.S.L. 1995, is hereby repealed.

SECTION 3. REPEALER Section 1, p. 2129, of Senate Joint Resolution No. 29 of the 1st Session of the 45th Oklahoma Legislature, is hereby repealed.

SECTION 4. REPEALER Section 2, Chapter 157, O.S.L. 1996,  
is hereby repealed.

SECTION 5. REPEALER Section 15, Chapter 301, O.S.L.  
1996, is hereby repealed.

SECTION 6. REPEALER Section 1, Chapter 312, O.S.L. 1995,  
is hereby repealed.

SECTION 7. REPEALER Sections 1, 2, 3 and 4, p. 1872, of  
Senate Joint Resolution No. 34 of the 2nd Session of the 45th  
Oklahoma Legislature, are hereby repealed.

SECTION 8. REPEALER Section 1, Chapter 295, O.S.L. 1994,  
is hereby repealed.

SECTION 9. REPEALER Section 6, Chapter 323, O.S.L. 1996,  
is hereby repealed.

SECTION 10. REPEALER Section 5, Chapter 319, O.S.L.  
1996, is hereby repealed.

SECTION 11. REPEALER Section 7, Chapter 346, O.S.L.  
1995, is hereby repealed.

SECTION 12. REPEALER Section 21, Chapter 340, O.S.L.  
1995, is hereby repealed.

SECTION 13. REPEALER Section 38, Chapter 1, 2nd  
Extraordinary Session, O.S.L. 1994 (85 O.S. Supp. 1996, Section  
113), is hereby repealed.

SECTION 14. REPEALER Section 1, Chapter 113, O.S.L.  
1995, and Section 2, Chapter 113, O.S.L. 1995, as amended by Section  
4, Chapter 350, O.S.L. 1995 (63 O.S. Supp. 1996, Sections 2818.2 and  
2818.3), are hereby repealed.

SECTION 15. It being immediately necessary for the preservation  
of the public peace, health and safety, an emergency is hereby  
declared to exist, by reason whereof this act shall take effect and  
be in full force from and after its passage and approval.
