CONFERENCE COMMITTEE SUBSTITUTE

An Act relating to budgeting; amending Section 8, Chapter 265, O.S.L. 1999, which relates to budgetary limitations of the State Fire Marshal; modifying certain budgetary limitations; amending Section 17, Chapter 249, O.S.L. 1999, which relates to salary limitations of the Oklahoma Department of Tourism and Recreation; modifying certain salary limits; amending Section 4, Chapter 258, O.S.L. 1999, which relates to salary limitations of the Corporation Commission; modifying certain salary limits; and declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

STATE FIRE MARSHAL

SECTION 1. AMENDATORY Section 8, Chapter 265, O.S.L. 1999, is amended to read as follows:

Section 8. For the fiscal year ending June 30, 2000, the State Fire Marshal shall budget all funds in the following categories and amounts:

The State Fire Marshal shall develop outcome-based performance measures for each budget category.

The State Fire Marshal shall expend Thirty-three Thousand Five Hundred Seventy-four Dollars (\$33,574.00) for prior year obligations.

SECTION 2. AMENDATORY Section 17, Chapter 249, O.S.L. 1999, is amended to read as follows:

Section 17. Of the unclassified employee positions utilized by the Oklahoma Tourism and Recreation Department the annual compensation for the unclassified employee positions listed below during the fiscal year ending June 30, 2000, shall be subject to the following maximum salaries paid per annum:

SECTION 3. AMENDATORY Section 4, Chapter 258, O.S.L.

1999, is amended to read as follows:

Section 4. The authorized number and maximum annual salary, payable monthly, for the unclassified employee positions specified in this section utilized in the operation of the Corporation Commission shall not exceed the numbers and salary maximums set forth in this section. The amounts listed do not constitute an

appropriation but are listed to establish maximums only for the fiscal year ending June 30, 2000.
