CONFERENCE COMMITTEE SUBSTITUTE

An Act relating to budgeting; amending Section 3, Chapter 241, O.S.L. 1998, which relates to budgetary limitations of the Oklahoma Military Department; modifying certain budgetary limitations; amending Section 16, Chapter 275, O.S.L. 1998, which relates to budgetary limitations of the Oklahoma Indigent Defense System; modifying certain budgetary limitations; and declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY Section 3, Chapter 241, O.S.L. 1998, is amended to read as follows:

Section 3. For the fiscal year ending June 30, 1999, the Military Department of the State of Oklahoma shall budget all funds in the following categories and amounts:

SECTION 2.      AMENDATORY      Section 16, Chapter 275, O.S.L.  
1998, is amended to read as follows:

Section 16. For the fiscal year ending June 30, 1999, the Oklahoma Indigent Defense System shall budget all funds in the following categories and amounts:
