COMMITTEE SUBSTITUTE

An Act relating to public health and safety; amending Section 49, Chapter 284, O.S.L. 1992, and Section 50, Chapter 284, O.S.L. 1992, as amended by Section 6, Chapter 199, O.S.L. 1997 (63 O.S. Supp. 1999, Sections 4210.6 and 4210.7), which relate to the Oklahoma Boating Safety Regulation Act; restricting sitting or riding on bow of vessel above certain speeds unless vessel is equipped in specified ways; and declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY Section 49, Chapter 284, O.S.L. 1992 (63 O.S. Supp. 1999, Section 4210.6), is amended to read as follows:

Section 4210.6 No person shall sit or ride on the sides of a any vessel, a covered bow or the back of any seat of a vessel, or stand in a vessel while under way at any speed greater than idle or trolling speed; ~~provided, however, the operator of such vessel may stand if said vessel is specifically designed to be operated from a standing position.~~ No person shall sit or ride on a covered bow of any vessel while under way at any speed greater than idle or trolling speed unless such vessel is equipped with either built-in seating or is equipped with side walkways or factory-equipped walk-through areas to a flat foredeck surrounded by life rails, deck rails, stern rails, bow rails, or other such coamings, gunwales, bulwarks, or enclosures extending at least twenty-four (24) inches above the deck; provided that no person riding on a covered bow shall extend any appendage over the edge of the vessel either above

or below the bow rail. No person shall stand on the foredeck of any vessel while under way at a speed greater than idle or trolling speed, and any person under twelve (12) years of age shall not be on the foredeck of any vessel without wearing a life jacket and being accompanied on the foredeck by an adult.

SECTION 2. AMENDATORY Section 50, Chapter 284, O.S.L. 1992, as amended by Section 6, Chapter 199, O.S.L. 1997 (63 O.S. Supp. 1999, Section 4210.7), is amended to read as follows:

Section 4210.7 No operator shall allow any person to occupy the front or back deck of any vessel while under way at any speed greater than idle or trolling speed unless such vessel is equipped with either built-in seating or is equipped with side walkways or factory-equipped walk-through areas to a flat deck surrounded by life rails, deck rails, stern rails, bow rails, or other such coamings, gunwales, bulwarks, or enclosures extending at least twenty-four (24) inches above the deck.

SECTION 3. It being immediately necessary for the preservation of the public peace, health and safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.
