An Act relating to general appropriations for the expenses of various agencies of the executive, legislative and judicial departments of the state; making appropriations to the Oklahoma Arts Council, the State Board of Education, the Oklahoma Educational Television Authority, the Oklahoma State Regents for Higher Education, the Commissioners of the Land Office, the Oklahoma Department of Libraries, the Physician Manpower Training Commission, the Oklahoma Board of Private Vocational Schools, the Board of Trustees of the Oklahoma School of Science and Mathematics, the Oklahoma Center for the Advancement of Science and Technology, the Oklahoma Commission for Teacher Preparation, the State Board of Vocational and Technical Education, the Office of the State Auditor and Inspector, the Rural Economic Action Plan Fund of the State Treasury, the Department of Central Services, the Department of Civil Emergency Management, the State Election Board, the Office of State Finance, the Office of the Governor, the Oklahoma House of Representatives, the Legislative Service Bureau, the Office of the Lieutenant Governor, the Oklahoma Merit Protection Commission, the Military Department, the Office of Personnel Management, the Office of the Secretary of State, the Oklahoma State Senate, the Oklahoma Tax Commission, the Office of the State Treasurer, the Oklahoma Commission on Children and Youth, the Office of Handicapped Concerns, the State Department of Health, the Oklahoma Human Rights Commission, the Oklahoma Indian Affairs Commission, the J.D. McCarty Center for Children with Developmental Disabilities, the Department of Mental Health and Substance Abuse Services, the Oklahoma Department of Veterans Affairs, the Oklahoma Health Care Authority, the Department of Human Services, the State Department of Rehabilitation Services, the University Hospitals Authority, the Office of Juvenile Affairs, the State Department of Agriculture, the Oklahoma Conservation Commission, the Oklahoma Historical Society, the J.M. Davis Memorial Commission, the Oklahoma Liquefied Petroleum Gas Board, the State Department of Mines, the Oklahoma Tourism and Recreation Department, the Oklahoma Water Resources Board, the Will Rogers Memorial Commission, the State Banking Department,

the Oklahoma Department of Commerce, the Department of Consumer Credit, the Corporation Commission, the Department of Environmental Quality, the Oklahoma Horse Racing Commission, the State Insurance Department, the Oklahoma Department of Labor, the Oklahoma Securities Commission, the Office of the Attorney General, the Court of Criminal Appeals, the Ethics Commission, the Oklahoma Indigent Defense System, the Council on Judicial Complaints, the Supreme Court, the Workers' Compensation Court, the Alcoholic Beverage Laws Enforcement Commission, the Department of Corrections, the State Fire Marshal, the Oklahoma State Bureau of Investigation, the Council on Law Enforcement Education and Training, the Board of Medicolegal Investigations, the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control, the Pardon and Parole Board, the Department of Public Safety and the Department of Transportation; stating sums of the appropriations; stating purposes and restrictions; authorizing and requiring certain expenditures; making appropriations nonfiscal; providing lapse dates; requiring certain budget procedures; prohibiting certain budget procedures; and providing effective dates.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SUBCOMMITTEE ON EDUCATION

SECTION 1. There is hereby appropriated to the Oklahoma Arts Council from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of Four Million One Hundred Five Thousand Four Hundred Ninety-seven Dollars (\$4,105,497.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Arts Council by law.

SECTION 2. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of One Billion One Hundred Thirty-six Million Nine Hundred Thirteen Thousand Six Hundred Seventeen Dollars (\$1,136,913,617.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 3. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Common Education Technology Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of Nineteen Million Three Hundred Ninety-one Thousand Two Hundred Forty-nine Dollars (\$19,391,249.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 4. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Common Education Technology Fund of the State Treasury for the fiscal year ending June 30, 2000, the sum of Fifteen Million Three Hundred

Fifty-eight Thousand Five Hundred Sixty-four Dollars (\$15,358,564.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 5. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Common Education Technology Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of One Million Six Hundred Ninety-six Thousand Nine Hundred Forty-six Dollars (\$1,696,946.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 6. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Education Reform Revolving Fund created in Section 41.29b of Title 62 of the Oklahoma Statutes, the sum of Three Hundred Seventy-four Million Eight Hundred Seventy-seven Thousand Eight Hundred Seventy-eight Dollars (\$374,877,878.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 7. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Mineral Leasing Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of Seven Hundred Twelve Thousand Five Hundred Dollars (\$712,500.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 8. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Mineral Leasing Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of One Hundred Eighty-four Thousand Eighty-seven Dollars (\$184,087.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 9. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of One Hundred Two Million One Hundred Seventy-five Thousand Four Hundred Ninety-one Dollars (\$102,175,491.00) or so much thereof as may be necessary for the support of public school activities.

SECTION 10. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of Four Million Six Hundred Six Thousand Dollars (\$4,606,000.00) or so much thereof as may be necessary for the support of public school activities.

SECTION 11. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of Nineteen Million One Hundred Ninety-six Thousand Four Hundred Forty-eight Dollars (\$19,196,448.00) or so much thereof as may be necessary for the purchase of textbooks.

SECTION 12. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year

ending June 30, 2001, the sum of Two Hundred Fifty-eight Thousand One Hundred Twenty-two Dollars (\$258,122.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of Accountability by law.

SECTION 13. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of Twenty Million Ninety-two Thousand Eight Hundred Ninety-one Dollars (\$20,092,891.00) or so much thereof as may be necessary for Administrative and Support Functions of the State Department of Education.

SECTION 14. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of Thirty Million Six Hundred Nine Thousand Eight Hundred Thirty-two Dollars (\$30,609,832.00) or so much thereof as may be necessary for the Certified Employee Health Benefit Allowance.

SECTION 15. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of Forty-two Million Seventy Thousand Three Hundred Ninety Dollars (\$42,070,390.00) or so much thereof as may be necessary for the Support Personnel Health Benefit Allowance.

SECTION 16. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of Thirty-five Thousand Dollars (\$35,000.00) which shall be transferred to the Oklahoma National Board Certification Revolving Fund created in Section 6-204.4 of Title 70 of the Oklahoma Statutes for the purpose of awarding annual bonuses as directed.

SECTION 17. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of Two Million Four Hundred Seventeen Thousand Six Hundred Seventy-nine Dollars (\$2,417,679.00) or so much thereof as may be necessary for the Certified Employee Health Benefit Allowance for the school year ending June 30, 2000.

SECTION 18. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of Three Million One Hundred Seventy-seven Thousand One Hundred Fifty Dollars (\$3,177,150.00) or so much thereof as may be necessary for the Support Personnel Health Benefit Allowance for the school year ending June 30, 2000.

SECTION 19. There is hereby appropriated to the Oklahoma Educational Television Authority from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of Three Million Five Hundred Three Thousand Seventeen Dollars (\$3,503,017.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Educational Television Authority by law.

SECTION 20. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of Six Hundred Thirty-four Million Eight Hundred Ninety-one Thousand Nine Hundred Three Dollars (\$634,891,903.00) or so much thereof as may be necessary for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 21. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the Higher Education Capital Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of Nineteen Million Three Hundred Ninety-one Thousand Two Hundred Forty-nine Dollars (\$19,391,249.00) or so much thereof as may be necessary for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 22. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the Higher Education Capital Fund of the State Treasury for the fiscal year ending June 30, 2000, the sum of Fifteen Million Three Hundred Fifty-eight Thousand Five Hundred Sixty-four Dollars (\$15,358,564.00) or so much thereof as may be necessary for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 23. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the Higher Education Capital Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of One Million Six Hundred Ninety-six Thousand Nine Hundred Forty-six Dollars (\$1,696,946.00) or so much thereof as may be necessary for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 24. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of Sixty-seven Million Four Hundred Seventy-six Thousand One Hundred Thirteen Dollars (\$67,476,113.00) or so much thereof as may be necessary for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma

Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 25. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the proceeds of the sale of bonds deposited in the Oklahoma Building Bonds of 1992 Fund A in the State Treasury, the sum of Two Hundred Twenty-five Thousand Nine Hundred Eighty-seven Dollars (\$225,987.00) or so much thereof as may be necessary for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Constitution of the State of Oklahoma for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 26. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the proceeds of the sale of bonds deposited in the Oklahoma Building Bonds of 1992 Fund B in the State Treasury, the sum of One Hundred Eleven Thousand Three Hundred Seventy-six Dollars (\$111,376.00) or so much thereof as may be necessary for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Constitution of the State of Oklahoma for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 27. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury the sum of Four Million Five Hundred Seventy-two Thousand Five Hundred Four Dollars (\$4,572,504.00) or so much thereof as may be necessary for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Constitution of the State of Oklahoma for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 28. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of Four Million Nine Hundred Twenty-one Thousand One Hundred Three Dollars (\$4,921,103.00) or so much thereof as may be necessary for the general operating budget of the Administrative Offices of the Oklahoma State Regents for Higher Education.

SECTION 29. There is hereby appropriated to the Commissioners of the Land Office from any monies not otherwise appropriated from the Commissioners of the Land Office Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of Three Million Four Hundred Thirty-two Thousand Nine Hundred Eighty-three Dollars (\$3,432,983.00) or so much thereof as may be necessary to perform the duties imposed upon the Commissioners of the Land Office by law.

SECTION 30. There is hereby appropriated to the Commissioners of the Land Office from any monies not otherwise appropriated from the Commissioners of the Land Office Fund of the State Treasury for the fiscal year ending June 30, 2000, the sum of Eight Hundred Thousand Seven Hundred Eighty Dollars (\$800,780.00) or so much thereof as may be necessary to perform the duties imposed upon the Commissioners of the Land Office by law.

SECTION 31. There is hereby appropriated to the Oklahoma Department of Libraries from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of Six Million Seven Hundred Ten Thousand Five Hundred Eighty-six Dollars (\$6,710,586.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Department of Libraries by law.

SECTION 32. There is hereby appropriated to the Physician Manpower Training Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of Five Million Forty-nine Thousand Six Hundred Sixty Dollars (\$5,049,660.00) or so much thereof as may be necessary to perform the duties imposed upon the Physician Manpower Training Commission by law.

SECTION 33. There is hereby appropriated to the Physician Manpower Training Commission from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury the sum of Four Hundred Thousand Dollars (\$400,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Physician Manpower Training Commission by law.

SECTION 34. There is hereby appropriated to the Oklahoma Board of Private Vocational Schools from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of One Hundred Sixty-nine Thousand One Hundred Seventeen Dollars (\$169,117.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Board of Private Vocational Schools by law.

SECTION 35. There is hereby appropriated to the Board of Trustees of the Oklahoma School of Science and Mathematics from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of Four Million Seven Hundred Thirteen Thousand One Hundred Three Dollars (\$4,713,103.00) or so much thereof as may be necessary to perform the duties imposed upon the Board of Trustees of the Oklahoma School of Science and Mathematics by law.

SECTION 36. There is hereby appropriated to the Oklahoma Center for the Advancement of Science and Technology from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of Eleven Million Six Hundred Fifty-eight Thousand Forty-one Dollars (\$11,658,041.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Center for the Advancement of Science and Technology by law.

SECTION 37. There is hereby appropriated to the Oklahoma Commission for Teacher Preparation from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for

the fiscal year ending June 30, 2001, the sum of One Million Six Hundred Four Thousand Nine Hundred Twenty-five Dollars (\$1,604,925.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Commission for Teacher Preparation by law.

SECTION 38. There is hereby appropriated to the State Board of Vocational and Technical Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of One Hundred Fifteen Million Eight Hundred Twenty Thousand Six Hundred Eighty-nine Dollars (\$115,820,689.00) or so much thereof as may be necessary to perform the duties imposed upon the State Board of Vocational and Technical Education by law.

#### SUBCOMMITTEE ON GENERAL GOVERNMENT

SECTION 39. There is hereby appropriated to the Office of the State Auditor and Inspector from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of Five Million Four Hundred Ninety-six Thousand Eight Hundred Seventy-three Dollars (\$5,496,873.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the State Auditor and Inspector by law.

SECTION 40. There is hereby appropriated to the Office of the State Auditor and Inspector from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of Five Hundred Thirty-four Thousand Ninety-one Dollars (\$534,091.00) or so much thereof as may be necessary to perform the duties imposed upon the Commission on County Government Personnel Education and Training. The appropriation made in this section shall be expended exclusively for the purpose so stated and shall not be transferable.

SECTION 41. There is hereby appropriated to the Office of the State Auditor and Inspector from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of Forty-five Thousand Dollars (\$45,000.00) or so much thereof as may be necessary to provide uniform computer systems development, including computer software for county government, in accordance with the State Auditor and Inspector's duties to prescribe accounting procedures and to provide technical assistance to county government. The appropriation made in this section shall be expended exclusively for the purpose so stated and shall not be transferable.

SECTION 42. There is hereby appropriated to the Rural Economic Action Plan Fund of the State Treasury from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of Fifteen Million Five Hundred Thousand Dollars (\$15,500,000.00) or so much thereof as may be necessary to implement the provisions of Section 2006 through 2013 of Title 62 of the Oklahoma Statutes.

SECTION 43. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of Eight Million Two Hundred Fifty-

seven Thousand Thirteen Dollars (\$8,257,013.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Central Services by law.

SECTION 44. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of Three Million Eight Hundred Thirty Thousand One Hundred Seventeen Dollars (\$3,830,117.00) to be transferred to the Building and Facility Revolving Fund created in Section 63.1 of Title 74 of the Oklahoma Statutes for the purpose of maintaining state buildings operated by the Department of Central Services.

SECTION 45. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of Four Thousand Eight Hundred Seventy-five Dollars (\$4,875.00) or so much thereof as may be necessary to perform maintenance on the Veterans Memorial within the Capitol complex.

SECTION 46. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the Public Building Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of One Million One Hundred Sixty-four Thousand Two Hundred Twenty-five Dollars (\$1,164,225.00) or so much thereof as may be necessary for asbestos abatement programs and for the expenses of filing claims for reimbursement from the Manville Property Damage Settlement Trust. The monies designated in this section shall be expended exclusively for the purposes so stated and shall not be transferable.

SECTION 47. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of One Hundred Ninety-two Thousand Seven Hundred Dollars (\$192,700.00) or so much thereof as may be necessary to maintain the Hissom Memorial Center.

SECTION 48. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of One Million Twenty-one Thousand Nineteen Dollars (\$1,021,019.00) or so much thereof as may be necessary for the Capitol restroom renovation.

SECTION 49. There is hereby appropriated to the Department of Civil Emergency Management from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of Seven Hundred Sixty-two Thousand Three Hundred Sixty-nine Dollars (\$762,369.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Civil Emergency Management by law.

SECTION 50. There is hereby appropriated to the State Election Board from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of Six Million Two Hundred Eighty-five Thousand Five Hundred Three Dollars (\$6,285,503.00) or so much thereof as may

be necessary to perform the duties imposed upon the State Election Board by law.

SECTION 51. There is hereby appropriated to the Office of the Attorney General for deposit in the Attorney General's Evidence Fund provided for in Section 19 of Title 74 of the Oklahoma Statutes from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury the sum of One Hundred Fifty Thousand Dollars (\$150,000.00) or so much thereof as may be necessary for expenses related to official responsibilities of the Attorney General.

SECTION 113. There is hereby appropriated to the Office of the Attorney General from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of Forty Thousand Dollars (\$40,000.00) or so much thereof as may be necessary for legal representation of the Public Employees Relations Board. The monies designated in this section shall be used exclusively for the purpose so stated and shall not be transferable.

SECTION 114. There is hereby appropriated to the Office of the Attorney General from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of Thirty Million Three Hundred Eight Thousand Sixty-seven Dollars (\$30,308,067.00) or so much thereof as may be necessary to perform the duties imposed upon the district attorneys and the District Attorneys Council by law.

SECTION 115. There is hereby appropriated to the Office of the Attorney General from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury the sum of Three Hundred Eighty Thousand Dollars (\$380,000.00) or so much thereof as may be required by the district attorneys and District Attorneys Council to pay witness fees as required by Section 82 of Title 28 of the Oklahoma Statutes.

SECTION 116. There is hereby appropriated to the Office of the Attorney General from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury the sum of Twenty-five Thousand Dollars (\$25,000.00) to be transferred to the District Attorneys Evidence Fund.

SECTION 117. There is hereby appropriated to the Court of Criminal Appeals from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of Two Million Six Hundred Thirty-eight Thousand One Hundred Twenty-two Dollars (\$2,638,122.00) or so much thereof as may be necessary to perform the duties imposed upon the Court of Criminal Appeals by law.

SECTION 118. There is hereby appropriated to the Ethics Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of Four Hundred Fifty-eight Thousand Seven Hundred Thirty Dollars (\$458,730.00) or so much thereof as may be necessary to perform the duties imposed upon the Ethics Commission by law.

SECTION 119. There is hereby appropriated to the Oklahoma Indigent Defense System from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of Fourteen Million Two Hundred Five Thousand One Hundred Eighty-one Dollars (\$14,205,181.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Indigent Defense System by law.

SECTION 120. There is hereby appropriated to the Council on Judicial Complaints from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury, for the fiscal year ending June 30, 2001, the sum of Two Hundred Ninety-seven Thousand Four Hundred Twenty-five Dollars (\$297,425.00) or so much thereof as

may be necessary to perform the duties imposed upon the Council on Judicial Complaints by law.

SECTION 121. There is hereby appropriated to the Supreme Court from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of Nine Million Six Thousand Five Hundred Twenty-two Dollars (\$9,006,522.00) or so much thereof as may be necessary to perform the duties imposed upon the District Courts by law.

SECTION 122. There is hereby appropriated to the Supreme Court from any monies not otherwise appropriated from the State Judicial Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of Twenty-one Million Four Hundred Six Thousand Seven Hundred Fifty-one Dollars (\$21,406,751.00) or so much thereof as may be necessary to perform the duties imposed upon the District Courts by law.

SECTION 123. There is hereby appropriated to the Supreme Court from any monies not otherwise appropriated from the State Judicial Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of Seven Million Nine Hundred Eleven Thousand Five Hundred Twenty-eight Dollars (\$7,911,528.00) or so much thereof as may be necessary to perform the duties imposed upon the District Courts by law.

SECTION 124. There is hereby appropriated to the Supreme Court from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of Ten Million Eight Hundred Ninety-seven Thousand Two Hundred Seven Dollars (\$10,897,207.00) or so much thereof as may be necessary to perform the duties imposed upon the Supreme Court or Court of Civil Appeals by law.

SECTION 125. There is hereby appropriated to the Supreme Court for deposit in the Supreme Court Revolving Fund from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury the sum of Nine Hundred Thousand Dollars (\$900,000.00) for expenditures authorized by Section 1310.1 of Title 20 of the Oklahoma Statutes.

SECTION 126. There is hereby appropriated to the Supreme Court from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of Six Hundred Thousand Dollars (\$600,000.00) to transfer to the Legal Services Revolving Fund created pursuant to subsection G of Section 921.1 of Title 12 of the Oklahoma Statutes.

SECTION 127. There is hereby appropriated to the Workers' Compensation Court from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of Four Million Forty-seven Thousand Five Hundred Four Dollars (\$4,047,504.00) or so much thereof as may be necessary to perform the duties imposed upon the Workers' Compensation Court by law.

SECTION 128. There is hereby appropriated to the Workers' Compensation Court from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury the sum of One Hundred Thousand Dollars (\$100,000.00) or so much thereof as may be

necessary to perform the duties imposed upon the Workers' Compensation Court by law.

SUBCOMMITTEE ON PUBLIC SAFETY AND TRANSPORTATION

SECTION 129. There is hereby appropriated to the Alcoholic Beverage Laws Enforcement Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of Three Million Nine Hundred Fifty-seven Thousand Eight Hundred Fifty Dollars (\$3,957,850.00) or so much thereof as may be necessary to perform the duties imposed upon the Alcoholic Beverage Laws Enforcement Commission by law.

SECTION 130. There is hereby appropriated to the Department of Corrections from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of Three Hundred Fifty-five Million Two Hundred Twenty-seven Thousand Five Hundred Thirty-five Dollars (\$355,227,535.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Corrections by law.

SECTION 131. There is hereby appropriated to the State Fire Marshal from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of One Million Seven Hundred Fifty Thousand Two Hundred Sixteen Dollars (\$1,750,216.00) or so much thereof as may be necessary to perform the duties imposed upon the State Fire Marshal by law.

SECTION 132. There is hereby appropriated to the Oklahoma State Bureau of Investigation from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of Ten Million Three Hundred Fifty-five Thousand Four Hundred Forty-five Dollars (\$10,355,445.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma State Bureau of Investigation by law.

SECTION 133. There is hereby appropriated to the Council on Law Enforcement Education and Training from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of Three Hundred Eighty-five Thousand Eight Hundred Sixty-nine Dollars (\$385,869.00) or so much thereof as may be necessary to perform the duties imposed upon the Council on Law Enforcement Education and Training by law.

SECTION 134. There is hereby appropriated to the Council on Law Enforcement Education and Training from any monies not otherwise appropriated from C.L.E.E.T. Fund for the fiscal year ending June 30, 2001, the sum of Two Million Two Hundred Sixty-nine Thousand Two Hundred Ninety Dollars (\$2,269,290.00) or so much thereof as may be necessary to perform the duties imposed upon the Council on Law Enforcement Education and Training by law.

SECTION 135. There is hereby appropriated to the Council on Law Enforcement Education and Training from any monies not otherwise appropriated from the C.L.E.E.T. Fund for the fiscal year ending June 30, 1999, the sum of One Hundred Seventy-eight Thousand Four Hundred Eighty Dollars (\$178,480.00) or so much thereof as may be

necessary to perform the duties imposed upon the Council on Law Enforcement Education and Training by law.

SECTION 136. There is hereby appropriated to the Board of Medicolegal Investigations from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of Three Million Three Hundred Sixty-seven Thousand Four Hundred Ninety-eight Dollars (\$3,367,498.00) or so much thereof as may be necessary to perform the duties imposed upon the Board of Medicolegal Investigations by law.

SECTION 137. There is hereby appropriated to the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of Five Million Five Hundred Sixty-six Thousand Six Hundred Thirty-six Dollars (\$5,566,636.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control by law.

SECTION 138. There is hereby appropriated to the Pardon and Parole Board from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of One Million Nine Hundred Fifty-six Thousand Two Hundred Twenty Dollars (\$1,956,220.00) or so much thereof as may be necessary to perform the duties imposed upon the Pardon and Parole Board by law.

SECTION 139. There is hereby appropriated to the Department of Public Safety from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of Sixty-six Million Three Hundred Twenty-eight Thousand Two Hundred Twelve Dollars (\$66,328,212.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Public Safety by law.

SECTION 140. There is hereby appropriated to the Department of Public Safety from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury the sum of One Million Five Hundred Thousand Dollars (\$1,500,000.00) or so much thereof as may be necessary for the purchase of motor vehicles.

SECTION 141. There is hereby appropriated to the Department of Public Safety from any monies not otherwise appropriated from the C.L.E.E.T. Fund for the fiscal year ending June 30, 1999, the sum of Two Hundred Twenty-three Thousand Three Hundred Fifty-eight Dollars (\$223,358.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Public Safety by law.

SECTION 142. There is hereby appropriated to the Department of Transportation from any monies not otherwise appropriated from the State Transportation Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of One Hundred Eighty-one Million Nine Hundred Eighty-eight Thousand One Hundred Twenty-six Dollars (\$181,988,126.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Transportation by law. Said appropriation shall be transferred to the State Highway Construction and Maintenance Fund and shall be expended in the same manner and for the same purposes as provided by law for other monies

accruing to the credit of the State Highway Construction and Maintenance Fund.

SECTION 143. There is hereby appropriated to the Department of Transportation from any monies not otherwise appropriated from the State Transportation Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of Nine Million One Hundred Sixty Thousand Three Hundred Thirty-nine Dollars (\$9,160,339.00) or so much thereof as may be necessary to perform the duties as set forth in Section 2002 of Title 69 of the Oklahoma Statutes. The appropriation set forth in this section shall be transferred to the State Highway Construction and Maintenance Fund.

SECTION 144. There is hereby appropriated to the Department of Transportation from any monies not otherwise appropriated from the State Transportation Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of Two Million Eight Hundred Twenty-five Thousand Eight Hundred Ninety-three Dollars (\$2,825,893.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Transportation by law. Said appropriation shall be transferred to the State Highway Construction and Maintenance Fund and shall be expended in the same manner and for the same purposes as provided by law for other monies accruing to the credit of the State Highway Construction and Maintenance Fund.

SECTION 145. There is hereby appropriated to the Department of Transportation from any monies not otherwise appropriated from the State Transportation Fund of the State Treasury for the fiscal year ending June 30, 2000, the sum of Four Thousand Six Hundred Thirty-seven Dollars (\$4,637.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Transportation by law. Said appropriation shall be transferred to the State Highway Construction and Maintenance Fund and shall be expended in the same manner and for the same purposes as provided by law for other monies accruing to the credit of the State Highway Construction and Maintenance Fund.

SECTION 146. There is hereby appropriated to the Department of Transportation from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2001, the sum of Thirty-three Million Seven Hundred Eighty-seven Thousand Three Hundred Thirty-nine Dollars (\$33,787,339.00) or so much thereof as may be necessary to perform the duties as set forth in Section 2002 of Title 69 of the Oklahoma Statutes. Said appropriation shall be transferred to the State Highway Construction and Maintenance Fund.

SECTION 147. Appropriations made by this act, not including appropriations made for capital outlay purposes, may be budgeted for the fiscal year ending June 30, 2001 (hereafter FY-01) or may be budgeted for the fiscal year ending June 30, 2002 (hereafter FY-02). Funds budgeted for FY-01 may be encumbered only through June 30, 2001, and must be expended by November 15, 2001. Any funds remaining after November 15, 2001, and not budgeted for FY-02, shall lapse to the credit of the proper fund for the then current fiscal year. Funds budgeted for FY-02 may be encumbered only through June 30, 2002. Any funds remaining after November 15, 2002, shall lapse to the credit of the proper fund for the then current fiscal year. These appropriations may not be budgeted in both fiscal years simultaneously. Funds budgeted in FY-01, and not required to pay

obligations for that fiscal year, may be budgeted for FY-02, after the agency to which the funds have been appropriated has prepared and submitted a budget work program revision removing these funds from the FY-01 budget work program and after such revision has been approved by the Office of State Finance.

SECTION 148. Sections 16 through 18 and 48 of this act shall become effective April 21, 2000.

SECTION 149. Sections 1, 9 through 15, 19 through 47 and 49 through 147 of this act shall become effective July 1, 2000.

SECTION 150. Sections 2 through 8 of this act shall become effective August 1, 2000.
