4 SENATE BILL NO. 863 - By: HARRISON of the Senate and EASLEY of the
5 House.

6 An Act relating to sunset; amending 74 O.S. 1991, Section
7 3907, as last amended by Section 2, Chapter 19, O.S.L. 1999
8 (74 O.S. Supp. 1999, Section 3907), which relates to the
9 2000 sunset list; modifying termination date; and adding
10 entity to list.

11 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

12 SECTION 1. AMENDATORY 74 O.S. 1991, Section 3907, as
13 last amended by Section 2, Chapter 19, O.S.L. 1999 (74 O.S. Supp.
14 1999, Section 3907), is amended to read as follows:

15 Section 3907. The following statutory entities and their
16 successors shall be terminated on July 1, ~~2000~~ 2006, and all powers,
17 duties and functions shall be abolished one (1) year thereafter:
