Supp. 1999, Section 601.50), which relates to the annual plan for comprehensive system of mental health services for children and youth; modifying appointing authority; repealing 10 O.S. 1991, Section 601.7, as last amended by Section 186, Chapter 352, O.S.L. 1995 (10 O.S.
