SENATE BILL NO. 413

AS INTRODUCED

An Act relating to schools and driving privileges; amending 47 O.S. 1991, Sections 6-103, as last amended by Section 2, Chapter 201, O.S.L. 1997, and 6-105, as last amended by Section 6, Chapter 2, O.S.L. 1997 (47 O.S. Supp. 1998, Sections 6-103 and 6-105), which relate to driver licenses; deleting obsolete language; providing for certain persons to drive during driver education sessions; modifying requirements for issuing certain driver licenses; modifying classes of licenses; providing age requirements for certain classes of driver licenses; restricting driving privileges for certain holders of certain classes of driver licenses; providing for removal of certain restrictions; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 47 O.S. 1991, Section 6-103, as last amended by Section 2, Chapter 201, O.S.L. 1997 (47 O.S. Supp. 1998, Section 6-103), is amended to read as follows:

Section 6-103. A. Except as otherwise provided by law, the Department of Public Safety shall not issue a driver's license to:

1. Any person who is under eighteen (18) years of age, except that the Department may issue a Class D license to any person who:

~~a. is sixteen (16) years of age before January 1, 1997,~~

~~or~~

~~b. attains sixteen (16) years of age on or after January 1, 1997~~ August 15, 2000, and meets the requirements of ~~Section~~ Sections 6-105 and 6-107.3 of this title;

2. Any unemancipated person who is ~~sixteen (16) or seventeen (17)~~ younger than eighteen (18) years of age and whose custodial parent or guardian objects to the issuance of a license or permit by filing an objection pursuant to Section 6-103.1 of this title;

3. Any person whose driving privilege has been suspended, revoked, canceled or denied in this state or any other state until the driving privilege has been reinstated by the state withdrawing the privilege;

4. Any person whose driving privilege has been revoked for a period of three (3) years pursuant to the provisions of paragraph 4 of Section 6-205.1 of this title, until the passage of the three-year period;

5. Any person who is required by Section 6-101 et seq. of this title to take an examination, unless the person shall have successfully passed the examination;

6. Any person who is required under the laws of this state to deposit proof of financial responsibility and who has not deposited such proof;

7. Any person who is physically deformed or who is afflicted with any mental disease or physical condition that would impair the driving ability of the person or when the Commissioner of Public Safety, from information concerning the person or from the records and reports on file in the Department of Public Safety, determines that the operation of a motor vehicle by such person on the highways would be inimical to public safety or welfare;

8. Any person who is a nonresident, as defined in Section 1-137 of this title;

9. Any alien unless such person presents valid documentation of identity issued pursuant to the laws of the United States; or

10. Any person who possesses a valid license to operate a motor vehicle issued by another state until the other state license has been surrendered.

B. Any applicant who is denied a license under the provisions of subsection A of this section shall have the right to an appeal as provided in Section 6-211 of this title.

SECTION 2. AMENDATORY 47 O.S. 1991, Section 6-105, as last amended by Section 6, Chapter 2, O.S.L. 1997 (47 O.S. Supp. 1998, Section 6-105), is amended to read as follows:

Section 6-105. A. Unless a custodial parent or guardian has filed an objection to licensure pursuant to Section 6-103.1 of this title, any person under sixteen (16) years of age may be permitted to operate a motor vehicle ~~as follows:~~ as provided in this section. Any secondary school student who is ~~at least fifteen and one-half (15 1/2) years of age~~ in compliance with Section 6-107.3 of this title and:

1. Is between fifteen (15) and fifteen and one-half (15 1/2) years of age may drive during a session in which the driver is being instructed in a driver education course by a certified driver education instructor who is seated in the right front seat of the motor vehicle;

2. Is at least fifteen and one-half (15 1/2) years of age and:

a. is currently receiving instruction in or has successfully completed:

~~a.~~ (1) a prescribed secondary school driver education course, as provided for in Sections 19-113 through 19-121 of Title 70 of the Oklahoma Statutes, ~~or~~

~~b.~~ (2) a driver education course, certified by the Department of Public Safety, from a parochial, private, or other nonpublic secondary school, or ~~e.~~ (3) a commercial driver training course, as defined by Sections 801 through 808 of this title, ~~or~~

~~2.~~ b. ~~Whose~~ whose parent or legal guardian has certified to the Department by sworn affidavit that the person will receive a minimum of twenty-five (25) hours of actual behind-the-wheel training from a licensed driver who is at least eighteen (18) years of age and who has

been properly licensed to operate a Class D motor vehicle for a minimum of two (2) years, may ~~apply for a restricted Class D license. The Department of Public Safety, after the person has successfully passed all parts of the examination other than the driving examination and is in compliance with Section 6-107.3 of this title, shall issue to the person a restricted Class D license which shall grant to the person, while having such license in his or her possession, the privilege to operate a Class D motor vehicle upon the public highways, upon successfully passing all parts of the driver license examination administered by the Department of Public Safety except the driving examination, be granted a Class D1 license which will grant the licensee the privilege to operate a Class D motor vehicle upon the public highways~~ while accompanied by a licensed driver who is at least eighteen (18) years of age and who is actually occupying a seat beside the ~~restricted~~ Class D1 licensee. ~~This restricted license Class D shall be issued for the same period as all other driver licenses. The restricted Class D license may be suspended or canceled at the discretion of the Department for violation of restrictions, for failing to give the required or correct information on the application or for violation of any traffic laws of this state pertaining to the operation of a motor vehicle. A restricted licensee who is;~~

3. Is at least sixteen (16) years of age and has not completed a driver education course may be granted a Class D2 license upon satisfactory completion of the written and driving examinations required by the Department of Public Safety. A Class D2 license shall grant to the licensee the privilege to operate a Class D motor vehicle under the following conditions:

- a. upon the public highways only during daylight hours except for driving to and from work, school, school activities, and church activities, and

b. with only one passenger.

4. Is at least sixteen (16) and one-half (16 1/2) years of age, who has been issued a ~~restricted~~ Class D D1 or D2 license for a minimum of thirty (30) days ~~may have the restriction requiring an accompanying licensed driver removed by,~~ and who has not been convicted of, pled guilty to, or pled no contest to any moving vehicle violations may be issued a Class D license by presenting proof of age and the required driving record to the Department of Public Safety; provided, if the licensee holds a Class D1 license the licensee must satisfactorily ~~completing~~ complete a driving examination. ~~The Department shall cause an examination to be conducted not more than three times during the first six (6) months after date of eligibility of the restricted licensee to have the restriction removed for a Class D license and not more than one time every three (3) months thereafter upon request of the holder thereof;~~

5. Is at least sixteen (16) years of age, and has completed driver education or is at least seventeen (17) years of age may be issued a Class D license by satisfactorily completing a driving examination and a written examination if the examinations have not been satisfactorily completed in connection with a Class D1 or D2 license application; or

6. Is at least sixteen (16) years of age, has not completed driver education, and resides in or is enrolled in a school district that does not offer driver education shall be excused from the driver education requirement for a Class D license and may be granted a Class D license upon satisfactorily completing a driving and written examination.

B. Class D1 or D2 licenses shall be issued for the same period as all other driver licenses. The licenses may be suspended or cancelled at the discretion of the Department for violation of restrictions, for failing to give the required or correct

information on the application or for violation of any traffic laws of this state pertaining to the operation of a motor vehicle. No extra fee for converting a Class D1 or D2 license to a Class D license will be charged.

C. Any person fourteen (14) years of age or older may apply for a restricted Class D license with a motorcycle restriction. After the person has successfully passed all parts of the motorcycle examination other than the driving examination, has met all requirements provided for in the rules of the Department, is in compliance with Section 6-107.3 of this title, and unless a custodial parent or guardian has filed an objection pursuant to Section 6-103.1 of this title, the Department shall issue to the person a restricted Class D license with a motorcycle restriction which shall grant to the person, while having the license in his or her immediate possession, the privilege to operate a motor-driven cycle:

1. With a piston displacement not to exceed one hundred twenty-five (125) cubic centimeters; and
2. Between the hours of 4:30 a.m. to 9:00 p.m. only; and
3. While wearing approved protective headgear; and
4. While accompanied by and receiving instruction from any person who is at least twenty-one (21) years of age and who is properly licensed pursuant to the laws of this state to operate a motorcycle, and who has visual contact with the restricted licensee.

The restricted licensee may apply on or after thirty (30) days from date of issuance of the restricted Class D license with a motorcycle restriction to have the restriction of being accompanied by a licensed driver removed by successfully completing the driving portion of an examination.

~~C.~~ D. The Department may in its discretion issue a special permit to any person who has attained the age of fourteen (14) years, authorizing such person to operate farm vehicles between the

farm and the market to haul commodities grown on such farm; provided, that such special permit shall be temporary and shall expire not more than thirty (30) days after the issuance thereof. Special permits shall be issued only to farm residents and shall be issued only during the time of the harvest of the principal crops grown on such farm. Provided, however, the Department shall not issue a special permit pursuant to this subsection until the Department is fully satisfied after the examination of the application, and other evidence furnished in support thereof, that the person is physically and mentally developed to such a degree that the operation of a motor vehicle by the person would not be inimical to public safety.

~~D.~~ E. The Department may issue an instructor's permit to any qualified secondary school driver education instructor as defined by the Oklahoma State Board of Education Rules and Regulations for Oklahoma High School Driver and Traffic Safety Education, any driver education instructor, certified by the Department of Public Safety, of a parochial, private, or other nonpublic secondary school upon a proper application to the State Board of Education or the Department of Public Safety in the case of secondary schools that are not regulated by the State Board of Education or a commercial driver training course instructor as provided for in Sections 801 through 808 of this title. The Department shall promulgate rules for the issuance of such permits. Any instructor as defined in this subsection who has been issued a permit may instruct any person who is at least fifteen and one-half (15 1/2) years of age or who is at least fifteen (15) years of age and of secondary school sophomore or higher educational standing while regularly enrolled and certified by the instructor as a student taking a prescribed course of secondary school driver education, a driver education course, certified by the Department of Public Safety, from a parochial, private, or other nonpublic secondary school or a commercial driver

training course as defined by Sections 801 through 808 of this title to operate a motor vehicle while accompanied by and receiving instruction from the instructor who is actually occupying a seat beside the driver.

~~E.~~ F. In addition to the licenses to operate motor vehicles, the Department may issue cards for purposes of identification only. The identification cards shall be issued and renewed in the same manner as driver licenses in this state and for a fee of Seven Dollars (\$7.00) to any resident of this state. The application for an identification card by any person under the age of sixteen (16) shall be signed and verified by the parent or legal guardian before a person authorized to administer oaths. Such cards shall be valid for a period of four (4) years from the month of issuance; however, the identification cards issued to persons sixty-five (65) years of age or older shall be valid indefinitely from the month of issuance, and no person sixty-five (65) years of age or older shall be charged a fee for an identification card. The fees derived pursuant to this section shall be apportioned as provided in Section 1104 of this title.

The Oklahoma Tax Commission is hereby authorized to reimburse, from funds available to that agency, each motor license agent issuing an identification card to a person sixty-five (65) years of age or older, an amount not to exceed One Dollar (\$1.00) for each card so issued. The ~~Oklahoma~~ Tax Commission shall develop procedures for claims for reimbursement.

SECTION 3. This act shall become effective August 15, 2000.
