AS INTRODUCED

A Concurrent Resolution congratulating W. G. "Bill" Maxwell of Mid-West Oil, Limited, upon his selection as Vice Chair/Chair-Elect of the Petroleum Marketers Association of America; and directing distribution.

WHEREAS, W. G. "Bill" Maxwell is a partner in Mid-West Oil, Limited, which has offices located in Enid and Oklahoma City, Oklahoma. The company has grown and diversified over the years marketing gasoline, diesel fuel, and lubricating oil through a network of company owned and operated outlets, associate marketers, retailers, and commercial accounts; and

WHEREAS, W. G. "Bill" Maxwell has been active in many civic and trade associations including the Oklahoma Petroleum Marketers Association-Oklahoma Association of Convenience Stores, serving as President and National Director. Bill has also been active in the Benevolent and Protective Order of Elks serving as the Exalted Ruler and District Governor for the Grand Lodge and enjoys his fraternal and charitable activities. Other involvements by Bill include 8 years as board member of the Oklahoma Lions Eye Bank, and as a Board Member of The Petroleum Club of Oklahoma City; and

WHEREAS, the Petroleum Marketers Association of America is a federation of 42 state and regional trade associations representing 7,850 independent petroleum marketers. The bulk of these marketers are small, family businesses providing petroleum products to their

local community. Collectively, these marketers sell approximately half of the gasoline, three-fifths of the diesel fuel and four-fifths of the home heating oil consumed annually in America. It is the primary mission of the association to nationally unify petroleum marketers through their state and regional associations to effectively further the common business interests of the petroleum industry; and

WHEREAS, W. G. "Bill" Maxwell has actively served in the Petroleum Marketers Association of America. He served as the South Central Regional Vice President and as Treasurer. He was recently selected as Vice Chair, a position that is also Chair of the Finance Committee and Chair-Elect of the association; and

WHEREAS, W.G. "Bill" Maxwell will serve as PMAA'S Chairman for the year 2001.
