We, your Conference Committee to whom was referred Engrossed House Bill No. 1124, and Engrossed Senate Amendments thereto, by: Winchester et al of the House and Wilcoxson et al of the Senate.

entitled:

An Act relating to criminal procedure; amending 22 O.S. 1991, Sections 60.1, 60.2, 60.3, 60.4, as last amended by Sections 5, 6, 7 and 8, Chapter 370, O.S.L. 2000 (22 O.S. Supp. 2000, Sections 60.1, 60.2, 60.3 and 60.4), which relate to the Protection from Domestic Abuse Act; adding definition; authorizing certain persons to apply for protective order; authorizing court to grant certain relief; and providing an effective date.
