providing for legislative intent; requiring collaboration and development of a  
comprehensive strategic state plan for investing in stronger families; providing for  
contents; requiring database; providing for content; encouraging certain partnerships;  
amending Section 26, Chapter 396, O.S.L. 1999 (10 O.S. Supp. 2000, Section 21.2), which  
relates to permanent care and custody of children \* \* \* limiting amount of adoption  
subsidies; providing for codification; and declaring an emergency.
