We, your Conference Committee to whom was referred Engrossed House Bill No. 2904, and Engrossed Senate Amendments thereto, by: Roach, Tyler, and Perry of the House, and Williams of the Senate

entitled:

An Act relating to economic development; amending 62 O.S. 2001, Section 859, which relates to notice for public hearings; modifying publication requirements for certain public hearings; amending 68 O.S. 2001, Section 2902, which relates to an exemption from ad valorem taxation for qualifying manufacturing concerns; modifying provisions related to date of construction or expansion and increased payroll requirement; providing for construction of certain statutory provisions; providing for noncodification; and declaring an emergency.
