BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY Section 6, Chapter 358, O.S.L. 1999 (62 O.S. Supp. 2000, Section 45.6), is amended to read as follows:

Section 45.6 The Office of State Finance, or the Joint Legislative Committee on Budget and Program Oversight, ~~or the Joint Committee on Accountability in Government,~~ jointly or separately, may hold hearings on any matter required by ~~this act~~ the Oklahoma Program Performance Budgeting and Accountability Act.

SECTION 22. REPEALER Section 10, Chapter 373, O.S.L. 2000, is hereby repealed.

SECTION 23. REPEALER Section 10, Chapter 407, O.S.L. 1997 (56 O.S. Supp. 2000, Section 1010.10), is hereby repealed.

SECTION 24. This act shall become effective July 1, 2001.

SECTION 25. It being immediately necessary for the preservation of the public peace, health and safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.
