A Concurrent Resolution relating to rules of the Oklahoma Department of Education; waiving the thirty-legislative-day review period for proposed permanent rules OAC 210:15-19-11, OAC 210:15-23-1, OAC 210:15-23-1.2 and OAC 210:15-23-2, relating to Curriculum and Instruction, proposed permanent rules OAC 210:20-9-9, OAC 210:20-9-10.1 and OAC 210:20-9-91, relating to Staff, proposed permanent rule OAC 210:25-5-13, relating to Finance, and proposed permanent rules OAC 210:40-52-3, OAC 210:40-52-5, OAC 210:40-52-6.2, OAC 210:40-29-1, OAC 210:40-29-2 and OAC 210:40-54-3, relating to Grants and Programs-in-Aid; and directing distribution.

WHEREAS, pursuant to Section 308 of Title 75 of the Oklahoma Statutes, the Legislature may waive the thirty-legislative-day review period for any rule which has been transmitted for legislative review; and

WHEREAS, on April 24, 2001, the Oklahoma Department of Education submitted to the Legislature for its review proposed amendments to proposed permanent rules OAC 210:15-19-11, OAC 210:15-23-1, OAC 210:15-23-1.2 and OAC 210:15-23-2, relating to Curriculum and Instruction, proposed permanent rules OAC 210:20-9-9, OAC 210:20-9-10.1 and OAC 210:20-9-91, relating to Staff, proposed permanent rule OAC 210:25-5-13, relating to Finance, and proposed permanent rules OAC 210:40-52-3, OAC 210:40-52-5, OAC 210:40-52-6.2, OAC 210:40-29-1, OAC 210:40-29-2 and OAC 210:40-54-3, relating to Grants and Programs-in-Aid; and

WHEREAS, the Legislature recognizes the substantive value and importance of such proposed amendments to permanent rules OAC

210:15-19-11, OAC 210:15-23-1, OAC 210:15-23-1.2, OAC 210:15-23-2, OAC 210:20-9-9, OAC 210:20-9-10.1, OAC 210:20-9-91, OAC 210:25-5-13, OAC 210:40-52-3, OAC 210:40-52-5, OAC 210:40-52-6.2, OAC 210:40-29-1, OAC 210:40-29-2 and OAC 210:40-54-3.

NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE 1ST SESSION OF THE 48TH OKLAHOMA LEGISLATURE, THE SENATE CONCURRING THEREIN:

THAT the Legislature hereby waives the thirty-legislative-day review period of proposed amendments to permanent rules OAC 210:15-19-11, OAC 210:15-23-1, OAC 210:15-23-1.2, OAC 210:15-23-2, OAC 210:20-9-9, OAC 210:20-9-10.1, OAC 210:20-9-91, OAC 210:25-5-13, OAC 210:40-52-3, OAC 210:40-52-5, OAC 210:40-52-6.2, OAC 210:40-29-1, OAC 210:40-29-2 and OAC 210:40-54-3.

THAT copies of this resolution shall be distributed to the Governor, the Chair of the Oklahoma Board of Education and the Editor of the "The Oklahoma Register".
