A Concurrent Resolution designating the Coal Creek Bridge on State Highway 131 as the John C. Farley Bridge; directing Oklahoma Department of Transportation to place permanent markers; and directing distribution.

WHEREAS, John C. Farley entered service for his country with the United States Army in February 1945 with a rank of Private 1st Class; and

WHEREAS, John C. Farley was "killed in action" in March of 1946, and his place of rest is located in lot 2, plot 3, row 23, grave 2941 of the Military Cemetery in Manila, Philippines; and

WHEREAS, for the gallant service of John C. Farley, the United States Army issued awards of the Purple Heart, Good Conduct Medal,

Asiatic-Pacific Campaign Medal, World War II Victory Medal, Philippine Liberation Medal, Philippine Defense Medal, Philippine Independence Medal and the Honorable Service Logo Button of World War II.

NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE 1ST SESSION OF THE 48TH OKLAHOMA LEGISLATURE, THE SENATE CONCURRING THEREIN:

THAT the Coal Creek Bridge, east of Cairo Community on State Highway 131 be designated as "John C. Farley Bridge".

THAT the Oklahoma Department of Transportation shall cause permanent suitable markers to be placed upon the bridge bearing the name.

THAT copies of this resolution be distributed to Neal McCaleb, Secretary and Director of Transportation, to the members of the State Transportation Commission, and to Eva Inez Argo.
