A Concurrent Resolution praising the life and accomplishments of the late State Senator Warren E. Green; extending condolences to his family and friends; and directing distribution.

WHEREAS, Warren Ernest Green was born on December 23, 1921, in Mannford, Oklahoma, the son of Clarence Green and Millie Priscilla Shoumake Green; and

WHEREAS, Warren E. Green graduated from high school and moved to Tulsa, Oklahoma, to attend Draughon's Business College. He worked for Douglas Aircraft as an electrician during World War II and later was employed by Fred Jones Ford; and

WHEREAS, in 1952 Warren E. Green opened Green's Drive Inn, which shared property with Green's Auto Sales and Services. When the store-restaurant burned in 1958, the auto dealership was expanded and remained a family-owned and operated business for 38 years as Green Auto Service, Inc.; and

WHEREAS, Warren E. Green served six terms in the Oklahoma State House of Representatives from the 30th through the 35th Oklahoma Legislature. He was a strong opponent of taxes and firm supporter of governmental reform; and

WHEREAS, Senator Warren E. Green served three terms in the Oklahoma State Senate from the 36th through the 41st Oklahoma Legislature. Senator Warren E. Green was frequently mentioned as a possible candidate for Congress or statewide office throughout his tenure in the State Senate; and

WHEREAS, Warren E. Green was active in community activities as a charter member and elder emeritus for the Southside Christian Church. He was a 32nd-degree Mason, Akdar Shriner, and affiliated with the Brookside Blue Lodge. Warren E. Green also served on the Board of Directors for Oasis Senior Citizen Center, as President of the Brookside Lions Club, and was an active member of the Henthorne Senior Citizens' Activity Center; and

WHEREAS, Warren E. Green was involved in civic affairs as a member of the Tulsa Consistory, Brookside Merchants, Oil Capitol Suburban Chamber of Commerce, Republican Men's Club, and the City-County Bond Advisory Council; and

WHEREAS, Warren Ernest Green died Saturday, February 10, 2001, at the age of 79 years.

NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE 1ST SESSION OF THE 48TH OKLAHOMA LEGISLATURE, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN:
