An Act relating to general appropriations for the expenses of various agencies of the executive, legislative and judicial departments of the state; making appropriations to the Oklahoma Arts Council, the State Board of Education, the Oklahoma Educational Television Authority, the Oklahoma State Regents for Higher Education, the Oklahoma Department of Libraries, the Commissioners of the Land Office, the Physician Manpower Training Commission, the Oklahoma Board of Private Vocational Schools, the Board of Trustees of the Oklahoma School of Science and Mathematics, the Oklahoma Center for the Advancement of Science and Technology, the Oklahoma Commission for Teacher Preparation, the State Board of Career and Technology Education, the Office of the State Auditor and Inspector, the Rural Economic Action Plan Fund of the State Treasury, the Department of Central Services, the Department of Civil Emergency Management, the State Election Board, the Ethics Commission, the Office of State Finance, the Office of the Governor, the Oklahoma House of Representatives, the Legislative Service Bureau, the Office of the Lieutenant Governor, the Oklahoma Merit Protection Commission, the Military Department of the State of Oklahoma, the Office of Personnel Management, the Secretary of State, the Oklahoma State Senate, the Oklahoma Space Industry Development Authority, the Oklahoma Tax Commission, the Office of State Treasurer, the Oklahoma Department of Commerce, the Department of Transportation, the Oklahoma Commission on Children and Youth, the Office of Handicapped Concerns, the Oklahoma Human Rights Commission, the Department of Human Services, reappropriating and redesignating funding, the State Department of Rehabilitation Services, the Oklahoma Indian Affairs Commission, the Office of Juvenile Affairs, the Department of Mental Health and Substance Abuse Services, the State Department of Health, the University Hospitals Authority, the Oklahoma Health Care Authority, the J.D. McCarty Center for Children with Developmental Disabilities, the Oklahoma Department of Veterans Affairs, the State Department of Agriculture, the Banking Department, the Oklahoma Capitol Complex and Centennial Commemoration Commission, the Oklahoma Conservation Commission, the Department of Consumer Credit, the Corporation Commission, the Department of Environmental Quality, the Oklahoma Horse Racing Commission, the State Insurance Department, the

Department of Labor, the Oklahoma Liquefied Petroleum Gas Board, the Department of Mines, the Native American Cultural and Educational Authority of Oklahoma, the Oklahoma Securities Commission, the Oklahoma Tourism and Recreation Department, the Oklahoma Water Resources Board, the Oklahoma Historical Society, the J.M. Davis Memorial Commission, the Will Rogers Memorial Commission, the Alcoholic Beverage Laws Enforcement Commission, the Department of Corrections, the State Fire Marshal, the Oklahoma State Bureau of Investigation, the Council on Law Enforcement Education and Training, the Board of Medicolegal Investigations, the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control, the Pardon and Parole Board, the Department of Public Safety, the Office of the Attorney General, the Court of Criminal Appeals, the Supreme Court, the Workers' Compensation Court, the Oklahoma Indigent Defense System, and the Council on Judicial Complaints; stating sums of the appropriations; stating purposes and restrictions; authorizing and requiring certain expenditures; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SUBCOMMITTEE ON EDUCATION

SECTION 1. There is hereby appropriated to the Oklahoma Arts Council from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of Four Million One Hundred Ninety-one Thousand Seven Hundred Eighty-five Dollars (\$4,191,785.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Arts Council by law.

SECTION 2. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of One Billion One Hundred Fifty-five Million Fifty-one Thousand Eight Hundred Seven Dollars (\$1,155,051,807.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 3. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Education Reform Revolving Fund created in Section 41.29b of Title 62 of the Oklahoma Statutes, the sum of Three Hundred Ninety-three Million Four Hundred Twenty-nine Thousand Four Hundred Ninety-two Dollars (\$393,429,492.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 4. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Mineral Leasing Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of Two Million One Hundred Thirty-seven Thousand Five Hundred Dollars (\$2,137,500.00) or so much

thereof as may be necessary for the financial support of public schools.

SECTION 5. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Mineral Leasing Fund of the State Treasury for the fiscal year ending June 30, 2000, the sum of Five Hundred Eighty-one Thousand Six Hundred Sixty-eight Dollars (\$581,668.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 6. The State Board of Education is hereby authorized to expend during the fiscal year ending June 30, 2002, from the Common Education Technology Revolving Fund of the State Treasury, the sum of Twenty-nine Million Thirty-seven Thousand Five Hundred Forty-eight Dollars (\$29,037,548.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 7. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of Three Hundred Fifty-one Million Six Hundred Sixteen Thousand Nine Hundred Four Dollars (\$351,616,904.00) or so much thereof as may be necessary for the support of public school activities.

SECTION 8. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2000, the sum of Nineteen Million Two Hundred Three Thousand One Hundred Eighty-five Dollars (\$19,203,185.00) or so much thereof as may be necessary for the purchase of textbooks.

SECTION 9. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of Two Hundred Seventy-two Thousand Five Hundred Seventeen Dollars (\$272,517.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of Accountability by law.

SECTION 10. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of Twenty Million Seven Hundred Six Thousand Three Hundred Seventy-four Dollars (\$20,706,374.00) or so much thereof as may be necessary for Administrative and Support Functions of the State Department of Education.

SECTION 11. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of Ten Million Dollars (\$10,000,000.00) or so much thereof as may be necessary to implement the School District Utility Assistance Program.

SECTION 12. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of Four Hundred Twenty Thousand Dollars (\$420,000.00) or so much thereof as may be necessary for the support of the Education Leadership Oklahoma Program and shall be transferred to the Oklahoma National Board

Certification Revolving Fund created in Section 6-204.4 of Title 70 of the Oklahoma Statutes for the purpose of awarding annual bonuses as directed.

SECTION 13. There is hereby appropriated to the Oklahoma Educational Television Authority from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of Three Million Seven Hundred Nineteen Thousand Three Hundred Seventeen Dollars (\$3,719,317.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Educational Television Authority by law.

SECTION 14. There is hereby appropriated to the Oklahoma Educational Television Authority from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of Six Million Seven Hundred Thousand Dollars (\$6,700,000.00) or so much thereof as may be necessary for the cost of digital conversion and any other duties imposed upon the Oklahoma Educational Television Authority by law. Of this amount, the Oklahoma Educational Television Authority is directed to provide One Million One Hundred Thousand Dollars (\$1,100,000.00) no later than April 30, 2001, to any public higher education institution with an existing non-commercial television broadcast license which has Federal Communications Commission (FCC) construction permits for allocated digital television frequencies for the purpose of providing funding for federally mandated digital conversion. In order to qualify for funds pursuant to this section a higher education institution must present a request for funds to the Oklahoma Educational Television Authority no later than April 15, 2001, and must show documentation of application for federal grants to provide partial funding for digital conversion prior to March 1, 2001.

SECTION 15. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of Seven Hundred Seventeen Million Five Hundred Forty-four Thousand Eighty-six Dollars (\$717,544,086.00) or so much thereof as may be necessary for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 16. The Oklahoma State Regents for Higher Education are hereby authorized to expend during the fiscal year ending June 30, 2002, the sum of Twenty-nine Million Thirty-seven Thousand Five Hundred Forty-eight Dollars (\$29,037,548.00) from the Higher Education Capital Revolving Fund of the State Treasury for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 17. The Oklahoma State Regents for Higher Education are hereby authorized to expend during the fiscal year ending June 30, 2002, the sum of Twenty-nine Million Thirty-seven Thousand Five Hundred Forty-eight Dollars (\$29,037,548.00) from the Oklahoma Tuition Scholarship Revolving Fund of the State Treasury for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 18. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2000, the sum of Forty Million Dollars (\$40,000,000.00) or so much thereof as may be necessary for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 19. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of Five Million Fifty-six Thousand Three Hundred Sixty-five Dollars (\$5,056,365.00) or so much thereof as may be necessary for the general operating budget of the Administrative Offices of the Oklahoma State Regents for Higher Education.

SECTION 20. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of Two Million Eight Hundred Forty-three Thousand Three Hundred Ninety-six Dollars (\$2,843,396.00) or so much thereof as may be necessary for the allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operation budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 21. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of Five Million Dollars (\$5,000,000.00) or so much thereof as may be necessary to implement the provisions of the Higher Education Utilities Assistance Program.

SECTION 22. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of Nine Million Dollars (\$9,000,000.00) or so much thereof as may be necessary for expenditures in the endowed chairs program.

SECTION 23. There is hereby appropriated to the Oklahoma Department of Libraries from any monies not otherwise appropriated

from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of Six Million Nine Hundred Ninety Thousand Six Hundred Twenty-six Dollars (\$6,990,626.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Department of Libraries by law.

SECTION 24. There is hereby appropriated to Commissioners of the Land Office from any monies not otherwise appropriated from the Commissioners of the Land Office Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of Four Million Two Hundred Sixty-one Thousand Two Hundred Sixty-three Dollars (\$4,261,263.00) or so much thereof as may be necessary to perform the duties imposed upon the Commissioners of the Land Office by law.

SECTION 25. There is hereby appropriated to the Physician Manpower Training Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of Five Million Fifty-two Thousand Six Hundred Sixty Dollars (\$5,052,660.00) or so much thereof as may be necessary to perform the duties imposed upon the Physician Manpower Training Commission by law.

SECTION 26. There is hereby appropriated to the Physician Manpower Training Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2000, the sum of Four Hundred Thousand Dollars (\$400,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Physician Manpower Training Commission by law.

SECTION 27. There is hereby appropriated to the Oklahoma Board of Private Vocational Schools from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of One Hundred Seventy Thousand Six Hundred Seventeen Dollars (\$170,617.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Board of Private Vocational Schools by law.

SECTION 28. There is hereby appropriated to the Board of Trustees of the Oklahoma School of Science and Mathematics from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of Five Million Five Hundred Forty-nine Thousand One Hundred Eleven Dollars (\$5,549,111.00) or so much thereof as may be necessary to perform the duties imposed upon the Board of Trustees of the Oklahoma School of Science and Mathematics by law.

SECTION 29. There is hereby appropriated to the Board of Trustees of the Oklahoma School of Science and Mathematics from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of One Hundred Forty Thousand One Hundred Ninety-three Dollars (\$140,193.00) or so much thereof as may be necessary to perform the duties imposed upon the Board of Trustees of the Oklahoma School of Science and Mathematics by law.

SECTION 30. There is hereby appropriated to the Oklahoma Center for the Advancement of Science and Technology from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of Twelve Million One Hundred Sixty-seven Thousand Five Hundred Forty-one

Dollars (\$12,167,541.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Center for the Advancement of Science and Technology by law.

SECTION 31. There is hereby appropriated to the Oklahoma Commission for Teacher Preparation from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of Two Million Three Hundred Thirty-four Thousand Nine Hundred Twenty-five Dollars (\$2,334,925.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Commission for Teacher Preparation by law.

SECTION 32. There is hereby appropriated to the State Board of Career and Technology Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of One Hundred Twenty-six Million Three Hundred Twenty-eight Thousand Nine Hundred Sixty-four Dollars (\$126,328,964.00) or so much thereof as may be necessary to perform the duties imposed upon the State Board of Career and Technology Education by law.

SECTION 33. There is hereby appropriated to the State Board of Career and Technology Education from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of Two Million Four Hundred Thousand Dollars (\$2,400,000.00) or so much thereof as may be necessary for the Training and Industry Program.

SECTION 34. There is hereby appropriated to the State Board of Career and Technology Education from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of Five Hundred Thousand Dollars (\$500,000.00) or so much thereof as may be necessary to implement the provisions of the Career and Technology Education District Utility Assistance Program.

SECTION 35. There is hereby appropriated to the State Board of Career and Technology Education from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of Eight Hundred Fifteen Thousand Three Hundred Thirty-four Dollars (\$815,334.00) or so much thereof as may be necessary to perform the duties imposed upon the State Board of Career and Technology Education by law.

SUBCOMMITTEE ON GENERAL GOVERNMENT AND TRANSPORTATION

SECTION 36. There is hereby appropriated to the Office of the State Auditor and Inspector from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of Five Million Five Hundred Eighty-four Thousand Three Hundred Seventy-three Dollars (\$5,584,373.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the State Auditor and Inspector by law.

SECTION 37. There is hereby appropriated to the Office of the State Auditor and Inspector from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of Five Hundred Thirty-four Thousand Ninety-one Dollars (\$534,091.00) or so much

thereof as may be necessary to perform the duties imposed upon the Commission on County Government Personnel Education and Training. The appropriation made in this section shall be expended exclusively for the purpose so stated and shall not be transferable.

SECTION 38. There is hereby appropriated to the Office of the State Auditor and Inspector from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of Forty-five Thousand Dollars (\$45,000.00) or so much thereof as may be necessary to provide uniform computer systems development, including computer software for county government, in accordance with the State Auditor and Inspector's duties to prescribe accounting procedures and to provide technical assistance to county government. The appropriation made in this section shall be expended exclusively for the purpose so stated and shall not be transferable.

SECTION 39. There is hereby appropriated to the Rural Economic Action Plan Fund of the State Treasury from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of Fifteen Million Five Hundred Thousand Dollars (\$15,500,000.00) or so much thereof as may be necessary to implement the provisions of Sections 2006 through 2013 of Title 62 of the Oklahoma Statutes.

SECTION 40. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of Nine Million Seven Hundred Forty-five Thousand Five Hundred Sixty-four Dollars (\$9,745,564.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Central Services by law.

SECTION 41. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of Three Million Eight Hundred Thirty Thousand One Hundred Seventeen Dollars (\$3,830,117.00) to be transferred to the Building and Facility Revolving Fund created in Section 63.1 of Title 74 of the Oklahoma Statutes for the purpose of maintaining state buildings operated by the Department of Central Services.

SECTION 42. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of Four Thousand Eight Hundred Seventy-five Dollars (\$4,875.00) or so much thereof as may be necessary to perform maintenance on the Veterans Memorial within the Capitol complex.

SECTION 43. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of One Hundred Ninety-two Thousand Seven Hundred Dollars (\$192,700.00) or so much thereof as may be necessary to maintain the Hissom Memorial Center.

SECTION 44. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the

Public Building Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of One Million Three Hundred Eighty-eight Thousand Nine Hundred Ninety-five Dollars (\$1,388,995.00) or so much thereof as may be necessary for asbestos abatement programs and for the expenses of filing claims for reimbursement from the Manville Property Damage Settlement Trust. The monies designated in this section shall be expended exclusively for the purposes so stated and shall not be transferable.

SECTION 45. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of One Million Fifty-six Thousand One Hundred Ninety-five Dollars (\$1,056,195.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Central Services by law.

SECTION 46. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of Five Million Five Hundred Thousand Dollars (\$5,500,000.00) or so much thereof as may be necessary to implement the provisions of the State Agency Utility Assistance Program.

SECTION 47. There is hereby appropriated to the Department of Civil Emergency Management from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of Seven Hundred Sixty-eight Thousand Six Hundred Four Dollars (\$768,604.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Civil Emergency Management by law.

SECTION 48. There is hereby appropriated to the State Election Board from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of Seven Million Five Hundred Ninety-six Thousand Five Hundred Three Dollars (\$7,596,503.00) or so much thereof as may be necessary to perform the duties imposed upon the State Election Board by law.

SECTION 49. There is hereby appropriated to the Ethics Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of Four Hundred Sixty-two Thousand Two Hundred Thirty Dollars (\$462,230.00) or so much thereof as may be necessary to perform the duties imposed upon the Ethics Commission by law.

SECTION 50. There is hereby appropriated to the Office of State Finance from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of Nine Million Three Hundred Forty Thousand One Hundred Thirty-two Dollars (\$9,340,132.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of State Finance by law.

SECTION 51. There is hereby appropriated to the Office of State Finance from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of One Hundred Sixty-three Thousand Sixty-seven Dollars (\$163,067.00) or so much thereof as may

be necessary to perform the duties imposed upon the Office of State Finance by law.

SECTION 52. There is hereby appropriated to the Office of the Governor from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the following amount or so much thereof as may be required for the following purposes:
