(sunset - amending 62 O.S., Section 45.6 - hearings -
defunct entity - repealing various sections in Titles 2, 10,
43A, 56, 63, 74 and 85 - effective date -
emergency)

SECTION 1. AMENDATORY Section 6, Chapter 358, O.S.L.
1999 (62 O.S. Supp. 2000, Section 45.6), is amended to read as
follows:

Section 45.6 The Office of State Finance, or the Joint
Legislative Committee on Budget and Program Oversight, ~~or the Joint~~

may hold hearings on any matter required by ~~this act~~ the Oklahoma
Program Performance Budgeting and Accountability Act.
