ENGROSSED HOUSE BILL NO. 1986 - By: ERWIN of the House and SHURDEN of the Senate.

[ motor vehicles - cameras for motor license agents -  
effective date -  
emergency ]

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 47 O.S. 2001, Section 1140.1, is amended to read as follows:

Section 1140.1 A. ~~Except as otherwise provided in this section, each~~ Each motor license agent appointed after July 1, 1988, ~~within a specific municipality shall~~ may be furnished a camera by the Department of Public Safety without charge ~~if, based upon the number of driver's licenses issued during the preceding year, the total number of licenses issued shall average not less than one thousand two hundred (1,200) per year per camera within the municipality and not less than one thousand two hundred (1,200) per year per camera within the county; provided, each county shall have at least one motor license agent who shall be furnished a camera without charge.~~

1       ~~B. Any motor license agent who has been furnished a camera~~  
2 ~~without charge prior to July 1, 1988, shall continue to have such~~  
3 ~~camera furnished without charge until a new motor license agent is~~  
4 ~~appointed.~~

5       ~~C. A motor license agent appointed after July 1, 1988, who is~~  
6 ~~not entitled to be furnished a camera pursuant to the provisions of~~  
7 ~~subsection A of this section may be furnished a camera upon signing~~  
8 ~~an agreement with the Department of Public Safety to process a~~  
9 ~~minimum of one thousand two hundred (1,200) licenses per year or to~~  
10 ~~pay the Department the sum of fifty cents (\$0.50) for each license~~  
11 ~~under one thousand two hundred (1,200) issued per year. For~~  
12 ~~agreements entered into prior to the effective date of this act~~  
13 ~~under which the payment was calculated based upon the difference~~  
14 ~~between the number of licenses issued and three thousand (3,000),~~  
15 ~~the payment shall be recalculated based upon the difference between~~  
16 ~~the number of licenses issued and one thousand two hundred (1,200).~~  
17 ~~The amount of the difference between the recalculated payment and~~  
18 ~~any payment actually made by a motor license agent prior to the~~  
19 ~~effective date of this act shall be refunded to the motor license~~  
20 ~~agent.~~

21       ~~D. For the purposes of this section, each motor license agent~~  
22 ~~appointed after July 1, 1988, shall be considered a new agent,~~

1 ~~whether assets of another agency were inherited, purchased or~~  
2 ~~otherwise acquired.~~

3 E. The furnishing of any camera shall be ~~subject to~~  
4 ~~availability from the vendor and, if limited, shall be allocated by~~  
5 ~~priority according to subsections A, B and C of this section, in~~  
6 ~~that order~~ limited to no **fewer** than two hundred eighty cameras  
7 statewide. The Commissioner of Public Safety shall promulgate rules  
8 to implement and administer the provisions of this section.

9 SECTION 2. This act shall become effective July 1, 2002.

10 SECTION 3. It being immediately necessary for the preservation  
11 of the public peace, health and safety, an emergency is hereby  
12 declared to exist, by reason whereof this act shall take effect and  
13 be in full force from and after its passage and approval.
