25 Oklahoma; stating purpose; making an appropriation to the  
26 State Department of Agriculture; stating purpose; making an  
27 appropriation to the Oklahoma State Regents for Higher  
28 Education; stating purpose; making an appropriation to  
29 University Hospitals Authority; stating purpose; and  
30 declaring an emergency.

31 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

32 SECTION 1. There is hereby appropriated to the Department of  
33 Central Services from any monies not otherwise appropriated from the  
34 Special Cash Fund of the State Treasury, the sum of One Million  
35 Fifty-six Thousand One Hundred Ninety-five Dollars (\$1,056,195.00)

1 or so much thereof as may be necessary to perform the duties imposed  
2 upon the Department of Central Services by law.

3 SECTION 2. There is hereby appropriated to the Office of State  
4 Finance from any monies not otherwise appropriated from the Special  
5 Cash Fund of the State Treasury, the sum of One Hundred Sixty-three  
6 Thousand Sixty-seven Dollars (\$163,067.00) or so much thereof as may  
7 be necessary to perform the duties imposed upon the Office of State  
8 Finance by law.

9 SECTION 3. There is hereby appropriated to the Oklahoma  
10 Historical Society from any monies not otherwise appropriated from  
11 the Special Cash Fund of the State Treasury, the sum of One Million  
12 Six Hundred Ninety-two Thousand Eight Hundred Ninety-five Dollars  
13 (\$1,692,895.00) or so much thereof as may be necessary to perform  
14 the duties imposed upon the Oklahoma Historical Society by law.

15 SECTION 4. There is hereby appropriated to the J.D. McCarty  
16 Center for Children with Developmental Disabilities from any monies  
17 not otherwise appropriated from the Special Cash Fund of the State  
18 Treasury, the sum of Five Hundred Forty-four Thousand Nine Hundred  
19 Dollars (\$544,900.00) or so much thereof as may be necessary to  
20 perform the duties imposed upon the J.D. McCarty Center for Children  
21 with Developmental Disabilities by law.

22 SECTION 5. There is hereby appropriated to the Department of  
23 Rehabilitation Services from any monies not otherwise appropriated

1 from the Special Cash Fund of the State Treasury, the sum of Seven  
2 Hundred Fourteen Thousand One Hundred Ninety Dollars (\$714,190.00)  
3 or so much thereof as may be necessary to perform the duties imposed  
4 upon the Department of Rehabilitation Services by law.

5 SECTION 6. There is hereby appropriated to the Board of  
6 Trustees of the Oklahoma School for Science and Math from any monies  
7 not otherwise appropriated from the Special Cash Fund of the State  
8 Treasury, the sum of One Hundred Forty Thousand One Hundred Ninety-  
9 three Dollars (\$140,193.00) or so much thereof as may be necessary  
10 to perform the duties imposed upon the Board of Trustees of the  
11 Oklahoma School for Science and Math by law.

12 SECTION 7. There is hereby appropriated to the Oklahoma Supreme  
13 Court from any monies not otherwise appropriated from the Special  
14 Cash Fund of the State Treasury, the sum of Five Hundred Twenty-nine  
15 Thousand Thirty Dollars (\$529,030.00) or so much thereof as may be  
16 necessary to perform the duties imposed upon the Oklahoma Supreme  
17 Court by law.

18 SECTION 8. There is hereby appropriated to the Oklahoma Tourism  
19 and Recreation Department from any monies not otherwise appropriated  
20 from the Special Cash Fund of the State Treasury, the sum of One  
21 Hundred Eighty-five Thousand One Hundred Sixty Dollars (\$185,160.00)  
22 or so much thereof as may be necessary to perform the duties imposed  
23 upon the Oklahoma Tourism and Recreation Department by law.

1 SECTION 9. There is hereby appropriated to the Oklahoma  
2 Department of Veteran's Affairs from any monies not otherwise  
3 appropriated from the Special Cash Fund of the State Treasury, the  
4 sum of Six Hundred Thirty-four Thousand Eight Hundred Thirty-six  
5 Dollars (\$634,836.00) or so much thereof as may be necessary to  
6 perform the duties imposed upon the Oklahoma Department of Veteran's  
7 Affairs by law.

8 SECTION 10. There is hereby appropriated to the State Board of  
9 Career and Technology Education from any monies not otherwise  
10 appropriated from the Special Cash Fund of the State Treasury, the  
11 sum of Eight Hundred Fifteen Thousand Three Hundred Thirty-four  
12 Dollars (\$815,334.00) or so much thereof as may be necessary to  
13 perform the duties imposed upon the State Board of Career and  
14 Technology Education by law.

15 SECTION 11. There is hereby appropriated to the Native American  
16 Cultural and Educational Authority of Oklahoma from any monies not  
17 otherwise appropriated from the Special Cash Fund of the State  
18 Treasury, the sum of Two Hundred Fifty-four Thousand Three Hundred  
19 Sixty-nine Dollars (\$254,369.00) or so much thereof as may be  
20 necessary to perform the duties imposed upon the Native American  
21 Cultural and Educational Authority of Oklahoma by law.

22 SECTION 12. There is hereby appropriated to the State  
23 Department of Agriculture from any monies not otherwise appropriated

1 from the Special Cash Fund of the State Treasury, the sum of Five  
2 Hundred Twenty Thousand Five Hundred Sixty-three Dollars  
3 (\$520,563.00) or so much thereof as may be necessary to perform the  
4 duties imposed upon the State Department of Agriculture by law.

5 SECTION 13. There is hereby appropriated to the Oklahoma State  
6 Regents for Higher Education from any monies not otherwise  
7 appropriated from the Special Cash Fund of the State Treasury, the  
8 sum of Two Million Eight Hundred Forty-three Thousand Three Hundred  
9 Ninety-six Dollars (\$2,843,396.00) or so much thereof as may be  
10 necessary for the allocation by the Oklahoma State Regents for  
11 Higher Education pursuant to the provisions of Article XIII-A of the  
12 Oklahoma Constitution for the education and general operation  
13 budgets of the institutions and for other programs, construction,  
14 renovations or repairs administered by the Oklahoma State Regents  
15 for Higher Education.

16 SECTION 14. There is hereby appropriated to the University  
17 Hospitals Authority from any monies not otherwise appropriated from  
18 the Special Cash Fund of the State Treasury, the sum of One Hundred  
19 Ninety-two Thousand Five Hundred Sixty-four Dollars (\$192,564.00) or  
20 so much thereof as may be necessary to perform the duties imposed  
21 upon the University Hospitals Authority by law.

22 SECTION 15. It being immediately necessary for the preservation  
23 of the public peace, health and safety, an emergency is hereby

1 declared to exist, by reason whereof this act shall take effect and  
2 be in full force from and after its passage and approval.
