

An Act relating to revenue and taxation; providing income tax credit for small business owners for investments in dilapidated or abandoned buildings; setting forth amount of credit; authorizing carryover of unused credit; requiring Oklahoma Tax Commission to prescribe forms; defining terms; providing for codification; and providing an effective date.
