

An Act relating to revenue and taxation; amending 68 O.S. 2001, Section 2358, which relates to computation of taxable incomes; modifying provisions related to standard deduction amounts; providing for standard deduction based upon provisions of the Internal Revenue Code of 1986, as amended; and providing an effective date.
