

An Act relating to state agencies; amending Sections 1 and 37 of Enrolled House Bill No. 1505 of the 1st Session of the 48th Oklahoma Legislature, which relate to education; modifying appropriation; authorizing expenditures; making an appropriation to the State Board of Education; modifying certain apportionments of monies; modifying allocation of certain funds; requiring certain expenditures for certain purposes; providing for content of certain program; providing for competitive bid and qualifications; amending 70 O.S. 1991, Section 16-114, as last amended by Section 43 of Enrolled House Bill No. 1505 of the 1st Session of the 48th Oklahoma Legislature, which relates to textbook allocations; modifying certain dates; amending Sections 61, 62 and 76 of Enrolled House Bill No. 1505 of the 1st Session of the 48th Oklahoma Legislature, which relate to certain schools; modifying budgetary limitations and categories and amounts relating to the Oklahoma School of Science and Mathematics; increasing maximum limitation for the salary of the Director of the Oklahoma Department of Career and Technology Education; making an appropriation to the Oklahoma Center for the Advancement of Science and Technology; specifying purpose; amending Section 1 of Enrolled Senate Bill No. 239 of the 1st Session of the 48th Oklahoma Legislature, which relates to the Oklahoma State Regents for Higher Education; making appropriations thereto; modifying appropriations; authorizing certain expenditures; amending Section 4, Chapter 371, O.S.L. 1999 (70 O.S.
