AS INTRODUCED

An Act relating to general appropriations for the expenses of various agencies of the executive, legislative and judicial departments of the state; making appropriations to the Oklahoma Arts Council, the State Board of Education, the Oklahoma Educational Television Authority, the Oklahoma State Regents for Higher Education, the Oklahoma Department of Libraries, the Commissioners of the Land Office, the Physician Manpower Training Commission, the Oklahoma Board of Private Vocational Schools, the Board of Trustees of the Oklahoma School of Science and Mathematics, the Oklahoma Center for the Advancement of Science and Technology, the Oklahoma Commission for Teacher Preparation, the State Board of Career and Technology Education, the Office of the State Auditor and Inspector, the Rural Economic Action Plan Fund of the State Treasury, the Department of Central Services, the Oklahoma Capitol Improvement Authority, the Department of Civil Emergency Management, the State Election Board, the Ethics Commission, the Office of State Finance, the Office of the Governor, the State Emergency Fund, the Oklahoma House of Representatives, the Legislative Service Bureau, the Office of the Lieutenant Governor, the Oklahoma Merit Protection Commission, the Military Department of the State of Oklahoma, the Office of Personnel Management, the Secretary of State, the Oklahoma State Senate, the Oklahoma Tax Commission, the Office of State Treasurer, the Oklahoma Department of Commerce, the Department of Transportation, the Oklahoma Commission on Children and Youth, the Office of Handicapped Concerns, the Oklahoma Human Rights Commission, the Department of Human Services, the State Department of Rehabilitation Services, the Oklahoma Indian Affairs Commission, the Office of Juvenile Affairs, the Department of Mental Health and Substance Abuse Services, the State Department of Health, the University Hospitals Authority, the Oklahoma Health Care Authority, the J.D. McCarty Center for Children with Developmental Disabilities, the Oklahoma Department of Veterans Affairs, the State Department of Agriculture, the Banking Department, the Oklahoma Conservation Commission, the Department of Consumer Credit, the Corporation Commission, the Department of

Environmental Quality, the Oklahoma Horse Racing Commission, the State Insurance Department, the Department of Labor, the Oklahoma Liquefied Petroleum Gas Board, the Department of Mines, the Oklahoma Securities Commission, the Oklahoma Tourism and Recreation Department, the Oklahoma Water Resources Board, the Oklahoma Historical Society, the J.M. Davis Memorial Commission, the Will Rogers Memorial Commission, the Alcoholic Beverage Laws Enforcement Commission, the Department of Corrections, the State Fire Marshal, the Oklahoma State Bureau of Investigation, the Council on Law Enforcement Education and Training, the Board of Medicolegal Investigations, the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control, the Pardon and Parole Board, the Department of Public Safety, the Office of the Attorney General, the Court of Criminal Appeals, the Supreme Court, the Workers' Compensation Court, and the Oklahoma Indigent Defense System; stating sums of the appropriations; stating purposes and restrictions; authorizing and requiring certain expenditures; requiring transfer of certain funds; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SUBCOMMITTEE ON EDUCATION

SECTION 1. There is hereby appropriated to the Oklahoma Arts Council from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Arts Council by law.

SECTION 2. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 3. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Education Reform Revolving Fund created in Section 41.29b of Title 62 of the Oklahoma Statutes, the sum of \_\_\_\_\_ Dollars

(\$0.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 4. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Mineral Leasing Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 5. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Mineral Leasing Fund of the State Treasury for the fiscal year ending June 30, 2000, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 6. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary for the support of public school activities.

SECTION 7. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary for the purchase of textbooks.

SECTION 8. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of Accountability by law.

SECTION 9. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary for Administrative and Support Functions of the State Department of Education.

SECTION 10. There is hereby appropriated to the Oklahoma Educational Television Authority from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Educational Television Authority by law.

SECTION 11. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 12. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary for the general operating budget of the Administrative Offices of the Oklahoma State Regents for Higher Education.

SECTION 13. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise

appropriated from the Special Cash Fund of the State Treasury, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 14. There is hereby appropriated to the Oklahoma Department of Libraries from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Department of Libraries by law.

SECTION 15. There is hereby appropriated to Commissioners of the Land Office from any monies not otherwise appropriated from the Commissioners of the Land Office Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary to perform the duties imposed upon the Commissioners of the Land Office by law.

SECTION 16. There is hereby appropriated to the Physician Manpower Training Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary to perform the duties imposed upon the Physician Manpower Training Commission by law.

SECTION 17. There is hereby appropriated to the Physician Manpower Training Commission from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be

necessary to perform the duties imposed upon the Physician Manpower Training Commission by law.

SECTION 18. There is hereby appropriated to the Oklahoma Board of Private Vocational Schools from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Board of Private Vocational Schools by law.

SECTION 19. There is hereby appropriated to the Board of Trustees of the Oklahoma School of Science and Mathematics from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary to perform the duties imposed upon the Board of Trustees of the Oklahoma School of Science and Mathematics by law.

SECTION 20. There is hereby appropriated to the Oklahoma Center for the Advancement of Science and Technology from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Center for the Advancement of Science and Technology by law.

SECTION 21. There is hereby appropriated to the Oklahoma Commission for Teacher Preparation from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Commission for Teacher Preparation by law.

SECTION 22. There is hereby appropriated to the Oklahoma Commission for Teacher Preparation from any monies not otherwise

appropriated from the Special Cash Fund of the State Treasury, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Commission for Teacher Preparation by law.

SECTION 23. There is hereby appropriated to the State Board of Career and Technology Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary to perform the duties imposed upon the State Board of Vocational and Technical Education by law.

SUBCOMMITTEE ON GENERAL GOVERNMENT AND TRANSPORTATION

SECTION 24. There is hereby appropriated to the Office of the State Auditor and Inspector from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the State Auditor and Inspector by law.

SECTION 25. There is hereby appropriated to the Office of the State Auditor and Inspector from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary to perform the duties imposed upon the Commission on County Government Personnel Education and Training. The appropriation made in this section shall be expended exclusively for the purpose so stated and shall not be transferable.

SECTION 26. There is hereby appropriated to the Office of the State Auditor and Inspector from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of \_\_\_\_\_

Dollars (\$0.00) or so much thereof as may be necessary to provide uniform computer systems development, including computer software for county government, in accordance with the State Auditor and Inspector's duties to prescribe accounting procedures and to provide technical assistance to county government. The appropriation made in this section shall be expended exclusively for the purpose so stated and shall not be transferable.

SECTION 27. There is hereby appropriated to the Rural Economic Action Plan Fund of the State Treasury from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary to implement the provisions of Section 2006 through 2013 of Title 62 of the Oklahoma Statutes.

SECTION 28. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Central Services by law.

SECTION 29. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of \_\_\_\_\_ Dollars (\$0.00) to be transferred to the Building and Facility Revolving Fund created in Section 63.1 of Title 74 of the Oklahoma Statutes for the purpose of maintaining state buildings operated by the Department of Central Services.

SECTION 30. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of \_\_\_\_\_ Dollars

(\$0.00) or so much thereof as may be necessary to perform maintenance on the Veterans Memorial within the capitol complex.

SECTION 31. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the Public Building Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary for asbestos abatement programs and for the expenses of filing claims for reimbursement from the Manville Property Damage Settlement Trust. The monies designated in this section shall be expended exclusively for the purposes so stated and shall not be transferable.

SECTION 32. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary to maintain the Hissom Memorial Center.

SECTION 33. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of \_\_\_\_\_ Dollars (\$0.00) for transfer to the Capital Improvement Revolving Fund.

SECTION 34. There is hereby appropriated to the Oklahoma Capitol Improvement Authority from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary for the purpose of retiring bonds issued by the Authority.

SECTION 35. There is hereby appropriated to the Department of Civil Emergency Management from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of \_\_\_\_\_ Dollars

(\$0.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Civil Emergency Management by law.

SECTION 36. There is hereby appropriated to the State Election Board from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary to perform the duties imposed upon the State Election Board by law.

SECTION 37. There is hereby appropriated to the State Election Board from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be required to pay the necessary expenses of holding elections.

SECTION 38. There is hereby appropriated to the Ethics Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary to perform the duties imposed upon the Ethics Commission by law.

SECTION 39. There is hereby appropriated to the Office of State Finance from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of State Finance by law.

SECTION 40. There is hereby appropriated to the Office of the Governor from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the following amount or so much thereof as may be required for the following purposes:

SECTION 41. There is hereby appropriated to the State Emergency Fund created pursuant to Section 139.42 of Title 62 of the Oklahoma Statutes from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary for state emergencies.

SECTION 42. There is hereby appropriated to the Oklahoma House of Representatives from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary to pay the salaries, per diem and expenses of the members of the House of Representatives, the salaries of the employees of the House of Representatives, and other necessary expenses. Claims and payrolls filed against the appropriation made to the House of Representatives for the fiscal year ending June 30, 2002, shall be approved by the Speaker of the House of Representatives.

SECTION 43. There is hereby appropriated to the Oklahoma House of Representatives from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary for the purchase of Oklahoma Statutes, Session Laws, and Supplements.

SECTION 44. There is hereby appropriated to the Legislative Service Bureau from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary to perform the duties imposed upon the Legislative Service Bureau by law.

SECTION 45. There is hereby appropriated to the Legislative Service Bureau from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary to fund the operations of the Oklahoma Criminal Justice Resource Center.

SECTION 46. There is hereby appropriated to the Office of the Lieutenant Governor from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the Lieutenant Governor by law.

SECTION 47. There is hereby appropriated to the Oklahoma Merit Protection Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Merit Protection Commission by law.

SECTION 48. There is hereby appropriated to the Military Department of the State of Oklahoma from any monies not otherwise

appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary to perform the duties imposed upon the Military Department of the State of Oklahoma by law.

SECTION 49. There is hereby appropriated to the Office of Personnel Management from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of Personnel Management by law.

SECTION 50. There is hereby appropriated to the Office of the Secretary of State from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the Secretary of State by law.

SECTION 51. There is hereby appropriated to the Office of the Secretary of State from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary for the expenses of the Office of Administrative Rules.

SECTION 52. There is hereby appropriated to the Office of the Secretary of State from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary for legal publication of ballot titles.

SECTION 53. There is hereby appropriated to the Oklahoma State Senate from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June

30, 2002, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary to pay monthly salaries, per diem, and expenses of the members of the Senate and the salaries of its employees, and such contingent expenses as may be ordered paid therefrom, including the preparation and printing of the journals and calendars of the Senate, and including the preparation and printing of the permanent journals thereof, in accordance with the following amount herein set forth:

SECTION 54. There is hereby appropriated to the Oklahoma Tax Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Tax Commission by law.

SECTION 55. From the appropriation made in Section 54 of this act, the Oklahoma Tax Commission shall pay an amount not to exceed \_\_\_\_\_ Dollars (\$0.00) for the personal services and other operating expenses of the Office of the State Auditor and Inspector in performing audits of the Oklahoma Tax Commission and motor license agents as required by law.

SECTION 56. There is hereby appropriated to the Office of the State Treasurer from any monies not otherwise appropriated from the

General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2002, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the State Treasurer by law.

SECTION 57. There is hereby appropriated to the Office of the State Treasurer from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary to pay for bank service charges.

SECTION 58. There is hereby appropriated to the Office of the State Treasurer for deposit in the State Land Reimbursement Fund from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary to make payments to counties for agricultural land free of homesteads which is owned by the state as school or park land.

SECTION 59.
