COMMUNICATION**EXECUTIVE DECLARATION OF EMERGENCY CONDITIONS**

I, Frank Keating, pursuant to the provisions of Section 23 of Article X of the Oklahoma Constitution, hereby declare that an emergency exists in the State of Oklahoma by reason of a lack of adequate funding for programs vital to the continued economic, educational, and social development of Oklahomans, and for health and safety issues.

Having declared that emergency conditions exist, I request the Senate and House of Representatives to concur in this declaration of emergency and to appropriate One Hundred Seventy Million Three Hundred Forty-two Thousand Eight Hundred Sixty-five Dollars (\$170,342,865.00) from the Constitutional Reserve Fund for the following purposes in the following amounts:

1. To the Department of Environmental Quality for costs associated with Tar Creek in the amount of Four Million Dollars (\$4,000,000.00).
2. To the State Board of Education for FY-2002 costs of the certified and support staff flexible benefits in the amount of Three Million Seven Hundred Six Thousand Eighty-Six Dollars (\$3,706,086.00).
3. To the State Board of Education for FY-2002 cost of National Board certification stipends in the amount of One Hundred Seventy Thousand Dollars (\$170,000.00).
4. To the State Board of Education for FY-2002 financial support of public schools in the amount of Six Million One Hundred Ninety-Two Thousand Eight Hundred Ninety-eight Dollars (\$6,192,898.00).
5. To the State Board of Education for annualizing the FY-2003 costs of the certified and support staff flexible benefits in the amount of Three Million Seven Hundred Six Thousand Eighty-Six Dollars (\$3,706,086.00).
6. To the State Board of Education for annualizing the FY-2003 cost of the National Board certification stipends in the amount of One Hundred Seventy Thousand Dollars (\$170,000.00).
7. To the State Ethics Commission for FY-2002 operating costs in the amount of Sixty-eight Thousand Nine Hundred Thirty-eight Dollars (\$68,938.00).
8. To the State Emergency Fund for matching federal disaster funds and for other disaster related assistance in the amount of Five Million Five Hundred One Thousand Dollars (\$5,501,000.00).
9. To the State Regents for Higher Education for FY-2002 allocation to the state institutions in the amount of Thirteen Million Three Hundred Eighty-five Thousand Seven Hundred Ninety-six Dollars (\$13,385,796.00).

10. To the State Regents for Higher Education for FY-2003 allocations to the state institutions in the amount of Forty-One Million Three Hundred Thousand Dollars (\$41,300,000.00).

11. To the State Regents for Higher Education for FY-2003 costs associated with operations at the University of Oklahoma/Tulsa campus in the amount of One Million Dollars (\$1,000,000.00).

12. To the State Regents for Higher Education for FY-2003 costs associated with operations at the Oklahoma State University/Tulsa campus in the amount of Two Million Five Hundred Thousand Dollars (\$2,500,000.00).

13. To the Oklahoma Educational and Television Authority for transmitter costs in the amount of Four Hundred Thousand Dollars (\$400,000.00).

14. To the Department of Labor for duties in the amount of Three Hundred Thousand Dollars (\$300,000.00).

15. To the Department of Central Services for costs associated with the Jim Thorpe Building in the amount of Five Hundred Thousand Dollars (\$500,000.00).

16. To the Health Care Authority for operations in the amount of Fifty-three Million Dollars (\$53,000,000.00)

Following a review of **House Bill 2911**, delivered to the Secretary of State on May 23, 2002, the section of the bill that requires evidence of approval by the Governor does not bear his approval or signature. The Governor was presented and received **HB 2911** on May 15, 2002.

In accordance with Article 6 Oklahoma Constitution, Section 11, "If any bill or resolution shall not be returned by the Governor within five days (Sundays excepted) after it shall have been presented to him, the same shall be a law in like manner as if he had signed it..."

According to Article 6 Oklahoma Constitution, Section 11, **House Bill 2911** has become law without the Governor's signature. A copy of the House Bill is enclosed.
