AMENDMENT NO. 1. Page 1, strike the title, enacting clause and entire bill and insert

McCarty Center for Children with Developmental Disabilities, the Department of Mental Health and Substance Abuse Services, the University Hospitals Authority, the

Oklahoma Department of Veterans Affairs, the Oklahoma Commission on Children and Youth, the Office of Handicapped Concerns, the Oklahoma Human Rights Commission, the Department of Human Services, the Oklahoma Indian Affairs Commission, the Office of Juvenile Affairs, the State Department of Rehabilitation Services, the Oklahoma Department of Agriculture, Food, and Forestry, the Oklahoma Capitol Complex and Centennial Commemoration Commission, the Department of Commerce, the Oklahoma Conservation Commission, the Department of Consumer Credit, the Corporation Commission, the Department of Environmental Quality, the Oklahoma Historical Society, the Oklahoma Horse Racing Commission, the State Insurance Department, the J.M. Davis Memorial Commission, the Department of Labor, the Department of Mines, the Oklahoma Scenic Rivers Commission, the Department of Securities, the Oklahoma Tourism and Recreation Department, the Oklahoma Water Resources Board, the Will Rogers Memorial Commission, the Alcoholic Beverage Laws Enforcement Commission, the Department of Corrections, the Pardon and Parole Board, the Oklahoma State Bureau of Investigation, the State Fire Marshal, the Board of Medicolegal Investigations, the Council on Law Enforcement Education and Training, the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control, the Department of Public Safety, the Oklahoma Indigent Defense System, the Office of the Attorney General, the Court of Criminal Appeals, the Supreme Court, the Workers' Compensation Court, the Council on Judicial Complaints, and the Rural Economic Action Plan Fund; stating sums of the appropriations; stating purposes and restrictions; authorizing and requiring certain expenditures; authorizing and requiring certain transfers; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SUBCOMMITTEE ON EDUCATION

SECTION 1. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of One Billion One Hundred Eleven Million One Hundred Forty-six Thousand Six Hundred Fifteen Dollars (\$1,111,146,615.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 2. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Education Reform Revolving Fund created in Section 41.29b of Title

62 of the Oklahoma Statutes, the sum of Four Hundred Fifteen Million Eight Hundred Eleven Thousand Nine Hundred Five Dollars (\$415,811,905.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 3. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Mineral Leasing Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of One Million Nine Hundred Thousand Dollars (\$1,900,000.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 4. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Mineral Leasing Fund of the State Treasury for the fiscal year ending June 30, 2003, the sum of Two Hundred Twenty Thousand Fifty-seven Dollars (\$220,057.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 5. The State Board of Education is hereby authorized to expend during the fiscal year ending June 30, 2005, from the Common Education Technology Revolving Fund of the State Treasury, the sum of Thirty Million Four Hundred Fifty-three Thousand Four Hundred Fifty-three Dollars (\$30,453,453.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 6. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of One Hundred Twenty-three Million Seven Hundred Twenty-eight Thousand Five Hundred Ninety-one Dollars (\$123,728,591.00) or so much thereof as may be necessary for the support of public school activities.

SECTION 7. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year

ending June 30, 2005, the sum of Seventy-eight Million Five Hundred Ninety-five Thousand One Hundred Forty-nine Dollars (\$78,595,149.00) or so much thereof as may be necessary for the support of public school activities.

SECTION 8. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of Thirty-three Million Dollars (\$33,000,000.00) or so much thereof as may be necessary for the purchase of textbooks.

SECTION 9. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of Fourteen Million Two Hundred Eighty-nine Thousand Two Hundred Seventy-four Dollars (\$14,289,274.00) or so much thereof as may be necessary for Administrative and Support Functions of the State Department of Education.

SECTION 10. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of One Hundred Twenty-five Million Five Hundred Twenty-five Thousand Nine Hundred Forty-two Dollars (\$125,525,942.00) or so much thereof as may be necessary for the Certified Employee Health Benefit Allowance.

SECTION 11. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of Seventy-five Million One Hundred Eighty-six Thousand Two Hundred Forty-nine Dollars (\$75,186,249.00) or so much thereof as may be necessary for the Support Personnel Health Benefit Allowance.

SECTION 12. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of Six Hundred Twenty-nine Million Five Hundred One Thousand Seven Hundred Ninety-six Dollars (\$629,501,796.00) or so much thereof as may be necessary for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 13. The Oklahoma State Regents for Higher Education are hereby authorized to expend during the fiscal year ending June 30, 2005, the sum of Thirty Million Four Hundred Fifty-three Thousand Four Hundred Fifty-three Dollars (\$30,453,453.00) from the Higher Education Capital Revolving Fund of the State Treasury for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 14. The Oklahoma State Regents for Higher Education are hereby authorized to expend during the fiscal year ending June 30, 2005, the sum of Thirty Million Four Hundred Fifty-three Thousand Four Hundred Fifty-three Dollars (\$30,453,453.00) from the Oklahoma Tuition Scholarship Revolving Fund of the State Treasury for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or

repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 15. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of Five Million One Hundred Ninety-nine Thousand Eighty-eight Dollars (\$5,199,088.00) or so much thereof as may be necessary for the general operating budget of the Administrative Offices of the Oklahoma State Regents for Higher Education.

SECTION 16. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of Fifteen Million Twenty-two Thousand Seven Hundred Eighty-seven Dollars (\$15,022,787.00) or so much thereof as may be necessary for expenditures in the Oklahoma Higher Learning Access Program.

SECTION 17. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of Seven Million Five Hundred Thousand Dollars (\$7,500,000.00) or so much thereof as may be necessary for expenditures in the endowed chairs program.

SECTION 18. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of Seventy-eight Million Five Hundred Thirty Thousand Five Hundred Ninety-nine Dollars (\$78,530,599.00) or so much thereof as may be necessary for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 19. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of Two Hundred Fifty Thousand One Hundred Twenty Dollars (\$250,120.00) or so much thereof as may be necessary for the Office of Accountability to perform the duties imposed upon the Office of Accountability by law.

SECTION 20. There is hereby appropriated to the State Board of Career and Technology Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of One Hundred Twelve Million Thirty-three Thousand Nine Hundred Twenty-four Dollars (\$112,033,924.00) or so much thereof as may be necessary to perform the duties imposed upon the State Board of Career and Technology Education by law.

SECTION 21. There is hereby appropriated to the State Board of Career and Technology Education from monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of Six Million One Hundred Fifty-seven Thousand Two Hundred Fifteen Dollars (\$6,157,215.00) or so much thereof as may be necessary for the Certified Employee Health Benefit Allowance.

SECTION 22. There is hereby appropriated to the State Board of Career and Technology Education from monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of Five Million Five Hundred Fifty-two Thousand Four Hundred Thirty-four Dollars (\$5,552,434.00) or so much thereof as may be necessary for the Support Personnel Health Benefit Allowance.

SECTION 23. There is hereby appropriated to the Oklahoma Arts Council from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June

30, 2005, the sum of Three Million Eight Hundred Seventy-eight Thousand Eight Hundred Seventy-one Dollars (\$3,878,871.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Arts Council by law.

SECTION 24. There is hereby appropriated to the Oklahoma Educational Television Authority from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of Four Million Two Hundred One Thousand Seven Hundred Fifty-three Dollars (\$4,201,753.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Educational Television Authority by law.

SECTION 25. There is hereby appropriated to the Commissioners of the Land Office from any monies not otherwise appropriated from the Commissioners of the Land Office Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of Four Million One Hundred Sixty-one Thousand Nine Hundred Sixty-five Dollars (\$4,161,965.00) or so much thereof as may be necessary to perform the duties imposed upon the Commissioners of the Land Office by law.

SECTION 26. There is hereby appropriated to the Oklahoma Department of Libraries from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of Six Million Two Hundred Twelve Thousand One Hundred Eighteen Dollars (\$6,212,118.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Department of Libraries by law.

SECTION 27. There is hereby appropriated to the Physician Manpower Training Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of Five Million Twenty-four Thousand Six Hundred Seven Dollars (\$5,024,607.00) or so

much thereof as may be necessary to perform the duties imposed upon the Physician Manpower Training Commission by law.

SECTION 28. There is hereby appropriated to the Oklahoma Board of Private Vocational Schools from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of One Hundred Fifty-five Thousand Four Hundred Fifty-six Dollars (\$155,456.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Board of Private Vocational Schools by law.

SECTION 29. There is hereby appropriated to the Board of Trustees of the Oklahoma School of Science and Mathematics from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of Six Million Four Hundred Twenty-two Thousand Three Hundred Nineteen Dollars (\$6,422,319.00) or so much thereof as may be necessary to perform the duties imposed upon the Board of Trustees of the Oklahoma School of Science and Mathematics by law.

SECTION 30. There is hereby appropriated to the Oklahoma Center for the Advancement of Science and Technology from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of Eleven Million Two Hundred Ninety-four Thousand Six Hundred Forty-seven Dollars (\$11,294,647.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Center for the Advancement of Science and Technology by law.

SECTION 31. There is hereby appropriated to the Oklahoma Commission for Teacher Preparation from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of One Million Nine Hundred Ninety-eight Thousand One Hundred Sixty-eight Dollars (\$1,998,168.00) or so much thereof as may be necessary to perform

the duties imposed upon the Oklahoma Commission for Teacher Preparation by law.

SUBCOMMITTEE ON GENERAL GOVERNMENT AND TRANSPORTATION

SECTION 32. There is hereby appropriated to the Office of the State Auditor and Inspector from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of Four Million Nine Hundred Fifty-one Thousand Five Hundred Seventy-seven Dollars (\$4,951,577.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the State Auditor and Inspector by law.

SECTION 33. There is hereby appropriated to the Office of the State Auditor and Inspector from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of Four Hundred Sixty-three Thousand One Hundred Ninety-nine Dollars (\$463,199.00) or so much thereof as may be necessary to perform the duties imposed upon the Commission on County Government Personnel Education and Training. The appropriation made in this section shall be expended exclusively for the purpose so stated and shall not be transferable.

SECTION 34. There is hereby appropriated to the Office of the State Bond Advisor from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of One Hundred Sixty-seven Thousand Ninety-six Dollars (\$167,096.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the State Bond Advisor by law.

SECTION 35. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of Eight Million Five Hundred Seventy-five Thousand Six Hundred Fifty-three Dollars (\$8,575,653.00) or so

much thereof as may be necessary to perform the duties imposed upon the Department of Central Services by law.

SECTION 36. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of Two Million Eight Hundred Twenty-two Thousand Three Hundred Forty-eight Dollars (\$2,822,348.00) to be transferred to the Building and Facility Revolving Fund created in Section 63.1 of Title 74 of the Oklahoma Statutes for the purpose of maintaining state buildings operated by the Department of Central Services.

SECTION 37. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of Three Thousand Eight Hundred Eighty-four Dollars (\$3,884.00) or so much thereof as may be necessary to perform maintenance on the Veterans Memorial within the Capitol complex.

SECTION 38. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of One Hundred Fifty-one Thousand Five Hundred Eighteen Dollars (\$151,518.00) or so much thereof as may be necessary to maintain the Hissom Memorial Center.

SECTION 39. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the Public Building Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of One Million Two Hundred Seventy-six Thousand Six Hundred Thirty-three Dollars (\$1,276,633.00) or so much thereof as may be necessary for asbestos abatement programs and for the expenses of filing claims for reimbursement from the Manville Property Damage Settlement Trust. The monies designated in this

section shall be expended exclusively for the purposes so stated and shall not be transferable.

SECTION 40. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the "Jobs and Growth Tax Relief Fund" otherwise designated as Fund 720 within the Office of State Finance, the sum of Three Hundred Thousand Dollars (\$300,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Central Services by law.

SECTION 41. There is hereby appropriated to the Oklahoma Department of Emergency Management from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of Six Hundred Eighty Thousand Nine Hundred Seventy-two Dollars (\$680,972.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Department of Emergency Management by law.

SECTION 42. There is hereby appropriated to the State Election Board from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of Five Million Six Hundred Twenty-two Thousand One Hundred Twenty-nine Dollars (\$5,622,129.00) or so much thereof as may be necessary to perform the duties imposed upon the State Election Board by law.

SECTION 43. There is hereby appropriated to the State Election Board from any monies not otherwise appropriated from the "Jobs and Growth Tax Relief Fund" otherwise designated as Fund 720 within the Office of State Finance, the sum of One Million Four Hundred Fifty Thousand Dollars (\$1,450,000.00) or so much thereof as may be necessary to perform the duties imposed upon the State Election Board by law.

SECTION 44. There is hereby appropriated to the Ethics Commission from any monies not otherwise appropriated from the

General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of Four Hundred Twenty Thousand Seven Hundred Forty-seven Dollars (\$420,747.00) or so much thereof as may be necessary to perform the duties imposed upon the Ethics Commission by law.

SECTION 45. There is hereby appropriated to the Office of State Finance from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of Eighteen Million Eight Hundred Seventy-four Thousand Five Hundred Thirty-five Dollars (\$18,874,535.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of State Finance by law.

SECTION 46. There is hereby appropriated to the Office of the Governor from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of Two Million Five Hundred Twenty-two Thousand Seven Hundred Nine Dollars (\$2,522,709.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the Governor by law.

SECTION 47. There is hereby appropriated to the Oklahoma House of Representatives from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the following amount, or so much thereof as may be necessary to pay monthly salaries, per diem, and expenses of the members of the House of Representatives and the salaries of its employees, and such contingent expenses as may be ordered paid therefrom, including the preparation and printing of the journals and calendars of the House of Representatives, and including the preparation and printing of the permanent journals thereof, in accordance with the following amount herein set forth:

For expenses of personnel services  
(including retirement and insurance

costs), including those of members, and employees of the House of Representatives, and expenses of maintenance and operation, including travel expenses, supplies, materials, printing, equipment, and printing of permanent journals; and for the renovation and modification of the House of Representatives area; and other necessary expenses \$17,730,670.00

Claims and payrolls filed against the appropriation made to the House of Representatives for the fiscal year ending June 30, 2005, shall be approved by the Speaker of the House of Representatives.

SECTION 48. There is hereby appropriated to the Legislative Service Bureau from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of One Million Ninety Thousand One Hundred Ninety-nine Dollars (\$1,090,199.00) or so much thereof as may be necessary to perform the duties imposed upon the Legislative Service Bureau by law.

SECTION 49. There is hereby appropriated to the Legislative Service Bureau from any monies not otherwise appropriated from the "Jobs and Growth Tax Relief Fund" otherwise designated as Fund 720 within the Office of State Finance, the sum of Four Hundred Thousand Dollars (\$400,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Legislative Service Bureau by law.

SECTION 50. There is hereby appropriated to the Legislative Service Bureau from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of Six Hundred Twelve Thousand Nine Hundred Ninety-four Dollars (\$612,994.00) or so much thereof as may

be necessary to perform the duties imposed upon the Oklahoma Criminal Justice Resource Center by law.

SECTION 51. There is hereby appropriated to the Department of Corrections from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of Three Hundred Eighty-four Million One Hundred Sixty-one Thousand Five Hundred Sixty-eight Dollars (\$384,161,568.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Corrections by law.

SECTION 111. There is hereby appropriated to the Pardon and Parole Board from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of Two Million One Hundred Fifty Thousand Three Hundred Twenty-eight Dollars (\$2,150,328.00) or so much thereof as may be necessary to perform the duties imposed upon the Pardon and Parole Board by law.

SECTION 112. There is hereby appropriated to the Oklahoma State Bureau of Investigation from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of Nine Million Six Hundred Eighty-one Thousand Nine Hundred Ten Dollars (\$9,681,910.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma State Bureau of Investigation by law.

SECTION 113. There is hereby appropriated to the State Fire Marshal from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of One Million Five Hundred Thirty-seven Thousand Sixty-one Dollars (\$1,537,061.00) or so much thereof as may be

necessary to perform the duties imposed upon the State Fire Marshal by law.

SECTION 114. There is hereby appropriated to the Board of Medicolegal Investigations from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of Three Million Four Hundred Twenty-seven Thousand Three Hundred Seventy-two Dollars (\$3,427,372.00) or so much thereof as may be necessary to perform the duties imposed upon the Board of Medicolegal Investigations by law.

SECTION 115. There is hereby appropriated to the Council on Law Enforcement Education and Training from any monies not otherwise appropriated from the C.L.E.E.T. Fund for the fiscal year ending June 30, 2005, the sum of One Million Nine Hundred Ninety-eight Thousand Three Hundred Eighty-six Dollars (\$1,998,386.00) or so much thereof as may be necessary to perform the duties imposed upon the Council on Law Enforcement Education and Training by law.

SECTION 116. There is hereby appropriated to the Council on Law Enforcement Education and Training from any monies not otherwise appropriated from the C.L.E.E.T. Fund for the fiscal year ending June 30, 2003, the sum of Three Hundred Fifty-four Thousand One Hundred Forty-two Dollars (\$354,142.00) or so much thereof as may be necessary to perform the duties imposed upon the Council on Law Enforcement Education and Training by law.

SECTION 117. There is hereby appropriated to the Council on Law Enforcement Education and Training from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of Three Hundred Thirty-three Thousand Seven Hundred Ninety Dollars (\$333,790.00) or so much thereof as may be necessary to perform the duties imposed upon the Council on Law Enforcement Education and Training by law.

SECTION 118. There is hereby appropriated to the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of Four Million Nine Hundred Sixty-seven Thousand Sixty-two Dollars (\$4,967,062.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control by law.

SECTION 119. There is hereby appropriated to the Department of Public Safety from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of Sixty-four Million Five Hundred Sixty-six Thousand Five Hundred Sixty-six Dollars (\$64,566,566.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Public Safety by law.

SECTION 120. There is hereby appropriated to the Department of Public Safety from any monies not otherwise appropriated from the C.L.E.E.T. Fund for the fiscal year ending June 30, 2005, the sum of Four Hundred Ninety-five Thousand Four Hundred Thirty-eight Dollars (\$495,438.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Public Safety by law.

SECTION 121. There is hereby appropriated to the Oklahoma Indigent Defense System from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of Fourteen Million Two Hundred Twenty-eight Thousand Seven Hundred Sixty-one Dollars (\$14,228,761.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Indigent Defense System by law.

SECTION 122. There is hereby appropriated to the Oklahoma Indigent Defense System from any monies not otherwise appropriated from the "Jobs and Growth Tax Relief Fund" otherwise designated as Fund 720 within the Office of State Finance, the sum of Two Hundred

Thousand Dollars (\$200,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Indigent Defense System by law.

SECTION 123. There is hereby appropriated to the Office of the Attorney General from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of Five Million Eight Hundred Three Thousand Seven Hundred Seventy-eight Dollars (\$5,803,778.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the Attorney General by law.

SECTION 124. There is hereby appropriated to the Office of Attorney General from any monies not otherwise appropriated from the "Jobs and Growth Tax Relief Fund" otherwise designated as Fund 720 within the Office of State Finance, the sum of One Hundred Fifty Thousand Dollars (\$150,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of Attorney General by law.

SECTION 125. There is hereby appropriated to the Court of Criminal Appeals from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of Two Million Six Hundred Seventy-five Thousand Five Hundred Forty-one Dollars (\$2,675,541.00) or so much thereof as may be necessary to perform the duties imposed upon the Court of Criminal Appeals by law.

SECTION 126. There is hereby appropriated to the Supreme Court from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of Six Million Ninety-eight Thousand Five Hundred Eighty-six Dollars (\$6,098,586.00) or so much thereof as may be necessary to perform the duties imposed upon the district courts by law.

SECTION 127. There is hereby appropriated to the Supreme Court from any monies not otherwise appropriated from the State Judicial

Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of Thirty-one Million Seven Hundred Eighty-seven Thousand Twenty-seven Dollars (\$31,787,027.00) or so much thereof as may be necessary to perform the duties imposed upon the district courts by law.

SECTION 128. There is hereby appropriated to the Supreme Court from any monies not otherwise appropriated from the State Judicial Fund of the State Treasury for the fiscal year ending June 30, 2003, the sum of Three Million Four Hundred Eighty-four Thousand Six Hundred Twelve Dollars (\$3,484,612.00) or so much thereof as may be necessary to perform the duties imposed upon the district courts by law.

SECTION 129. There is hereby appropriated to the Office of the Attorney General from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of Twenty-six Million Four Hundred Twenty-six Thousand Seven Hundred Thirty-one Dollars (\$26,426,731.00) or so much thereof as may be necessary to perform the duties imposed upon the District Attorneys Council by law. Of the funds appropriated herein, the Office of the Attorney General shall transfer up to the sum of Five Hundred Fifteen Thousand Three Hundred Seventeen Dollars (\$515,317.00) or so much thereof as may be required by the district attorneys and District Attorneys Council to the District Attorneys Evidence Fund for necessary expenses relative to any case within the official responsibility of the offices of the district attorneys as provided by Section 215.40 of Title 19 of the Oklahoma Statutes.

SECTION 130. For the fiscal year ending June 30, 2005, the District Attorneys Council is authorized to transfer an amount not to exceed Three Hundred Thousand Dollars (\$300,000.00), on an as-needed basis, from the Crime Victims Compensation Revolving Fund created by Section 142.17 of Title 21 of the Oklahoma Statutes to

the Sexual Assault Examination Fund created by Section 142.20 of Title 21 of the Oklahoma Statutes.

SECTION 131. For the fiscal year ending June 30, 2005, up to Four Hundred Seventy-five Thousand Dollars (\$475,000.00) is authorized to be transferred from the Crime Victims Compensation Revolving Fund, created by Section 142.17 of Title 21 of the Oklahoma Statutes to the District Attorneys Council for eight employees, including related duties to support the Crime Victims Compensation Board.

SECTION 132. For the fiscal year ending June 30, 2005, up to One Million Three Hundred Two Thousand Dollars (\$1,302,000.00) is authorized to be transferred from the Crime Victims Compensation Revolving Fund, created by Section 142.17 of Title 21 of the Oklahoma Statutes to the District Attorneys Council for duties to support Victim-Witness Services.

SECTION 133. There is hereby appropriated to the Workers' Compensation Court from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of Three Million Seven Hundred Seventy Thousand Four Hundred Nine Dollars (\$3,770,409.00) or so much thereof as may be necessary to perform the duties imposed upon the Workers' Compensation Court by law.

SECTION 134. There is hereby appropriated to the Supreme Court from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of Ten Million One Hundred Seventy-two Thousand Six Hundred Ninety-nine Dollars (\$10,172,699.00) or so much thereof as may be necessary to perform the duties imposed upon the Supreme Court or Court of Civil Appeals by law.

SECTION 135. There is hereby appropriated to the Supreme Court from any monies not otherwise appropriated from the "Jobs and Growth Tax Relief Fund" otherwise designated as Fund 720 within the Office

of State Finance, the sum of Five Hundred Thousand Dollars (\$500,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Supreme Court or Court of Civil Appeals by law.

SECTION 136. There is hereby appropriated to the Supreme Court from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of Seven Hundred Sixty-four Thousand Eight Hundred Forty-five Dollars (\$764,845.00) to transfer to the Legal Services Revolving Fund created pursuant to subsection G of Section 921.1 of Title 12 of the Oklahoma Statutes.

SECTION 137. There is hereby appropriated to the Supreme Court for deposit in the Supreme Court Revolving Fund from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of Nine Hundred Thousand Dollars (\$900,000.00) for expenditures authorized by Section 1310.1 of Title 20 of the Oklahoma Statutes.

SECTION 138. There is hereby appropriated to the Council on Judicial Complaints from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of Two Hundred Seventy-one Thousand One Hundred Fifty-two Dollars (\$271,152.00) or so much thereof as may be necessary to perform the duties imposed upon the Council on Judicial Complaints by law.

SECTION 139. There is hereby appropriated to the Rural Economic Action Plan Fund of the State Treasury from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of Fifteen Million Five Hundred Thousand Dollars (\$15,500,000.00) or so much thereof as may be necessary to implement the provisions of Sections 2006 through 2013 of Title 62 of the Oklahoma Statutes.

SECTION 140. There is hereby appropriated to the Oklahoma Department of Commerce from any monies not otherwise appropriated from the "Jobs and Growth Tax Relief Fund" otherwise designated as Fund 720 within the Office of State Finance, the sum of One Hundred Twenty-one Thousand Dollars (\$121,000.00) or so much thereof as may be necessary to the Native American Cultural and Educational Authority Fund for the purpose of paying debt service on outstanding bonds. Said funds are hereby authorized to be transferred to the Native American Cultural and Educational Authority Fund as created by Section 1226.17 of Title 74 of the Oklahoma Statutes.

SECTION 141. There is hereby appropriated to the Department of Corrections from any monies not otherwise appropriated from the "Jobs and Growth Tax Relief Fund" otherwise designated as Fund 720 within the Office of State Finance, the sum of Five Million Dollars (\$5,000,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Corrections by law.

SECTION 142. There is hereby appropriated to the Board of Medicolegal Investigations from any monies not otherwise appropriated from the "Jobs and Growth Tax Relief Fund" otherwise designated as Fund 720 within the Office of State Finance, the sum of One Hundred Thousand Dollars (\$100,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Board of Medicolegal Investigations by law.

SECTION 143. There is hereby appropriated to the Oklahoma Tax Commission from any monies not otherwise appropriated from the "Jobs and Growth Tax Relief Fund" otherwise designated as Fund 720 within the Office of State Finance, the sum of Seven Million Fifty Thousand Dollars (\$7,050,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Tax Commission by law.

SECTION 144. There is hereby appropriated to the State Department of Health from any monies not otherwise appropriated from the "Jobs and Growth Tax Relief Fund" otherwise designated as Fund

720 within the Office of State Finance, the sum of One Hundred Fourteen Thousand Dollars (\$114,000.00) or so much thereof as may be necessary to perform the duties imposed upon the State Department of Health by law.

SECTION 145. There is hereby appropriated to the J.D. McCarty Center for Children with Developmental Disabilities from any monies not otherwise appropriated from the "Jobs and Growth Tax Relief Fund" otherwise designated as Fund 720 within the Office of State Finance, the sum of Three Hundred Thousand Dollars (\$300,000.00) or so much thereof as may be necessary to perform the duties imposed upon the J.D. McCarty Center for Children with Developmental Disabilities by law.

SECTION 146. There is hereby appropriated to the University Hospitals Authority from any monies not otherwise appropriated from the "Jobs and Growth Tax Relief Fund" otherwise designated as Fund 720 within the Office of State Finance, the sum of Two Million One Hundred Thirty-seven Thousand Four Hundred Sixty-seven Dollars (\$2,137,467.00) or so much thereof as may be necessary to perform the duties imposed upon the University Hospitals Authority by law.

SECTION 147. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of Four Hundred Sixty-four Thousand Five Hundred Fifty (\$464,550.00) or so much thereof as may be necessary for the Education Leadership Oklahoma Program.

SECTION 148. Sections 1 through 139 of this act shall become effective July 1, 2004."
