A Concurrent Resolution commending and congratulating Jason White upon winning the Heisman Trophy and the Davey O'Brien National Quarterback Award; and directing distribution.

WHEREAS, in the 2003 football season, University of Oklahoma quarterback Jason White was statistically the best in the nation. During the pre-bowl season he led the nation in pass efficiency (174.75), scoring every 10.34 passes and had 16 completed passes of 40 yards or more, the most ever for an OU quarterback. During the pre-bowl football season, Jason White completed 265 of 414 passes for 3,744 yards and 40 touchdowns with only eight interceptions. With Jason White as the lead quarterback, the OU Sooners scored 50 or more points seven times, although Jason played the entire game in only three of Oklahoma's 12 victorious games; and

WHEREAS, on December 13, 2003, in New York, Jason White won the 69th Heisman Trophy, indicating that in 2003 he was the best college football player in the nation. He became only the fourth Sooner and

first University of Oklahoma quarterback to win this honor. Jason White also won the 27th Annual Davey O'Brien National Quarterback Award.

NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE 2ND SESSION OF THE 49TH OKLAHOMA LEGISLATURE, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN:

THAT the Oklahoma State Legislature commends and congratulates Jason White upon his selection as the 2003 Heisman Trophy winner and winning the 2003 Davey O'Brien National Quarterback Award.

THAT a copy of this resolution be distributed to Jason White.
