A Concurrent Resolution authorizing the University Hospitals Trust to demolish or remove certain property; and directing distribution.

WHEREAS, the University Hospitals Trust is in need of land to construct a children's ambulatory clinic; and

WHEREAS, in order to construct the children's ambulatory clinic the University Hospitals Trust is requesting authorization to demolish and remove property to which it holds title in order to construct such clinic.

NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE 2ND SESSION OF THE 49TH OKLAHOMA LEGISLATURE, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN:

THAT notwithstanding any other law to the contrary, for the purpose of constructing a children's ambulatory clinic, the University Hospitals Trust is authorized to remove or demolish any or all buildings and appurtenances to which it holds title located on the land described as follows:

A tract or parcel of land located in a part of the Southeast Quarter (SE 1/4) of Section Twenty Seven (27), Township Twelve (12) North, Range Three (3) West of the Indian Meridian, Oklahoma County, Oklahoma, more particularly described as follows:

Commencing at the Southwest corner of Block Thirteen (13), of Howe's Capitol Addition to Oklahoma City; thence S 89° 47' 37" E along the South line of said Block Thirteen (13) a distance of 27.50 feet to a point on the East right-of-way line of Phillips Avenue; thence N 00° 10' 36" E along said East right-of-way line a distance of 674.65 feet to a point on the South right-of-way line of Northeast 13th Street; thence S 89° 48' 51" E along said South right-of-way line a distance of 189.60 feet to the point or place of beginning; thence S 00° 11' 09" W a distance of 75.00 feet; thence S 89° 48' 51" E along a line parallel to and 75.00 feet south of said South right-of-way

line a distance of 177.50 feet; thence N 00° 11' 09" E a distance of 75.00 feet to a point on said South right-of-way line; thence N 89° 48' 51" W along said South right-of-way line a distance of 177.50 feet more or less to the point or place of beginning. Containing 0.31 acres more or less.

THAT a copy of this resolution be distributed to the Executive Director of the University Hospitals Trust, the President Pro Tempore of the Senate and the Speaker of the House of Representatives.
