SENATE BILL NO. 900 - By: PRUITT and EASLEY of the Senate and MORGAN (Fred) of the House.

[ state government - relating to surplus property agent -  
authorizing participation in surplus military equipment -  
effective date ]

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 80 O.S. 2001, Section 34.3, is amended to read as follows:

Section 34.3 The Surplus Property Agent shall, under the supervision and direction of the Director of the Department of Central Services:

A. 1. Ascertain from the federal government through any of its agencies, any surplus property available for sale, lease, or donation either within or outside this state and shall notify the state departments, boards, commissions, institutions, and agencies, counties, cities, and towns, and school districts of the availability of such property as is deemed necessary according to the types and quantities of property available;

2. Secure from state departments, boards, commissions, institutions, and agencies and from counties, cities, and towns, and

1 school districts, estimates of their needs for surplus property and  
2 keep federal agencies informed of such needs;

3 3. Purchase, or accept as gifts or donations, any surplus  
4 property from the federal government, its departments or agencies  
5 for redistribution, by sale or donation to any state department,  
6 board, commission, institution, or agency and to counties, cities,  
7 or towns, and school districts, and provide for the care and  
8 handling, transportation, and warehousing of property if necessary;

9 4. Distribute surplus property to state departments, boards,  
10 commissions, institutions, and agencies and to counties, cities,  
11 towns, school districts, and other entities authorized by the  
12 federal government to receive federal surplus property, provided,  
13 the entity reimburses the Surplus Property Agent for the purchase  
14 price and expenses incurred in connection with acquiring,  
15 warehousing, and distributing the surplus property;

16 5. With the approval of the Director of the Department of  
17 Central Services, employ such employees and assistants as may be  
18 necessary to carry out the purposes of ~~Sections 34.1 through 34.7~~ et  
19 seq. of this title;

20 6. Make acquisition of surplus automobiles in a manner  
21 consistent with other applicable sections of law in this state; and

22 7. Perform other duties as are necessary for the purposes of  
23 ~~Sections 34.1 through 34.7~~ et seq. of this title.

1        B. The surplus property agent may participate in programs  
2 through which the Government of the United States offers to provide  
3 surplus military equipment, including weapons, protective clothing  
4 and transportation devices.

5        SECTION 2. This act shall become effective November 1, 2004.
