

An Act relating to revenue and taxation; amending 68 O.S. 2001, Section 1354, which relates to sales subject to tax; providing for taxation of tangible personal property sold by certain Indian tribes to certain consumers; making the consumer or user liable for remitting the tax; establishing a penalty; requiring the Oklahoma Tax Commission to adopt rules; providing an effective date; and declaring an emergency.
