

An Act relating to revenue and taxation; amending 68 O.S. 2001, Section 2829, which relates to valuation methods for ad valorem taxation; prohibiting use of certain sales transactions; providing an exception; imposing statistical requirements with respect to fair cash value; and providing an effective date.
