

An Act relating to revenue and taxation; allowing credit against income taxes for individual taxpayer with child under six years old and an unemployed spouse; providing for amount of credit; providing income limit to claim credit; limiting definition of unemployed; limiting credit; providing for credit to be carried forward; providing for codification; and providing an effective date.
