

An Act relating to motor vehicles; amending 47 O.S. 2001, Sections 1104.1, 1104.2, 1104.3, 1104.4, 1104.5, Section 2, Chapter 179, O.S.L. 2002 and Section 2, Chapter 319, O.S.L. 2002 (47 O.S. Supp. 2003, Sections 1104.6 and 1104.7), which relate to Oklahoma Motor Vehicle License and Registration Act; modifying apportionment of certain fees for specified license plates; providing for apportionment of fee for Color Oklahoma license plate; creating Color Oklahoma Revolving Fund and providing for deposits thereto and expenditures therefrom; providing for apportionment of fee for Fight Cancer license plate; creating Oklahoma Central Cancer Registry Revolving Fund and providing for deposits thereto and expenditures therefrom; specifying fee; providing limitations on transferability, fees, procedures for renewal and other procedures for special license plates for political subdivisions, tax-exempt or nonprofit, Physically Disabled, Indian Tribal, Hearing Impaired, Antique or Classic Vehicles and Honorary Consuls; providing for design and use of special license plates; providing for disposition of fees; providing limitations on transferability, procedures for renewal and other procedures for special license plates for recognition of service or awards; directing Oklahoma Tax Commission to develop specified system; providing for special license plates for Prisoner of War, National Guard, Air National Guard, United States Armed Forces, Congressional Medal of Honor Recipient, Missing In Action, Purple Heart Recipient, Pearl Harbor Survivor, D-Day Survivor, Killed in Action, Gold Star Parents, Military Decoration, Vietnam Veteran, Police Officer, World War II Veteran, Korean War Veteran, Municipal Official, Red Cross Volunteer, Veterans of Foreign Wars, Desert Storm, Military Reserve Unit, Oklahoma City Bombing Victims and Survivors, Civil Air Patrol, Ninety-Nines, Combat Infantry Badge, Somalia Combat Veterans, Police Chaplain, Joint Service Commendation Medal, Merchant Marine, Legislative, Disabled Veterans, United States Air Force Association, Oklahoma Military Academy Alumni, Amateur Radio Operator, Former Legislator, American Legion and Deputy Sheriffs; providing fee for special license plates; providing for disposition of fees; providing for design and issuance of special license plates for persons wishing to demonstrate support, interest or membership; providing limitations on transferability, procedures for renewal and other procedures for special license plates; directing Oklahoma Tax Commission to develop specified system; providing for discontinuance of issuance and renewal of plates under certain conditions; providing for prepaid applications for certain plates; providing special license plates for Round and Square Dance, National Association for the Advancement of Colored People, National Rifle Association, Masonic Fraternity, Shriner's Hospitals for Burned and Crippled Children, Balloonists, Order of the Eastern Star, Knights of Columbus, Jaycees, Ducks Unlimited, Kiwanis International, Certified Public Accountants, Civil Emergency Management, Civilian Conservation Corps, Rotarian, Benevolent Protective Order of Elks, Humane Society, Oklahoma Mustang Club, American Business Clubs, West Point 200th Anniversary, Northern Cherokee Nation of Old Louisiana Territory, Oklahoma Aquarium, Pride of Broken Arrow, Fellowship of Christian Athletes, Parrothead Club, Oklahoma Bicycling Coalition, Electric Lineman, Alpha Kappa Alpha and Organ, Eye and Tissue; providing fee for special license plates; providing for disposition of fees; providing for design and issuance of personalized license; providing limitations on transferability, procedures for renewal and other procedures for personalized license plates; providing for personalized license plates for persons in certain combinations of numbers and letters, eligible for certain

military decoration, motorcycles in certain combinations of numbers and letters, eligible for Korean War and World War II Veteran plates in certain combinations of letters and numbers and vehicles of a specified age; providing fee for personalized license plates; providing for disposition of fees; providing for design and issuance of special license plates for persons wishing to demonstrate support and provide financial assistance; providing limitations on transferability, procedures for renewal and other procedures for special license plates; directing Oklahoma Tax Commission to develop specified system; providing for discontinuance of issuance and renewal of plates under certain conditions; providing for prepaid applications for certain plates; providing special license plates for University or College Supporter, Environmental Awareness, Firefighter, Wildlife Conservation, Child Abuse Prevention, United States Olympic Committee Supporter, Oklahoma History, Historic Route 66, Heart of the Heartland, Emergency Medical Technician, Fight Breast Cancer, Crime Victims Awareness, Oklahoma Safe Kids Association, Four-H Club, Agricultural Awareness, Oklahoma Statehood Centennial, Support Education, Retired Oklahoma Highway Patrol Officers, Boy Scouts of America Supporter, Urban Forestry and Beautification, Oklahoma State Parks Supporter, Adoption Creates Families, Choose Life, Future Farmers of America, Lions Club, Color Oklahoma, Girl Scouts of the United States of America, Oklahoma City Memorial Marathon, Oklahoma Scenic Rivers and Fight Cancer; providing fee for personalized license plates; providing for disposition of fees; providing for design and issuance of special license plate for National Association of Stock Car Auto Racing Driver; providing for fee and disposition thereof; providing for design and issuance of special license plate for Animal Friendly Fund; specifying fee for plate; authorizing Oklahoma Tax Commission to enter into certain licensing agreement and to establish certain procedure for determining order in which plates are sold; amending 68 O.S. 2001, Section 113, which relates to tax administration; exempting certain disbursements from certain fund from agency budget limits; requiring Oklahoma Tax Commission to provide opportunity for taxpayers to donate income tax refunds for benefit of Oklahoma Pet Overpopulation Fund; creating the Oklahoma Pet Overpopulation Fund; specifying distribution of funds; creating Animal Friendly Revolving Fund; specifying distribution of funds; amending 70 O.S. 2001, Section 2282, which relates to schools and scholarship funds; modifying statutory reference pertaining to Heart of the Heartland Scholarship Fund; directing Oklahoma Tax Commission to enter into specified study and implement uniform format for special license plate; providing Oklahoma Capital Improvement Authority with certain authorization to construct building, provide funding, borrow monies and issue negotiable obligations; expressing legislative intent; authorizing the use of certain funds; providing specific authority with respect to the issuance of bonds; providing for the sale and redemption of specified bonds; providing for utilization of certain funds; providing certain exemption from taxation; providing for the investment of certain funds; placing management, maintenance and operation of specified buildings and improvements under the control of the Oklahoma Tax Commission; providing for transfer of certain buildings or improvements under certain circumstances; allowing State Veterinarian to adopt various education programs; allowing State Veterinarian to work with certain entities; requiring State Veterinarian to implement certain procedures to expend funds; repealing 47 O.S. 2001, Section 1136, as amended by Section 2 of Enrolled House Bill No. 1890 of the 2nd Session of the 49th Oklahoma Legislature, which relates to special license plates;

repealing 47 O.S. 2001, Section 1136.1, which relates to license plates for antique or classic vehicles; repealing 47 O.S. 2001, Section 253, which relates to disposition of fees for certain special license plates; providing for codification; providing for noncodification; and providing an effective date.
