

An Act relating to motor vehicles; amending 47 O.S. 2001, Section 6-117, as amended by Section 17, Chapter 397, O.S.L. 2002 (47 O.S. Supp. 2002, Section 6-117), which relates to driver licenses; modifying fee for collision reports and driving record summaries and specifying apportionment thereof; amending 47 O.S. 2002, Sections 1102, as amended by Section 14, Chapter 22, O.S.L. 2002, Section 2, Chapter 319, O.S.L. 2002, 1105, as amended by Section 1, Chapter 454, O.S.L. 2002, 1113, as amended by Section 3, Chapter 417, O.S.L. 2002, 1115, as amended by Section 2 of Enrolled Senate Bill No. 234 of the 1st Session of the 49th Oklahoma Legislature, 1120, 1120.1, 1124.1, 1131, 1136, as last amended by Section 1 of Enrolled Senate Bill No. 355 of the 1st Session of the 49th Oklahoma Legislature, and 1151, as amended by Section 1, Chapter 59, O.S.L. 2002 (47 O.S. Supp. 2002, Sections 1102, 1104.7, 1105, 1113 and 1151), which relate to the Oklahoma Vehicle License and Registration Act; modifying and deleting definitions; requiring Oklahoma Tax Commission to assign number to certain vehicles and providing procedures related thereto; requiring certain information be stamped on certificate of title; deleting requirement for certain statement of origin; modifying decal to be issued upon vehicle registration; requiring Tax Commission to charge certain fee for replacement license plate; modifying requirements for payment of current or past-due fees and taxes with respect to vehicles donated to nonprofit charitable organizations; requiring Tax Commission to assess certain fee to process amended registration filed under International Registration Plan; providing that collection and payment thereof be prerequisite for amending registration; providing for apportionment of fee; clarifying assessment of registration fees on rental motor vehicles; defining term; authorizing Tax Commission to retain certain funds subject to certain provisions; directing use and apportionment of certain funds; specifying purposes for which certain temporary permits may be issued; removing requirement for Tax Commission to mail certain notices; recodifying provisions relating to special license plates; requiring display of certain sample license plate; allowing motor license agents to stock inventory of Future Farmers of America special license plates; creating special license plate for county and deputy sheriffs; creating special license plate for honorary consuls; creating special license plate for Color Oklahoma; creating Oklahoma City Memorial Marathon special license plate; creating the Beirut Combat Veteran special license plate; providing for apportionment of certain revenues; modifying time period when certain operation of vehicle deemed unlawful; amending 63 O.S. 2002, Sections 4013, 4020, 4021 and 4032, which relate to the Oklahoma Vessel and Motor Registration Act; modifying time by which secured party must deliver certain form and fee to Tax Commission or motor license agent; modifying requirements for payment of current or past-due fees and taxes with respect to vessel or motor donated to nonprofit charitable organizations; modifying time period when certain operation of vessel or motor deemed unlawful; repealing 47 O.S. 2001, Section 1105.4, which relates to the Oklahoma Vehicle License and Registration Act and 47 O.S. 2001, Section 1136, as last amended by Section 1 of Enrolled House Bill No. 1599 of the 1st Session of the 49th Oklahoma Legislature, which is a duplicate section and which relates to special license plates; providing for codification; providing for noncodification; providing an effective date; and declaring an emergency.
