AS INTRODUCED

A Concurrent Resolution commending and honoring Mike Bailey for receiving the Association of Community College Trustees Award for Trustee Leadership for the Western Region; and directing distribution.

WHEREAS, Mike Bailey is the recipient of the Association of Community Colleges Trustees in Washington, D.C., Award for Trustee Leadership for the Western Region of the United States; and

WHEREAS, Mike Bailey was appointed to the Board of Regents for Eastern Oklahoma State College in Wilburton by Governor Frank Keating in 2001; and

WHEREAS, Mike Bailey has exhibited a long history of outstanding leadership as Assistant Chief of the Choctaw Nation, selected Who's Who Among Top Executives internationally in 1999, and appointed by President Bill Clinton to the National Advisory Council of the United States Small Business Administration in 2000; and

WHEREAS, Mike Bailey has worked tirelessly to provide leadership in education, being selected as Administrator of the Year by the National Indian School Board Association in 1993, selected as one of Oklahoma's CareerTech Champions in 2001, appointed by Governor Brad Henry to serve as a member of the Steering Committee for *Oklahoma's*

EDGE: Economic Development Generating Excellence, and recipient of the Honorary State FFA Degree from the Oklahoma FFA Association, the highest award the State FFA Association can bestow; and

WHEREAS, Mike Bailey is an exceptional leader and advocate for all education representing the Choctaw Nation nationally and the State of Oklahoma; and

WHEREAS, Mike Bailey has given generously of his time, his expertise, and in his capacity as Assistant Chief of the Choctaw Nation, and made resources available to Eastern Oklahoma State College that exceed all expectations; and

WHEREAS, Mike Bailey has served with distinction as a regent, receiving the Association of Community College Trustees Leadership Award for the Western Region, and has been recommended to Governor Brad Henry for reappointment as a regent.

NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE 2ND SESSION OF THE 49TH OKLAHOMA LEGISLATURE, THE SENATE CONCURRING THEREIN:
