AMENDMENT NO. 1. Page 1, strike the stricken title, enacting
clause and entire bill and insert

"An Act relating to general appropriations for the expenses of various agencies of the executive, legislative and judicial departments of the state; making appropriations to the Oklahoma Arts Council, the State Board of Education, the Oklahoma Educational Television Authority, the Oklahoma State Regents for Higher Education, the Oklahoma Department of Libraries, the Commissioners of the Land Office, the Physician Manpower Training Commission, the Board of Trustees of the Oklahoma School of Science and Mathematics, the Oklahoma Center for the Advancement of Science and Technology, the Oklahoma Commission for Teacher Preparation, the State Board of Career and Technology Education, the Office of the State Auditor and Inspector, the Office of the State Bond Advisor, the Department of Central Services, the Oklahoma Department of Emergency Management, the State Election Board, the Ethics Commission, the Office of State Finance, the Office of the Governor, the Oklahoma House of Representatives, the Legislative Service Bureau, the Office of the Lieutenant Governor, the Oklahoma Merit Protection Commission, the Military Department of the State of Oklahoma, the Office of Personnel Management, the Office of the Secretary of State, the Oklahoma State Senate, the Oklahoma Tax Commission, the Office of the State Treasurer, the Oklahoma Space Industry Development Authority, the Department of Transportation, the Oklahoma Commission on Children and Youth, the Office of Handicapped Concerns, the Oklahoma Human Rights Commission, the Department of Human Services, the State Department of Rehabilitation Services, the Oklahoma Indian Affairs Commission, the Office of Juvenile Affairs, the Department of Mental Health and Substance Abuse Services, the State Department of Health, the

University Hospitals Authority, the Oklahoma Health Care Authority, the J.D. McCarty Center for Children with Developmental Disabilities, the Oklahoma Department of Veterans Affairs, the Oklahoma Department of Agriculture, Food, and Forestry, the Oklahoma Capitol Complex and Centennial Commemoration Commission, the Oklahoma Department of Commerce, the Oklahoma Conservation Commission, the Department of Consumer Credit, the Corporation Commission, the Department of Environmental Quality, the Oklahoma Historical Society, the Oklahoma Horse Racing Commission, the Insurance Department, the J.M. Davis Memorial Commission, the Department of Labor, the Department of Mines, the Scenic Rivers Commission, the Oklahoma Tourism and Recreation Department, the Oklahoma Water Resources Board, the Will Rogers Memorial Commission, the Alcoholic Beverage Laws Enforcement Commission, the Department of Corrections, the Office of the State Fire Marshal, the Oklahoma State Bureau of Investigation, the Council on Law Enforcement Education and Training, the Board of Medicolegal Investigations, the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control, the Pardon and Parole Board, the Department of Public Safety, the Office of the Attorney General, the Court of Criminal Appeals, the Supreme Court, the Council on Judicial Complaints, the Workers' Compensation Court, and the Oklahoma Indigent Defense System; stating sums of the appropriations; stating purposes and restrictions; authorizing and requiring certain expenditures; requiring transfer of certain funds; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SUBCOMMITTEE ON EDUCATION

SECTION 1. There is hereby appropriated to the Oklahoma Arts Council from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Four Million Two Hundred Fifty-nine Thousand Six Hundred Fifty-two Dollars (\$4,259,652.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Arts Council by law.

SECTION 2. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of One Billion One Hundred Ninety-five Million Seven Hundred Eighty-five Thousand Eight Hundred Thirty-

seven Dollars (\$1,195,785,837.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 3. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Education Reform Revolving Fund created in Section 41.29b of Title 62 of the Oklahoma Statutes, the sum of Five Hundred Eighteen Million Four Hundred Thousand Eight Hundred Forty-eight Dollars (\$518,400,848.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 4. The State Board of Education is hereby authorized to expend during the fiscal year ending June 30, 2007, from the Common Education Technology Revolving Fund of the State Treasury, the sum of Forty-five Million Seven Thousand Dollars (\$45,007,000.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 5. There is hereby appropriated to the State Board of Education, from any monies not otherwise appropriated from the Mineral Leasing Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Four Million Five Hundred Sixty Thousand Dollars (\$4,560,000.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 6. There is hereby appropriated to the State Board of Education, from any monies not otherwise appropriated from the Mineral Leasing Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of Two Million Eight Hundred Forty-three Thousand Seven Hundred Thirty-three Dollars (\$2,843,733.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 7. The State Board of Education is hereby appropriated during the fiscal year ending June 30, 2007, from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Fifty-two Million Nine Hundred

Eighty Thousand Seventy-five Dollars (\$52,980,075.00) or so much thereof as may be necessary for Certified Employee Salary Increases for the fiscal year ending June 30, 2007, in the support of public school activities.

SECTION 8. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Four Hundred Eighty-one Million Eight Hundred Eighty-four Thousand Five Hundred Forty-five Dollars (\$481,884,545.00) or so much thereof as may be necessary for the support of public school activities.

SECTION 9. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury the sum of Thirty-three Million Dollars (\$33,000,000.00) or so much thereof as may be necessary for the purchase of textbooks.

SECTION 10. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Twenty-two Million Seven Hundred Twenty-nine Thousand Two Hundred Twenty Dollars (\$22,729,220.00) or so much thereof as may be necessary for Administrative and Support Functions of the State Department of Education.

SECTION 11. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Five Million Eight Hundred Eighty-six Thousand Six Hundred Seventy-five Dollars (\$5,886,675.00) or so much thereof as may be necessary for transfer to the School Consolidation Assistance Fund.

SECTION 12. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the

Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Five Million Eight Hundred Eighty-six Thousand Six Hundred Seventy-five Dollars (\$5,886,675.00) or so much thereof as may be necessary for transfer to the Teachers' Retirement System Dedicated Revenue Revolving Fund.

SECTION 13. There is hereby appropriated to the Oklahoma Educational Television Authority from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Four Million Six Hundred Eighty-four Thousand One Hundred Twenty-five Dollars (\$4,684,125.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Educational Television Authority by law.

SECTION 14. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Seven Hundred Ninety-eight Million Eight Hundred Thousand Six Hundred Nineteen Dollars (\$798,800,619.00) or so much thereof as may be necessary for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education. Of those funds appropriated, the sum of Two Million Three Hundred Forty-four Thousand Six Hundred Fifty Dollars (\$2,344,650.00) shall be transferred to the Oklahoma Tuition Equalization Grant Trust Fund to implement the provisions of the Oklahoma Tuition Equalization Grant Act.

SECTION 15. The Oklahoma State Regents for Higher Education are hereby authorized to expend during the fiscal year ending June 30, 2007, the sum of Forty-five Million Seven Thousand Dollars

(\$45,007,000.00) from the Higher Education Capital Revolving Fund of the State Treasury for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 16. The Oklahoma State Regents for Higher Education are hereby authorized to expend during the fiscal year ending June 30, 2007, the sum of Forty-five Million Seven Thousand Dollars (\$45,007,000.00) from the Oklahoma Student Aid Revolving Fund of the State Treasury for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 17. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Nineteen Million Nine Hundred Eighty Thousand Seventy-five Dollars (\$19,980,075.00) pursuant to paragraph 2 of subsection C of Section 713 of Title 3A of the Oklahoma Statutes for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 18. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the

sum of Nineteen Million Five Hundred Thousand Dollars (\$19,500,000.00) or so much thereof as may be necessary for expenditures in the Oklahoma Higher Learning Access Program.

SECTION 19. The Oklahoma State Regents for Higher Education are hereby authorized to expend during the fiscal year ending June 30, 2007, the sum of Four Million Nine Hundred Twenty-seven Thousand Eight Hundred Dollars (\$4,927,800.00) from the Oklahoma Higher Learning Access Trust Fund of the State Treasury or so much thereof as may be necessary for expenditures in the Oklahoma Higher Learning Access Program.

SECTION 20. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Three Million Nine Hundred Thousand Dollars (\$3,900,000.00) or so much thereof as may be necessary for expenditures for concurrent enrollment pursuant to Section 628.13 of Title 70 of the Oklahoma Statutes.

SECTION 21. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Thirty-three Million Dollars (\$33,000,000.00) pursuant to paragraph 2 of subsection C of Section 713 of Title 3A of the Oklahoma Statutes for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education or for any other purpose authorized by paragraph 2 of subsection C of Section 713 of Title 3A of the Oklahoma Statutes.

SECTION 22. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for

the fiscal year ending June 30, 2007, the sum of Five Million Five Hundred Sixty-one Thousand Two Hundred Sixty-six Dollars (\$5,561,266.00) or so much thereof as may be necessary for the general operating budget of the Administrative Offices of the Oklahoma State Regents for Higher Education.

SECTION 23. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Seven Hundred Fifty Thousand One Hundred Twenty Dollars (\$750,120.00) or so much thereof as may be necessary for the Office of Accountability to perform the duties imposed upon the Office of Accountability by law.

SECTION 24. There is hereby appropriated to the Oklahoma Department of Libraries from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Six Million Seven Hundred Twenty-five Thousand Six Hundred Six Dollars (\$6,725,606.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Department of Libraries by law.

SECTION 25. There is hereby appropriated to the Commissioners of the Land Office from any monies not otherwise appropriated from the Commissioners of the Land Office Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Four Million Seven Hundred Ninety-two Thousand One Hundred Eighty-nine Dollars (\$4,792,189.00) or so much thereof as may be necessary to perform the duties imposed upon the Commissioners of the Land Office by law.

SECTION 26. There is hereby appropriated to the Physician Manpower Training Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Five Million Three Hundred Sixty Seven Thousand Four Hundred Ninety-six Dollars (\$5,367,496.00) or so much thereof as may be necessary to perform

the duties imposed upon the Physician Manpower Training Commission by law.

SECTION 27. There is hereby appropriated to the Board of Trustees of the Oklahoma School of Science and Mathematics from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Seven Million One Hundred Ten Thousand Five Hundred Ten Dollars (\$7,110,510.00) or so much thereof as may be necessary to perform the duties imposed upon the Board of Trustees of the Oklahoma School of Science and Mathematics by law.

SECTION 28. There is hereby appropriated to the Oklahoma Center for the Advancement of Science and Technology from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Twelve Million Four Hundred Twenty-eight Thousand Seven Hundred Twenty-five Dollars (\$12,428,725.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Center for the Advancement of Science and Technology by law.

SECTION 29. There is hereby appropriated to the Oklahoma Commission for Teacher Preparation from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Two Million Forty-one Thousand Four Hundred Twenty-eight Dollars (\$2,041,428.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Commission for Teacher Preparation by law.

SECTION 30. There is hereby appropriated to the State Board of Career and Technology Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of One Hundred Forty-one Million Seven Hundred Twenty Thousand Four Hundred Forty-one Dollars (\$141,720,441.00) or so much thereof as may be necessary to

perform the duties imposed upon the State Board of Career and Technology Education by law.

SUBCOMMITTEE ON GENERAL GOVERNMENT AND TRANSPORTATION

SECTION 31. There is hereby appropriated to the Office of the State Auditor and Inspector from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Five Million Seven Hundred Twenty-three Thousand Nine Hundred Seventy-five Dollars (\$5,723,975.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the State Auditor and Inspector by law.

SECTION 32. There is hereby appropriated to the Office of the State Auditor and Inspector from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Four Hundred Fifty Six Thousand One Hundred Four Dollars (\$456,104.00) or so much thereof as may be necessary to perform the duties imposed upon the Commission on County Government Personnel Education and Training. The appropriation made in this section shall be expended exclusively for the purpose so stated and shall not be transferable.

SECTION 33. There is hereby appropriated to the Office of the State Auditor and Inspector from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Fifteen Million Five Hundred Thousand Dollars (\$15,500,000.00) or so much thereof as may be necessary to provide uniform computer systems development, including computer software for county government, in accordance with the State Auditor and Inspector's duties to prescribe accounting procedures and to provide technical assistance to county government. The appropriation made in this section shall be expended exclusively for the purpose so stated and shall not be transferable.

SECTION 34. There is hereby appropriated to the Office of the State Bond Advisor from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of One Hundred Eighty-three Thousand Eight Hundred Fifteen Dollars (\$183,815.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the State Bond Advisor by law.

SECTION 35. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Ten Million Five Hundred Seven Thousand Four Hundred Forty-five Dollars (\$10,507,445.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Central Services by law.

SECTION 36. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of One Hundred Fifty-one Thousand Five Hundred Eighteen Dollars (\$151,518.00) to be transferred to the Building and Facility Revolving Fund created in Section 63.1 of Title 74 of the Oklahoma Statutes for the purpose of maintaining state buildings operated by the Department of Central Services.

SECTION 37. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the Public Building Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of Three Hundred Fifty-seven Thousand Four Hundred Seven Dollars (\$357,407.00) or so much thereof as may be necessary to perform maintenance on the Veterans Memorial within the capitol complex.

SECTION 38. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the Public Building Fund of the State Treasury for the fiscal year

ending June 30, 2007, the sum of One Million Three Hundred Sixty-four Thousand Seventy-nine Dollars (\$1,364,079.00) or so much thereof as may be necessary for asbestos abatement programs and for the expenses of filing claims for reimbursement from the Manville Property Damage Settlement Trust. The monies designated in this section shall be expended exclusively for the purposes so stated and shall not be transferable.

SECTION 39. There is hereby appropriated to the Oklahoma Department of Emergency Management from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of One Million Four Hundred Forty-seven Thousand Six Hundred Thirty-six Dollars (\$1,447,636.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Department of Emergency Management by law.

SECTION 40. There is hereby appropriated to the State Election Board from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Five Million Three Hundred One Thousand Three Hundred Sixty-one Dollars (\$5,301,361.00) or so much thereof as may be necessary to perform the duties imposed upon the State Election Board by law.

SECTION 41. There is hereby appropriated to the State Election Board from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of One Million Six Hundred Thirty Thousand Dollars (\$1,630,000.00) or so much thereof as may be required to pay the necessary expenses of holding elections.

SECTION 42. There is hereby appropriated to the Ethics Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Five Hundred Thousand One Hundred

Eighteen Dollars (\$500,118.00) or so much thereof as may be necessary to perform the duties imposed upon the Ethics Commission by law.

SECTION 43. There is hereby appropriated to the Office of State Finance from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Eleven Million Nine Hundred Eighteen Thousand Nine Hundred Seventy-five Dollars (\$11,918,975.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of State Finance by law.

SECTION 44. There is hereby appropriated to the Office of State Finance from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Eleven Million Dollars (\$11,000,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of State Finance by law.

SECTION 45. There is hereby appropriated to the Office of the Governor from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Two Million Six Hundred Twenty Thousand Three Hundred Forty-six Dollars (\$2,620,346.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the Governor by law.

SECTION 46. There is hereby appropriated to the Oklahoma House of Representatives from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Eighteen Million Nine Hundred Ninety-four Thousand Eight Dollars (\$18,994,008.00) or so much thereof as may be necessary to pay the salaries, per diem and expenses of the members of the Oklahoma House of Representatives, the salaries of the employees of the Oklahoma House of Representatives, and other necessary expenses. Claims and payrolls

filed against the appropriation made to the Oklahoma House of Representatives for the fiscal year ending June 30, 2007, shall be approved by the Speaker of the House of Representatives.

SECTION 47. There is hereby appropriated to the Legislative Service Bureau from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Two Million Two Hundred Ninety-four Thousand Two Hundred Eighty Dollars (\$2,294,280.00) or so much thereof as may be necessary to perform the duties imposed upon the Legislative Service Bureau by law.

SECTION 48. There is hereby appropriated to the Legislative Service Bureau from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Six Hundred Fifty-six Thousand One Hundred Fifty-nine Dollars (\$656,159.00) or so much thereof as may be necessary to fund the operations of the Oklahoma Criminal Justice Resource Center.

SECTION 49. There is hereby appropriated to the Office of the Lieutenant Governor from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Six Hundred One Thousand Seventeen Dollars (\$601,017.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the Lieutenant Governor by law.

SECTION 50. There is hereby appropriated to the Office of the Attorney General from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Twelve Million Four Hundred Twenty-seven Thousand Nine Hundred Fifty-five Dollars (\$12,427,955.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the Attorney General by law.

SECTION 109. For the fiscal year ending June 30, 2007, the Office of the Attorney General is authorized to transfer an amount not to exceed Three Hundred Twenty Thousand Four Hundred Thirty Dollars (\$320,430.00) from the Office of the Attorney General's Evidence Fund (700 Fund), created by Section 19 of Title 74 of the Oklahoma Statutes to the Office of the Attorney General's Revolving Fund (200 Fund) created by Section 20 of Title 74 of the Oklahoma Statutes.

SECTION 110. There is hereby appropriated to the Office of the Attorney General from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Thirty-five Million Six Hundred Seventy-seven Thousand Ninety-seven Dollars (\$35,677,097.00) or so much thereof as may be necessary to perform the duties imposed upon the district attorneys and the District Attorneys Council by law. Of the funds appropriated herein, the Office of the Attorney General shall transfer up to the sum of Four Hundred Ninety-one Thousand Fourteen Dollars (\$491,014.00) or so much thereof as may be required by the district attorneys and District Attorneys Council to the District Attorneys Evidence Fund for necessary expenses relative to any case within the official responsibility of the offices of the district attorneys as provided by Section 215.40 of Title 19 of the Oklahoma Statutes.

SECTION 111. For the fiscal year ending June 30, 2007, the District Attorneys Council is authorized to transfer an amount not to exceed Five Hundred Thousand Dollars (\$500,000.00), on an as-needed basis, from the Crime Victims Compensation Revolving Fund created by Section 142.17 of Title 21 of the Oklahoma Statutes to the Sexual Assault Examination Fund created by Section 142.20 of Title 21 of the Oklahoma Statutes.

SECTION 112. For the fiscal year ending June 30, 2007, up to One Million Three Hundred One Thousand Three Hundred Seventy-five

Dollars (\$1,301,375.00) is authorized to be transferred from the Crime Victims Compensation Revolving Fund, created by Section 142.17 of Title 21 of the Oklahoma Statutes, to the District Attorneys Council for duties to support Victim-Witness Services.

SECTION 113. There is hereby appropriated to the Court of Criminal Appeals from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Three Million One Hundred Seventy Thousand Three Hundred Ninety-five Dollars (\$3,170,395.00) or so much thereof as may be necessary to perform the duties imposed upon the Court of Criminal Appeals by law.

SECTION 114. There is hereby appropriated to the Supreme Court from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Fourteen Million Seven Hundred Ninety-four Thousand Eight Dollars (\$14,794,008.00) or so much thereof as may be necessary to perform the duties imposed upon the Supreme Court or Court of Civil Appeals by law.

SECTION 115. There is hereby appropriated to the Supreme Court from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Nine Hundred Fourteen Thousand Eight Hundred Forty-five Dollars (\$914,845.00) to transfer to the Legal Services Revolving Fund created pursuant to subsection G of Section 921.1 of Title 12 of the Oklahoma Statutes.

SECTION 116. There is hereby appropriated to the Supreme Court for deposit in the Supreme Court Revolving Fund from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Nine Hundred Thousand Dollars (\$900,000.00) for expenditures authorized by Section 1310.1 of Title 20 of the Oklahoma Statutes.

SECTION 117. The Supreme Court is hereby authorized to expend during the fiscal year ending June 30, 2007, from the State Judicial Revolving Fund of the State Treasury, the sum of Thirty-eight Million One Hundred Eighty-three Thousand Three Hundred Thirty-nine Dollars (\$38,183,339.00) or so much thereof as may be necessary for the financial support of the District Courts.

SECTION 118. There is hereby appropriated to the Supreme Court from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Thirteen Million Seven Hundred Fifty-five Thousand Four Hundred Eighty-two Dollars (\$13,755,482.00) or so much thereof as may be necessary to perform the duties imposed upon the District Courts by law.

SECTION 119. There is hereby appropriated to the Council on Judicial Complaints from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Two Hundred Eighty-one Thousand Two Hundred Seventy-eight Dollars (\$281,278.00) or so much thereof as may be necessary to perform the duties imposed upon the Council on Judicial Complaints by law.

SECTION 120. There is hereby appropriated to the Workers' Compensation Court from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Four Million Nine Hundred Twenty-one Thousand Six Hundred Four Dollars (\$4,921,604.00) or so much thereof as may be necessary to perform the duties imposed upon the Workers' Compensation Court by law.

SECTION 121. There is hereby appropriated to the Oklahoma Indigent Defense System from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Fifteen Million Eight Hundred Twenty-eight Thousand Five Hundred Five Dollars (\$15,828,505.00) or

so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Indigent Defense System by law.

SECTION 122. This act shall become effective July 1, 2006."
