An Act relating to general appropriations for the expenses of various agencies of the executive, legislative and judicial departments of the state; making appropriations to the Oklahoma State Regents for Higher Education, the State Board of Career and Technology Education, the Oklahoma Arts Council, the Oklahoma Educational Television Authority, the Commissioners of the Land Office, the Oklahoma Department of Libraries, the Physician Manpower Training Commission, the Oklahoma Board of Private Vocational Schools, the Board of Trustees of the Oklahoma School of Science and Mathematics, the Oklahoma Center for the Advancement of Science and Technology, the Oklahoma Commission for Teacher Preparation, the Office of the State Auditor and Inspector, the Office of the State Bond Advisor, the Department of Central Services, the Oklahoma Department of Emergency Management, the State Election Board, the Ethics Commission, the Office of State Finance, the Office of the Governor, the Oklahoma House of Representatives, the Legislative Service Bureau, the Office of the Lieutenant Governor, the Oklahoma Merit Protection Commission, the Military Department of the State of Oklahoma, the Office of Personnel Management, the Office of the Secretary of State, the Oklahoma State Senate, the Oklahoma Space Industry Development Authority, the Oklahoma Tax Commission, the Department of Transportation, the Office of the State Treasurer, the Oklahoma Health Care Authority, the State Department of Health, the J.D. McCarty Center for Children with Developmental Disabilities, the Department of Mental Health and Substance Abuse Services, the University Hospitals Authority, the Oklahoma Department of Veterans Affairs, the Oklahoma Commission on Children and Youth, the Office of Handicapped Concerns, the Oklahoma Human Rights Commission, the Department of Human Services, the Oklahoma Indian Affairs Commission, the Office of Juvenile Affairs, the State Department of Rehabilitation Services, the Oklahoma Department of Agriculture, Food, and Forestry, the Oklahoma Capitol Complex and Centennial Commemoration Commission, the Department of Commerce, the Oklahoma Conservation Commission, the Department of Consumer Credit, the Corporation Commission, the Department of Environmental Quality, the Oklahoma Historical Society, the Oklahoma Horse Racing Commission, the State Insurance Department, the J.M. Davis Memorial

Commission, the Department of Labor, the Department of Mines, the Oklahoma Scenic Rivers Commission, the Oklahoma Tourism and Recreation Department, the Oklahoma Water Resources Board, the Will Rogers Memorial Commission, the Alcoholic Beverage Laws Enforcement Commission, the Department of Corrections, the Pardon and Parole Board, the Oklahoma State Bureau of Investigation, the State Fire Marshal, the Board of Medicolegal Investigations, the Council on Law Enforcement Education and Training, the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control, the Department of Public Safety, the Oklahoma Indigent Defense System, the Office of the Attorney General, the Court of Criminal Appeals, the Supreme Court, the Workers' Compensation Court, the Council on Judicial Complaints, the Rural Economic Action Plan Fund and The State Emergency Fund; stating sums of the appropriations; stating purposes and restrictions; authorizing and requiring certain expenditures; authorizing and requiring certain transfers; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SUBCOMMITTEE ON EDUCATION

SECTION 1. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Six Hundred Eighty-seven Million Five Hundred Twelve Thousand Ten Dollars (\$687,512,010.00) or so much thereof as may be necessary for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 2. The Oklahoma State Regents for Higher Education are hereby authorized to expend during the fiscal year ending June 30, 2006, the sum of Fifty-seven Million Eight Hundred Twenty-two Thousand One Hundred Seventy-eight Dollars (\$57,822,178.00) from the Higher Education Capital Revolving Fund of the State Treasury for

allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 3. The Oklahoma State Regents for Higher Education are hereby authorized to expend during the fiscal year ending June 30, 2006, the sum of One Million Nine Hundred Seventy-seven Thousand Eight Hundred Sixty-one Dollars (\$1,977,861.00) from the Higher Education Capital Revolving Fund for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 4. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund, the sum of Twenty-eight Million Twenty-two Thousand One Hundred Thirty-nine Dollars (\$28,022,139.00) pursuant to paragraph 2 of subsection C of Section 713 of Title 3A of the Oklahoma Statutes for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 5. The Oklahoma State Regents for Higher Education are hereby authorized to expend during the fiscal year ending June 30, 2006, the sum of Fifty-five Million Eight Hundred Thousand Thirty-nine Dollars (\$55,800,039.00) from the Oklahoma Tuition Scholarship Revolving Fund of the State Treasury for allocation by the Oklahoma

State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 6. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Five Million Four Hundred Four Thousand Seven Hundred Ninety-one Dollars (\$5,404,791.00) or so much thereof as may be necessary for the general operating budget of the Administrative Offices of the Oklahoma State Regents for Higher Education.

SECTION 7. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of Eight Million Dollars (\$8,000,000.00) or so much thereof as may be necessary for expenditures in the Oklahoma Higher Learning Access Program.

SECTION 8. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the "Jobs and Growth Tax Relief Fund", otherwise designated as Fund 720 within the Office of State Finance, the sum of Seventeen Million Dollars (\$17,000,000.00) or so much thereof as may be necessary for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 9. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Eight Hundred Fifty

Thousand One Hundred Twenty Dollars (\$850,120.00) or so much thereof as may be necessary for the Office of Accountability to perform the duties imposed upon the Office of Accountability by law.

SECTION 10. There is hereby appropriated to the State Board of Career and Technology Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of One Hundred Fifteen Million Two Hundred Seventy-seven Thousand One Hundred Ninety-six Dollars (\$115,277,196.00) or so much thereof as may be necessary to perform the duties imposed upon the State Board of Career and Technology Education by law.

SECTION 11. There is hereby appropriated to the State Board of Career and Technology Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Six Million One Hundred Fifty-seven Thousand Two Hundred Fifteen Dollars (\$6,157,215.00) or so much thereof as may be necessary for the Certified Employee Health Benefit Allowance.

SECTION 12. There is hereby appropriated to the State Board of Career and Technology Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Five Million Five Hundred Fifty-two Thousand Four Hundred Thirty-four Dollars (\$5,552,434.00) or so much thereof as may be necessary for the Support Personnel Health Benefit Allowance.

SECTION 13. There is hereby appropriated to the Oklahoma Arts Council from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Four Million Ninety-three Thousand Three Hundred Thirty-eight Dollars (\$4,093,338.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Arts Council by law.

SECTION 14. There is hereby appropriated to the Oklahoma Educational Television Authority from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Four Million Two Hundred Ninety-eight Thousand Fifty-nine Dollars (\$4,298,059.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Educational Television Authority by law.

SECTION 15. There is hereby appropriated to the Commissioners of the Land Office from any monies not otherwise appropriated from the Commissioners of the Land Office Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Four Million Eight Hundred Forty-three Thousand Four Hundred Ninety-seven Dollars (\$4,843,497.00) or so much thereof as may be necessary to perform the duties imposed upon the Commissioners of the Land Office by law.

SECTION 16. There is hereby appropriated to the Oklahoma Department of Libraries from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Six Million Seven Hundred Eighty-one Thousand Three Hundred Fifty-five Dollars (\$6,781,355.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Department of Libraries by law.

SECTION 17. There is hereby appropriated to the Physician Manpower Training Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Five Million Thirty-four Thousand Four Hundred Ninety Dollars (\$5,034,490.00) or so much thereof as may be necessary to perform the duties imposed upon the Physician Manpower Training Commission by law.

SECTION 18. There is hereby appropriated to the Oklahoma Board of Private Vocational Schools from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of One Hundred Sixty-

one Thousand Eight Hundred Seventy-nine Dollars (\$161,879.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Board of Private Vocational Schools by law.

SECTION 19. There is hereby appropriated to the Board of Trustees of the Oklahoma School of Science and Mathematics from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Seven Million Two Hundred Sixty-six Thousand Five Hundred Thirteen Dollars (\$7,266,513.00) or so much thereof as may be necessary to perform the duties imposed upon the Board of Trustees of the Oklahoma School of Science and Mathematics by law.

SECTION 20. There is hereby appropriated to the Oklahoma Center for the Advancement of Science and Technology from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Sixteen Million Seven Hundred Thousand Nine Hundred Forty-two Dollars (\$16,700,942.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Center for the Advancement of Science and Technology by law.

SECTION 21. There is hereby appropriated to the Oklahoma Commission for Teacher Preparation from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Two Million Twenty-two Thousand Eight Hundred Seventy-five Dollars (\$2,022,875.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Commission for Teacher Preparation by law.

SUBCOMMITTEE ON GENERAL GOVERNMENT AND TRANSPORTATION

SECTION 22. There is hereby appropriated to the Office of the State Auditor and Inspector from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Five Million Three Hundred Ten Thousand Seven Hundred Sixty-three Dollars

(\$5,310,763.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the State Auditor and Inspector by law.

SECTION 23. There is hereby appropriated to the Office of the State Auditor and Inspector from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Four Hundred Seventy-eight Thousand Twenty-three Dollars (\$478,023.00) or so much thereof as may be necessary to perform the duties imposed upon the Commission on County Government Personnel Education and Training. The appropriation made in this section shall be expended exclusively for the purpose so stated and shall not be transferable.

SECTION 24. There is hereby appropriated to the Office of the State Bond Advisor from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of One Hundred Eighty-one Thousand Two Hundred Twelve Dollars (\$181,212.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the State Bond Advisor by law.

SECTION 25. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Nine Million Four Hundred Eleven Thousand Five Hundred Thirty-nine Dollars (\$9,411,539.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Central Services by law.

SECTION 26. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of One Million One Hundred Fifteen Thousand Four Hundred Forty-nine Dollars (\$1,115,449.00) to be transferred to the Building and Facility Revolving Fund created in Section 63.1 of

Title 74 of the Oklahoma Statutes for the purpose of maintaining state buildings operated by the Department of Central Services.

SECTION 27. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the Public Building Fund of the State Treasury for the fiscal year ending June 30, 2004, the sum of Five Hundred Seventy Thousand Four Hundred Ninety-four Dollars (\$570,494.00) to be transferred to the Building and Facility Revolving Fund created in Section 63.1 of Title 74 of the Oklahoma Statutes for the purpose of maintaining state buildings operated by the Department of Central Services.

SECTION 28. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the Public Building Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of One Million Three Hundred Ten Thousand One Hundred Fifty-one Dollars (\$1,310,151.00) to be transferred to the Building and Facility Revolving Fund created in Section 63.1 of Title 74 of the Oklahoma Statutes for the purpose of maintaining state buildings operated by the Department of Central Services.

SECTION 29. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Three Thousand Eight Hundred Eighty-four Dollars (\$3,884.00) or so much thereof as may be necessary to perform maintenance on the Veterans Memorial within the Capitol complex.

SECTION 30. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of One Hundred Fifty-one Thousand Five Hundred Eighteen Dollars (\$151,518.00) or so much thereof as may be necessary to maintain the Hissom Memorial Center.

SECTION 31. There is hereby appropriated to the Oklahoma Department of Emergency Management from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Seven Hundred One Thousand Five Hundred Sixty-one Dollars (\$701,561.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Department of Emergency Management by law.

SECTION 32. There is hereby appropriated to the State Election Board from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Six Million Four Hundred Forty-one Thousand Eight Hundred Thirty-nine Dollars (\$6,441,839.00) or so much thereof as may be necessary to perform the duties imposed upon the State Election Board by law.

SECTION 33. There is hereby appropriated to the Ethics Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Four Hundred Ninety-two Thousand Two Hundred Seventy-seven Dollars (\$492,277.00) or so much thereof as may be necessary to perform the duties imposed upon the Ethics Commission by law.

SECTION 34. There is hereby appropriated to the Office of State Finance from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Eighteen Million Seven Hundred Fifty-six Thousand Five Hundred Fifteen Dollars (\$18,756,515.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of State Finance by law.

SECTION 35. There is hereby appropriated to the Office of State Finance from any monies not otherwise appropriated from the Special Cash Fund, the sum of Six Million Dollars (\$6,000,000.00) or so much

thereof as may be necessary to perform the duties imposed upon the Office of State Finance by law.

SECTION 36. There is hereby appropriated to the Office of the Governor from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Two Million Five Hundred Seventy-eight Thousand Seven Hundred Ten Dollars (\$2,578,710.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the Governor by law.

SECTION 37. There is hereby appropriated to the Oklahoma House of Representatives from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the following amount, or so much thereof as may be necessary to pay monthly salaries, per diem, and expenses of the members of the House of Representatives and the salaries of its employees, and such contingent expenses as may be ordered paid therefrom, including the preparation and printing of the journals and calendars of the House of Representatives, and including the preparation and printing of the permanent journals thereof, in accordance with the following amount herein set forth:

For expenses of personnel services (including retirement and insurance costs), including those of members, and employees of the House of Representatives, and expenses of maintenance and operation, including travel expenses, supplies, materials, printing, equipment, and printing of permanent journals; and for the renovation and modification of the House of Representatives area; and other necessary expenses	\$18,629,154.00

Claims and payrolls filed against the appropriation made to the House of Representatives for the fiscal year ending June 30, 2006, shall be approved by the Speaker of the House of Representatives.

SECTION 38. There is hereby appropriated to the Legislative Service Bureau from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of One Million Seven Hundred Twenty-four Thousand Seven Hundred Eighty-eight Dollars (\$1,724,788.00) or so much thereof as may be necessary to perform the duties imposed upon the Legislative Service Bureau by law.

SECTION 39. There is hereby appropriated to the Legislative Service Bureau from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Six Hundred Forty Thousand Nine Hundred Ninety-five Dollars (\$640,995.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Criminal Justice Resource Center by law.

SECTION 40. There is hereby appropriated to the Office of the Lieutenant Governor from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Five Hundred Thirty-six Thousand Four Hundred Thirty-six Dollars (\$536,436.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the Lieutenant Governor by law.

SECTION 41. There is hereby appropriated to the Oklahoma Merit Protection Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Five Hundred Twenty-three Thousand Six Hundred Eighty-four Dollars (\$523,684.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Merit Protection Commission by law.

SECTION 42. There is hereby appropriated to the Military Department of the State of Oklahoma from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Ten Million Four Hundred Eleven Thousand Four Hundred Thirty-two Dollars (\$10,411,432.00) or so much thereof as may be necessary to perform the duties imposed upon the Military Department of the State of Oklahoma by law.

SECTION 43. There is hereby appropriated to the Office of Personnel Management from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Four Million Six Hundred Thirty-three Thousand Two Hundred Forty-nine Dollars (\$4,633,249.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of Personnel Management by law.

SECTION 44. There is hereby appropriated to the Office of the Secretary of State from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Five Hundred Ten Thousand One Hundred eighty-four Dollars (\$510,184.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the Secretary of State by law.

SECTION 45. There is hereby appropriated to the Oklahoma State Senate from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the following amount, or so much thereof as may be necessary to pay monthly salaries, per diem, and expenses of the members of the Senate and the salaries of its employees, and such contingent expenses as may be ordered paid therefrom, including the preparation and printing of the journals and calendars of the Senate, and including the preparation and printing of the permanent

journals thereof, in accordance with the following amount herein set forth:

For expenses of personnel services
(including retirement and insurance costs), including those of members, and employees of the Senate, and expenses of maintenance and operation, including travel expenses, supplies, materials, printing, equipment, and printing of permanent journals and for the renovation and modification of the Senate area \$13,146,893.00

SECTION 46. There is hereby appropriated to the Oklahoma Space Industry Development Authority from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Five Hundred Twenty-three Thousand Two Hundred Sixty-four Dollars (\$523,264.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Space Industry Development Authority by law.

SECTION 47. There is hereby appropriated to the Oklahoma Tax Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Forty-five Million Nine Hundred Seventy-six Thousand Two Hundred Ninety-one Dollars (\$45,976,291.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Tax Commission by law.

SECTION 48. From the appropriation made in Section 47 of this act, the Oklahoma Tax Commission shall pay an amount not to exceed One Hundred Fifty-eight Thousand Six Hundred Fifty Dollars (\$158,650.00) for the personal services and other operating expenses of the Office of the State Auditor and Inspector in performing

audits of the Oklahoma Tax Commission and motor license agents as required by law.

SECTION 49. There is hereby appropriated to the Office of Attorney General from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of One Hundred Fifty Thousand Dollars (\$150,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of Attorney General by law.

SECTION 110. There is hereby appropriated to the Court of Criminal Appeals from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Two Million Eight Hundred Twenty-eight Thousand One Hundred Sixty Dollars (\$2,828,160.00) or so much thereof as may be necessary to perform the duties imposed upon the Court of Criminal Appeals by law.

SECTION 111. There is hereby appropriated to the Supreme Court from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Three Million Eight Hundred Seventy-five Thousand One Hundred Twenty-one Dollars (\$3,875,121.00) or so much thereof as may be necessary to perform the duties imposed upon the district courts by law.

SECTION 112. The Supreme Court is hereby authorized to expend during the fiscal year ending June 30, 2006, from the State Judicial Revolving Fund of the State Treasury, the sum of Thirty-eight Million Nine Hundred Fifty-nine Thousand Eighteen Dollars (\$38,959,018.00) or so much thereof as may be necessary to perform the duties imposed upon the district courts by law.

SECTION 113. There is hereby appropriated to the Supreme Court from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of Three Million Dollars (\$3,000,000.00) or so much thereof as may be necessary to perform the duties imposed upon the district courts by law.

SECTION 114. There is hereby appropriated to the Office of the Attorney General from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Thirty Million Eight Hundred Forty Thousand Eight Hundred Fifty-one Dollars (\$30,840,851.00) or so much thereof as may be necessary to perform the duties imposed upon the District Attorneys Council by law. Of the funds appropriated herein, the Office of the Attorney General shall transfer up to the sum of Five Hundred Fifteen Thousand Three Hundred Seventeen Dollars (\$515,317.00) or so much thereof as may be required by the district attorneys and District Attorneys Council to the District Attorneys Evidence Fund for necessary expenses relative to any case within the official responsibility of the offices of the district attorneys as provided by Section 215.40 of Title 19 of the Oklahoma Statutes.

SECTION 115. For the fiscal year ending June 30, 2006, the District Attorneys Council is authorized to transfer an amount not to exceed Three Hundred Thousand Dollars (\$300,000.00), on an as-needed basis, from the Crime Victims Compensation Revolving Fund created by Section 142.17 of Title 21 of the Oklahoma Statutes to the Sexual Assault Examination Fund created by Section 142.20 of Title 21 of the Oklahoma Statutes.

SECTION 116. For the fiscal year ending June 30, 2006, up to Four Hundred Seventy-five Thousand Dollars (\$475,000.00) is authorized to be transferred from the Crime Victims Compensation Revolving Fund, created by Section 142.17 of Title 21 of the Oklahoma Statutes to the District Attorneys Council for eight employees, including related duties to support the Crime Victims Compensation Board.

SECTION 117. For the fiscal year ending June 30, 2006, up to One Million Three Hundred Two Thousand Dollars (\$1,302,000.00) is authorized to be transferred from the Crime Victims Compensation Revolving Fund, created by Section 142.17 of Title 21 of the

Oklahoma Statutes to the District Attorneys Council for duties to support Victim-Witness Services.

SECTION 118. There is hereby appropriated to the Workers' Compensation Court from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Three Million Nine Hundred Eighty-one Thousand Seven Hundred Seven Dollars (\$3,981,707.00) or so much thereof as may be necessary to perform the duties imposed upon the Workers' Compensation Court by law.

SECTION 119. There is hereby appropriated to the Supreme Court from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Four Million One Hundred Eighty-four Thousand Seven Hundred Forty-five Dollars (\$4,184,745.00) or so much thereof as may be necessary to perform the duties imposed upon the Supreme Court or Court of Civil Appeals by law.

SECTION 120. The Supreme Court is hereby authorized to expend during the fiscal year ending June 30, 2006, from the State Judicial Revolving Fund of the State Treasury, the sum of Seven Million Three Hundred Seventy-eight Thousand Nine Hundred Thirteen Dollars (\$7,378,913.00) or so much thereof as may be necessary to perform the duties imposed upon the Supreme Court or Court of Civil Appeals by law.

SECTION 121. There is hereby appropriated to the Supreme Court from any monies not otherwise appropriated from the Special Cash Fund, the sum of Five Hundred Thousand Dollars (\$500,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Supreme Court or Court of Civil Appeals by law.

SECTION 122. There is hereby appropriated to the Supreme Court from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Seven Hundred Sixty-four Thousand Eight Hundred Forty-

five Dollars (\$764,845.00) to transfer to the Legal Services Revolving Fund created pursuant to subsection G of Section 921.1 of Title 12 of the Oklahoma Statutes.

SECTION 123. There is hereby appropriated to the Supreme Court for deposit in the Supreme Court Revolving Fund from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Nine Hundred Thousand Dollars (\$900,000.00) for expenditures authorized by Section 1310.1 of Title 20 of the Oklahoma Statutes.

SECTION 124. There is hereby appropriated to the Council on Judicial Complaints from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Two Hundred Seventy-four Thousand Four Hundred Forty-six Dollars (\$274,446.00) or so much thereof as may be necessary to perform the duties imposed upon the Council on Judicial Complaints by law.

SECTION 125. There is hereby appropriated to the Rural Economic Action Plan Fund of the State Treasury from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Fifteen Million Five Hundred Thousand Dollars (\$15,500,000.00) or so much thereof as may be necessary to implement the provisions of Sections 2006 through 2013 of Title 62 of the Oklahoma Statutes.

SECTION 126. There is hereby appropriated to The State Emergency Fund created pursuant to Section 139.42 of Title 62 of the Oklahoma Statutes from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury the sum of Four Million Dollars (\$4,000,000.00) or so much thereof as may be necessary for matching federal disaster funds and for other disaster-related assistance.

SECTION 127. This act shall become effective July 1, 2005.
