An Act relating to the J.D. McCarty Center for Children with Developmental Disabilities; requiring budgeting in certain categories and amounts; providing for duties and compensation of employees; limiting salary of the Director; requiring compliance with budgetary limitations; exempting certain federal funds from expenditure limitations; providing exception; providing lapse dates; requiring and prohibiting certain budget and expenditure procedures; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. For the fiscal year ending June 30, 2007, the J.D. McCarty Center for Children with Developmental Disabilities shall budget all funds in the following categories and amounts:

SECTION 2. The duties and compensation of employees, not otherwise prescribed by law, necessary to perform the duties imposed upon the J.D. McCarty Center for Children with Developmental Disabilities by law shall be set by the Director. The salary of the Director shall not exceed Seventy-five Thousand Seven Hundred Five Dollars (\$75,705.00) per annum, payable monthly for the fiscal year ending June 30, 2007. The J.D. McCarty Center for Children with Developmental Disabilities, for the fiscal year ending June 30, 2007, shall be subject to the following budgetary limitations, except as may be authorized pursuant to the provisions of Section 3603 of Title 74 of the Oklahoma Statutes:

Receipt and expenditures of unanticipated federal funds awarded to the J.D. McCarty Center for Children with Developmental Disabilities after July 1, 2006, shall be exempt from expenditure

and budgetary limitations, provided that any such funds used for operations shall be included in the agency's budget work program.

SECTION 3. Appropriations made by Section 47 of Enrolled Senate Bill No. 80 of the 2nd Extraordinary Session of the 50th Oklahoma Legislature, not including appropriations made for capital outlay purposes, may be budgeted for the fiscal year ending June 30, 2007 (hereafter FY-07) or may be budgeted for the fiscal year ending June 30, 2008 (hereafter FY-08). Funds budgeted for FY-07 may be encumbered only through June 30, 2007, and must be expended by November 15, 2007. Any funds remaining after November 15, 2007, and not budgeted for FY-08, shall lapse to the credit of the proper fund for the then current fiscal year. Funds budgeted for FY-08 may be encumbered only through June 30, 2008. Any funds remaining after November 15, 2008, shall lapse to the credit of the proper fund for the then current fiscal year. These appropriations may not be budgeted in both fiscal years simultaneously. Funds budgeted in FY-07, and not required to pay obligations for that fiscal year, may be budgeted for FY-08, after the agency to which the funds have been appropriated has prepared and submitted a budget work program revision removing these funds from the FY-07 budget work program and after such revision has been approved by the Office of State Finance.

SECTION 4. This act shall become effective July 1, 2006.
