An Act relating to general appropriations for the expenses of various agencies of the executive, legislative and judicial departments of the state; making appropriations to the Office of the State Auditor and Inspector, Rural Economic Action Plan Fund, the Office of the State Bond Advisor, the Department of Central Services, the Oklahoma Department of Emergency Management, the State Election Board, the Ethics Commission, the Office of State Finance, the Office of the Governor, the Oklahoma House of Representatives, the Legislative Service Bureau, the Office of the Lieutenant Governor, the Oklahoma Merit Protection Commission, the Military Department of the State of Oklahoma, the Office of Personnel Management, the Office of the Secretary of State, the Oklahoma State Senate, the Oklahoma Tax Commission, the Office of the State Treasurer, the Oklahoma Space Industry Development Authority, the Department of Transportation, the Oklahoma Commission on Children and Youth, the Office of Handicapped Concerns, the Oklahoma Human Rights Commission, the Department of Human Services, the State Department of Rehabilitation Services, the Oklahoma Indian Affairs Commission, the Office of Juvenile Affairs, the Department of Mental Health and Substance Abuse Services, the State Department of Health, the University Hospitals Authority, the Oklahoma Health Care Authority, the J.D. McCarty Center for Children with Developmental Disabilities, the Oklahoma Department of Veterans Affairs, the Oklahoma Department of Agriculture, Food, and Forestry, the Oklahoma Capitol Complex and Centennial Commemoration Commission, the Oklahoma Department of Commerce, the Oklahoma Conservation Commission, the Department of Consumer Credit, the Corporation Commission, the Department of Environmental Quality, the Oklahoma Historical Society, the Oklahoma Horse Racing Commission, the Insurance Department, the J.M. Davis Memorial Commission, the Department of Labor, the Department of Mines, the Scenic Rivers Commission, the Oklahoma Tourism and Recreation

Department, the Oklahoma Water Resources Board, the Will Rogers Memorial Commission, the Alcoholic Beverage Laws Enforcement Commission, the Department of Corrections, the Office of the State Fire Marshal, the Oklahoma State Bureau of Investigation, the Council on Law Enforcement Education and Training, the Board of Medicolegal Investigations, the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control, the Pardon and Parole Board, the Department of Public Safety, the Office of the Attorney General, district attorneys and the District Attorneys Council, the Court of Criminal Appeals, the Supreme Court, the Council on Judicial Complaints, the Workers' Compensation Court, the Oklahoma Indigent Defense System, the Oklahoma Arts Council, the State Board of Education, the Oklahoma Educational Television Authority, the Oklahoma State Regents for Higher Education, the Oklahoma Department of Libraries, the Commissioners of the Land Office, the Physician Manpower Training Commission, the Board of Trustees of the Oklahoma School of Science and Mathematics, the Oklahoma Center for the Advancement of Science and Technology, the Oklahoma Commission for Teacher Preparation, the State Board of Career and Technology Education, the Oklahoma Board of Private Vocational Schools, the Oklahoma Tax Commission and the State Board of Education; stating sums of the appropriations; stating purposes and restrictions; authorizing and requiring certain expenditures; requiring transfer of certain funds; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SUBCOMMITTEE ON GENERAL GOVERNMENT AND TRANSPORTATION

SECTION 1. There is hereby appropriated to the Office of the State Auditor and Inspector from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Five Million Eight Hundred Nineteen Thousand Six Hundred Twenty-two Dollars (\$5,819,622.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the State Auditor and Inspector by law.

SECTION 2. There is hereby appropriated to the Office of the State Auditor and Inspector from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Four Hundred Thousand Dollars (\$400,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Commission on County Government Personnel Education and Training. The appropriation made in this section shall be expended exclusively for the purpose so stated and shall not be transferable.

SECTION 3. There is hereby appropriated to the Rural Economic Action Plan Fund of the State Treasury from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Fifteen Million Five Hundred Thousand Dollars (\$15,500,000.00) or so much thereof as may be necessary to implement the provisions of Sections 2006 through 2013 of Title 62 of the Oklahoma Statutes.

SECTION 4. There is hereby appropriated to the Office of the State Bond Advisor from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of One Hundred Eighty-five Thousand One Hundred Seventeen Dollars (\$185,117.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the State Bond Advisor by law.

SECTION 5. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Eleven Million Seven Hundred Sixty-six Thousand One Hundred Fifty-two Dollars (\$11,766,152.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Central Services by law.

SECTION 6. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of One Hundred Fifty-one Thousand Five Hundred Eighteen Dollars (\$151,518.00) or so much thereof as may be necessary to maintain the Hissom Memorial Center.

SECTION 7. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the Public Building Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of Three Hundred Fifty-seven Thousand Four Hundred Seven Dollars (\$357,407.00) to be transferred to the Building and Facility Revolving Fund created in Section 63.1 of Title 74 of the Oklahoma Statutes for the purpose of maintaining state buildings operated by the Department of Central Services.

SECTION 8. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the Public Building Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of One Million Three Hundred Sixty-four Thousand Seventy-nine Dollars (\$1,364,079.00) or so much thereof as may be necessary to be transferred to the Building and Facility Revolving Fund created in Section 63.1 of Title 74 of the Oklahoma Statutes for the purpose of maintaining state buildings operated by the Department of Central Services.

SECTION 9. There is hereby appropriated to the Oklahoma Department of Emergency Management from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Seven Hundred Fifty-six Thousand Eight Hundred Forty-three Dollars (\$756,843.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Department of Emergency Management by law.

SECTION 10. There is hereby appropriated to the State Election Board from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Five Million One Hundred Twenty-nine Thousand Nine Hundred Fifty-one Dollars (\$5,129,951.00) or so much thereof as may be necessary to perform the duties imposed upon the State Election Board by law.

SECTION 11. There is hereby appropriated to the State Election Board from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of Two Million Five Hundred Eighty Thousand Dollars (\$2,580,000.00) or so much thereof as may be required to pay the necessary expenses of holding elections.

SECTION 12. There is hereby appropriated to the Ethics Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Five Hundred Four Thousand Thirty-nine Dollars (\$504,039.00) or so much thereof as may be necessary to perform the duties imposed upon the Ethics Commission by law.

SECTION 13. There is hereby appropriated to the Office of State Finance from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Twelve Million Two Hundred Four Dollars (\$12,000,204.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of State Finance by law.

SECTION 14. There is hereby appropriated to the Office of State Finance from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Eleven Million Dollars (\$11,000,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of State Finance by law.

SECTION 15. There is hereby appropriated to the Office of the Governor from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Two Million Six Hundred Forty-one Thousand One Hundred Sixty-three Dollars (\$2,641,163.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the Governor by law.

SECTION 16. There is hereby appropriated to the Oklahoma House of Representatives from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Nineteen Million One Hundred Seventy-six Thousand Four Hundred Thirty-four Dollars (\$19,176,434.00) or so much thereof as may be necessary to pay the salaries, per diem and expenses of the members of the Oklahoma House of Representatives, the salaries of the employees of the Oklahoma House of Representatives, and other necessary expenses. Claims and payrolls filed against the appropriation made to the Oklahoma House of Representatives for the fiscal year ending June 30, 2007, shall be approved by the Speaker of the House of Representatives.

SECTION 17. There is hereby appropriated to the Legislative Service Bureau from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Two Million Three Hundred Thirty-one Thousand Two Hundred Eighty Dollars (\$2,331,280.00) or so much thereof as may be necessary to perform the duties imposed upon the Legislative Service Bureau by law.

SECTION 18. There is hereby appropriated to the Legislative Service Bureau from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Six Hundred Sixty-three Thousand Seven Hundred Forty-one Dollars (\$663,741.00) or so much thereof as may be necessary to fund the operations of the Oklahoma Criminal Justice Resource Center.

SECTION 19. There is hereby appropriated to the Office of the Lieutenant Governor from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Five Hundred Ninety-two Thousand Four Hundred Thirty-six Dollars (\$592,436.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the Lieutenant Governor by law.

SECTION 20. There is hereby appropriated to the Oklahoma Merit Protection Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Six Hundred Eleven Thousand Four Hundred Thirty-four Dollars (\$611,434.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Merit Protection Commission by law.

SECTION 21. There is hereby appropriated to the Military Department of the State of Oklahoma from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Twelve Million Eight Hundred Ninety-eight Thousand Three Hundred Thirty-four Dollars (\$12,898,334.00) or so much thereof as may be necessary to perform the duties imposed upon the Military Department of the State of Oklahoma by law.

SECTION 22. There is hereby appropriated to the Office of Personnel Management from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Four Million Eight Hundred Forty-eight Thousand Three Hundred Seventy-one Dollars (\$4,848,371.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of Personnel Management by law.

SECTION 23. There is hereby appropriated to the Office of the Secretary of State from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Five Hundred Twenty-five Thousand Four Hundred Thirty-four Dollars (\$525,434.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the Secretary of State by law.

SECTION 24. There is hereby appropriated to the Oklahoma State Senate from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the following amount, or so much thereof as may be necessary to pay monthly salaries, per diem, and expenses of the members of the Senate and the salaries of its employees, and such contingent expenses as may be ordered paid there from, including the preparation and printing of the journals and calendars of the Senate, and including the preparation and printing of the permanent journals thereof, in accordance with the following amount herein set forth:

For expenses of personal services (including retirement and insurance costs), including those of members, and employees of the Senate, and expenses of maintenance and operation, including travel expenses, supplies, materials, printing, equipment, and printing of permanent journals and for the renovation and modification of the Senate area	\$13,561,067.00

SECTION 25. There is hereby appropriated to the Oklahoma Tax Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Forty-seven Million Four Hundred Eighty-five Thousand Five Hundred Dollars (\$47,485,500.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Tax Commission by law.

SECTION 26. From the appropriation made in Section 25 of this act, the Oklahoma Tax Commission shall pay an amount not to exceed One Hundred Fifty Eight Thousand Six Hundred Fifty Dollars (\$158,650.00) for the personal services and other operating expenses of the Office of the State Auditor and Inspector in performing audits of the Oklahoma Tax Commission and motor license agents as required by law.

SECTION 27. There is hereby appropriated to the Office of the State Treasurer from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Four Million Five Hundred Thirty-two Thousand Six Hundred Ninety-seven Dollars (\$4,532,697.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the State Treasurer by law.

SECTION 28. There is hereby appropriated to the Office of the State Treasurer from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of One Hundred Thousand Dollars (\$100,000.00) or so much thereof as may be necessary to pay for bank service charges.

SECTION 29. There is hereby appropriated to the Oklahoma Space Industry Development Authority from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Five Hundred Twenty-eight Thousand Five Hundred Seventy-one Dollars (\$528,571.00)

or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Space Industry Development Authority by law.

SECTION 30. The Department of Transportation is hereby authorized to expend during the fiscal year ending June 30, 2007, from the Transportation Fund of the State Treasury, the sum of Two Hundred Ten Million Five Hundred Sixty-nine Thousand Three Hundred Thirty-two Dollars (\$210,569,332.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Transportation by law. Said authorization shall be transferred to the State Highway Construction and Maintenance Fund and shall be expended in the same manner and for the same purposes as provided by law for other monies accruing to the credit of the State Highway Construction and Maintenance Fund.

SECTION 31. There is hereby appropriated to the Department of Transportation from any monies not otherwise appropriated from the State Transportation Fund of the State Treasury for the fiscal year ending June 30, 2005, the sum of Seven Million Three Hundred Sixty-five Thousand Five Hundred Forty-eight Dollars (\$7,365,548.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Transportation by law. Said appropriation shall be transferred to the State Highway Construction and Maintenance Fund and shall be expended in the same manner and for the same purposes as provided by law for other monies accruing to the credit of the State Highway Construction and Maintenance Fund.

SECTION 32. There is hereby appropriated to the Department of Transportation from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Sixty-seven Million Four Hundred Seventy-six Thousand Nine Hundred Sixty-eight Dollars (\$67,476,968.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Transportation by law. Said appropriation shall be transferred to the State Highway Construction and Maintenance Fund and shall be expended in the same manner and for the same purposes as provided by law for other monies accruing to the credit of the State Highway Construction and Maintenance Fund.

#### SUBCOMMITTEE ON HUMAN SERVICES

SECTION 33. There is hereby appropriated to the Oklahoma Commission on Children and Youth from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Two Million One Hundred One Thousand Six Hundred Nine Dollars (\$2,101,609.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Commission on Children and Youth by law.

SECTION 34. There is hereby appropriated to the Office of Handicapped Concerns from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Three Hundred Eighty-one Thousand Eight Hundred Thirteen Dollars (\$381,813.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of Handicapped Concerns by law.

SECTION 35. There is hereby appropriated to the Oklahoma Human Rights Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Seven Hundred Four Thousand Three Hundred Ten Dollars (\$704,310.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Human Rights Commission by law.

SECTION 36. There is hereby appropriated to the Department of Human Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Four Hundred Eighty-six Million Six Hundred Thirty-five Thousand One Hundred Forty-five Dollars (\$486,635,145.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Human Services by law.

SECTION 37. There is hereby appropriated to the Department of Human Services from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of Thirty-five Million Eight Hundred Fifty-seven Thousand Six Hundred Eighty-eight Dollars (\$35,857,688.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Human Services by law.

SECTION 38. There is hereby appropriated to the Department of Human Services from any monies not otherwise appropriated from the Tobacco Settlement Fund of the State Treasury, the sum of Thirteen Million Three Hundred Four Thousand Four Hundred Ninety-one Dollars (\$13,304,491.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Human Services by law.

SECTION 39. There is hereby appropriated to the State Department of Rehabilitation Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Twenty-eight Million Nine Hundred Sixty-three Thousand Two Hundred Fifty Dollars (\$28,963,250.00) or so much thereof as may be necessary to perform the duties imposed upon the State Department of Rehabilitation Services by law.

SECTION 40. There is hereby appropriated to the State Department of Rehabilitation Services from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Two Hundred Fifty Thousand Dollars (\$250,000.00) pursuant to subparagraph (f) of paragraph 2 of subsection C of Section 713 of Title 3A of the Oklahoma Statutes for allocation by the State Department of Rehabilitation Services pursuant to the provisions of Article XIII Section 2 of the Oklahoma Constitution for the programs and personnel of the Oklahoma School for the Deaf and the Oklahoma School for the Blind administered by the State Department of Rehabilitation Services.

SECTION 41. There is hereby appropriated to the Oklahoma Indian Affairs Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year

ending June 30, 2007, the sum of Two Hundred Fifty-seven Thousand Seven Hundred Thirty-two Dollars (\$257,732.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Indian Affairs Commission by law.

SECTION 42. There is hereby appropriated to the Office of Juvenile Affairs from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of One Hundred Four Million Two Hundred Nineteen Thousand Five Hundred Eighty-five Dollars (\$104,219,585.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of Juvenile Affairs by law.

#### SUBCOMMITTEE ON HEALTH AND SOCIAL SERVICES

SECTION 43. There is hereby appropriated to the Department of Mental Health and Substance Abuse Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of One Hundred Ninety-four Million Seven Hundred Three Thousand Eight Hundred Dollars (\$194,703,800.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Mental Health and Substance Abuse Services by law.

SECTION 44. There is hereby appropriated to the State Department of Health from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Seventy-one Million Two Hundred Thirty-four Thousand One Hundred Thirty-one Dollars (\$71,234,131.00) or so much thereof as may be necessary to perform the duties imposed upon the State Department of Health by law.

SECTION 45. There is hereby appropriated to the University Hospitals Authority from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Forty-one Million Six Hundred Sixty-five Thousand Three Hundred Forty-two Dollars (\$41,665,342.00) or so much thereof as may be necessary to perform the duties imposed upon the University Hospitals Authority by law.

SECTION 46. There is hereby appropriated to the Oklahoma Health Care Authority from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Seven Hundred One Million Nine Hundred Sixty-four Thousand One Hundred Sixty-three Dollars (\$701,964,163.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Health Care Authority by law.

SECTION 47. There is hereby appropriated to the J.D. McCarty Center for Children with Developmental Disabilities from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Four Million Two Hundred Seventy-eight Thousand Nine Hundred Forty-four Dollars (\$4,278,944.00) or so much thereof as may be necessary to perform the duties imposed upon the J.D. McCarty Center for Children with Developmental Disabilities by law.

SECTION 48. There is hereby appropriated to the Oklahoma Department of Veterans Affairs from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Thirty-nine Million Three Hundred Twenty-four Thousand One Hundred Fifty-nine Dollars (\$39,324,159.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Department of Veterans Affairs by law.

SUBCOMMITTEE ON NATURAL RESOURCES AND REGULATORY SERVICES

SECTION 49. There is hereby appropriated to the Oklahoma Department of Agriculture, Food, and Forestry from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Twenty-eight Million Three Hundred Fourteen Thousand Nine Hundred Six Dollars (\$28,314,906.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Department of Agriculture, Food, and Forestry by law.

SECTION 50. The Oklahoma State Regents for Higher Education are hereby authorized to expend during the fiscal year ending June 30, 2007, the sum of Forty-five Million Seven Thousand Dollars (\$45,007,000.00) from the Higher Education Capital Revolving Fund of the State Treasury for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 111. The Oklahoma State Regents for Higher Education are hereby authorized to expend during the fiscal year ending June 30, 2007, the sum of Forty-five Million Seven Thousand Dollars (\$45,007,000.00) from the Oklahoma Student Aid Revolving Fund of the State Treasury for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 112. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Thirteen Million Seven Hundred Thirty Thousand Seventy-five Dollars (\$13,730,075.00) pursuant to paragraph 2 of subsection C of Section 713 of Title 3A of the Oklahoma Statutes for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 113. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Nineteen Million Five Hundred Thousand Dollars (\$19,500,000.00) or so much thereof as may be necessary for expenditures in the Oklahoma Higher Learning Access Program.

SECTION 114. The Oklahoma State Regents for Higher Education are hereby authorized to expend during the fiscal year ending June 30, 2007, the sum of Four Million Nine Hundred Twenty-seven Thousand Eight Hundred Dollars (\$4,927,800.00) from the Oklahoma Higher Learning Access Trust Fund of the State Treasury or so much thereof as may be necessary for expenditures in the Oklahoma Higher Learning Access Program.

SECTION 115. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of One Million Four Hundred Thousand Dollars (\$1,400,000.00) or so much thereof as may be necessary for expenditures for concurrent enrollment pursuant to Section 628.13 of Title 70 of the Oklahoma Statutes.

SECTION 116. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Thirty-three Million Dollars (\$33,000,000.00) pursuant to paragraph 2 of subsection C of Section 713 of Title 3A of the Oklahoma Statutes for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education or for any other purpose authorized by paragraph 2 of subsection C of Section 713 of Title 3A of the Oklahoma Statutes.

SECTION 117. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Five Million Five Hundred Sixty-one Thousand Two Hundred Sixty-six Dollars (\$5,561,266.00) or so much thereof as may be necessary for the general operating budget of the Administrative Offices of the Oklahoma State Regents for Higher Education.

SECTION 118. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Seven Hundred Fifty Thousand One Hundred Twenty Dollars (\$750,120.00) or so much thereof as may be necessary for the Office of Accountability to perform the duties imposed upon the Office of Accountability by law.

SECTION 119. There is hereby appropriated to the Oklahoma Department of Libraries from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Six Million Eight Hundred Forty-seven Thousand Seven Hundred Thirty-one Dollars (\$6,847,731.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Department of Libraries by law.

SECTION 120. There is hereby appropriated to the Commissioners of the Land Office from any monies not otherwise appropriated from the Commissioners of the Land Office Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Four Million Eight Hundred Twenty-eight Thousand Five Hundred Thirty-five Dollars (\$4,828,535.00) or so much thereof as may be necessary to perform the duties imposed upon the Commissioners of the Land Office by law.

SECTION 121. There is hereby appropriated to the Physician Manpower Training Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for

the fiscal year ending June 30, 2007, the sum of Five Million Seventy Thousand Four Hundred Ninety-nine Dollars (\$5,070,499.00) or so much thereof as may be necessary to perform the duties imposed upon the Physician Manpower Training Commission by law.

SECTION 122. There is hereby appropriated to the Physician Manpower Training Commission from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of Four Hundred Thousand Dollars (\$400,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Physician Manpower Training Commission by law.

SECTION 123. There is hereby appropriated to the Board of Trustees of the Oklahoma School of Science and Mathematics from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Seven Million Two Hundred Thirty Thousand Five Hundred Eight Dollars (\$7,230,508.00) or so much thereof as may be necessary to perform the duties imposed upon the Board of Trustees of the Oklahoma School of Science and Mathematics by law.

SECTION 124. There is hereby appropriated to the Oklahoma Center for the Advancement of Science and Technology from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Twenty-two Million Four Hundred Forty-two Thousand Six Hundred Sixteen Dollars (\$22,442,616.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Center for the Advancement of Science and Technology by law.

SECTION 125. There is hereby appropriated to the Oklahoma Commission for Teacher Preparation from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Two Million Fifty Thousand Seven Hundred Five Dollars (\$2,050,705.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Commission for Teacher Preparation by law.

SECTION 126. There is hereby appropriated to the State Board of Career and Technology Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of One Hundred Forty-one Million Two Hundred Eighty-seven Thousand Three Hundred Fifty-eight Dollars (\$141,287,358.00) or so much thereof as may be necessary to perform the duties imposed upon the State Board of Career and Technology Education by law.

SECTION 127. There is hereby appropriated to the State Board of Career and Technology Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Six Million Dollars (\$6,000,000.00) pursuant to paragraph 2 of subsection C of Section 713 of Title 3A of the Oklahoma Statutes for allocation by the State Board of Career and Technology Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or

repairs administered by the State Board of Career and Technology Education.

SECTION 128. The Oklahoma Board of Private Vocational Schools is hereby authorized to expend during the fiscal year ending June 30, 2007, from the Oklahoma Board of Private Vocational Schools Revolving Fund of the State Treasury, the sum of One Hundred Ninety-two Thousand Two Hundred Forty-five Dollars (\$192,245.00) or so much thereof as may be to perform the duties imposed upon the Board of Private Vocational Schools by law.

SECTION 129. There is hereby appropriated to the Oklahoma Tax Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Two Hundred Twenty-six Thousand One Hundred Four Dollars (\$226,104.00) or so much thereof as may be necessary to perform the duties imposed upon the Commission on County Government Personnel Education and Training. The appropriation made in this section shall be expended exclusively for the purpose so stated and shall not be transferable.

SECTION 130. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury the sum of Eleven Million Seven Hundred Nineteen Thousand Two Hundred Thirty-four Dollars (\$11,719,234.00) or so much thereof as may be necessary to be transferred to the Oklahoma Tax Commission and which shall be deposited in the Ad Valorem Reimbursement Fund created pursuant to Section 193 of Title 62 of the Oklahoma Statutes for the purpose of reimbursing counties for school districts that claim a loss of revenue due to a tax exemption granted for a new or expanded manufacturing or research and development facility pursuant to the provisions of Section 6B of Article X of the Oklahoma Constitution.

SECTION 131. Sections 1 through 129 of this act shall become effective July 1, 2006.
