FLOOR SUBSTITUTE

An Act relating to the District Attorneys Council; making an appropriation to the Office of the Attorney General for the benefit of the District Attorneys Council; stating purpose; amending Section 1, Chapter 495, O.S.L. 2004, which relates to budget categories; changing category amounts; and declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. There is hereby appropriated to the Office of the Attorney General from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of Two Million Two Hundred Fifty Thousand Dollars (\$2,250,000.00) or so much thereof as may be necessary to perform the duties imposed upon the District Attorneys Council by law.

SECTION 2. AMENDATORY Section 1, Chapter 495, O.S.L. 2004, is amended to read as follows:

Section 1. For the fiscal year ending June 30, 2005, the District Attorneys Council shall budget all funds in the following categories and amounts:
