13 expenses of various agencies of the executive,  
14 legislative and judicial departments of the state;  
15 making appropriations to the Oklahoma State Regents  
16 for Higher Education, the State Board of Career and  
17 Technology Education, the Oklahoma Arts Council, the  
18 Oklahoma Educational Television Authority, the  
19 Commissioners of the Land Office, the Oklahoma

Handicapped Concerns, the Oklahoma Human Rights  
Commission, the Department of Human Services, the  
Oklahoma Indian Affairs Commission, the Office of  
Juvenile Affairs, the State Department of  
Rehabilitation Services, the Oklahoma Department of  
Agriculture, Food, and Forestry, the Oklahoma Capitol  
Complex and Centennial Commemoration Commission, the

1 Department of Commerce, the Oklahoma Conservation  
2 Commission, the Department of Consumer Credit, the  
3 Corporation Commission, the Department of  
4 Environmental Quality, the Oklahoma Historical  
5 Society, the Oklahoma Horse Racing Commission, the  
6 State Insurance Department, the J.M. Davis Memorial  
7 Commission, the Department of Labor, the Department  
8 of Mines, the Oklahoma Scenic Rivers Commission, the  
9 Oklahoma Tourism and Recreation Department, the  
10 Oklahoma Water Resources Board, the Will Rogers  
11 Memorial Commission, the Alcoholic Beverage Laws  
12 Enforcement Commission, the Department of  
13 Corrections, the Pardon and Parole Board, the  
14 Oklahoma State Bureau of Investigation, the State  
15 Fire Marshal, the Board of Medicolegal  
16 Investigations, the Council on Law Enforcement  
17 Education and Training, the Oklahoma State Bureau of  
18 Narcotics and Dangerous Drugs Control, the Department  
19 of Public Safety, the Oklahoma Indigent Defense  
20 System, the Office of the Attorney General, the Court  
21 of Criminal Appeals, the Supreme Court, the Workers'  
22 Compensation Court, the Council on Judicial  
23 Complaints, and the Rural Economic Action Plan Fund;  
24 The State Emergency Fund; stating sums of the  
25 appropriations; stating purposes and restrictions;  
26 authorizing and requiring certain expenditures;  
27 authorizing and requiring certain transfers; and  
28 providing an effective date.

29 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

30 SUBCOMMITTEE ON EDUCATION

31 SECTION 1. There is hereby appropriated to the Oklahoma State  
32 Regents for Higher Education from any monies not otherwise  
appropriated from the General Revenue Fund of the State Treasury for  
the fiscal year ending June 30, 2006, the sum of Six Hundred Eighty-  
seven Million Five Hundred Twelve Thousand Ten Dollars  
(\$687,512,010.00) or so much thereof as may be necessary for  
allocation by the Oklahoma State Regents for Higher Education  
pursuant to the provisions of Article XIII-A of the Oklahoma  
Constitution for the education and general operating budgets of the  
institutions and for other programs, construction, renovations or  
repairs administered by the Oklahoma State Regents for Higher  
Education.

SECTION 2. The Oklahoma State Regents for Higher Education are  
hereby authorized to expend during the fiscal year ending June 30,

1 2006, the sum of Fifty-seven Million Eight Hundred Twenty-two  
2 Thousand One Hundred Seventy-eight Dollars (\$57,822,178.00) from the  
3 Higher Education Capital Revolving Fund of the State Treasury for  
4 allocation by the Oklahoma State Regents for Higher Education  
5 pursuant to the provisions of Article XIII-A of the Oklahoma  
6 Constitution for the education and general operating budgets of the  
7 institutions and for other programs, construction, renovations or  
8 repairs administered by the Oklahoma State Regents for Higher  
9 Education.

10 SECTION 3. The Oklahoma State Regents for Higher Education are  
11 hereby authorized to expend during the fiscal year ending June 30,  
12 2006, the sum of One Million Nine Hundred Seventy-seven Thousand  
13 Eight Hundred Sixty-one Dollars (\$1,977,861.00) from the Higher  
14 Education Capital Revolving Fund for allocation by the Oklahoma  
15 State Regents for Higher Education pursuant to the provisions of  
16 Article XIII-A of the Oklahoma Constitution for the education and  
17 general operating budgets of the institutions and for other  
18 programs, construction, renovations or repairs administered by the  
19 Oklahoma State Regents for Higher Education.

20 SECTION 4. There is hereby appropriated to the Oklahoma State  
21 Regents for Higher Education from any monies not otherwise  
22 appropriated from the Oklahoma Education Lottery Trust Fund, the sum  
23 of Twenty-eight Million Twenty-two Thousand One Hundred Thirty-nine  
24 Dollars (\$28,022,139.00) pursuant to paragraph 2 of subsection C of  
25 Section 713 of Title 3A of the Oklahoma Statutes for allocation by  
26 the Oklahoma State Regents for Higher Education pursuant to the  
27 provisions of Article XIII-A of the Oklahoma Constitution for the  
28 education and general operating budgets of the institutions and for  
29 other programs, construction, renovations or repairs administered by  
30 the Oklahoma State Regents for Higher Education.

31 SECTION 5. The Oklahoma State Regents for Higher Education are  
32 hereby authorized to expend during the fiscal year ending June 30,

1 2006, the sum of Fifty-five Million Eight Hundred Thousand Thirty-  
2 nine Dollars (\$55,800,039.00) from the Oklahoma Tuition Scholarship  
3 Revolving Fund of the State Treasury for allocation by the Oklahoma  
4 State Regents for Higher Education pursuant to the provisions of  
5 Article XIII-A of the Oklahoma Constitution for the education and  
6 general operating budgets of the institutions and for other  
7 programs, construction, renovations or repairs administered by the  
8 Oklahoma State Regents for Higher Education.

9 SECTION 6. There is hereby appropriated to the Oklahoma State  
10 Regents for Higher Education from any monies not otherwise  
11 appropriated from the General Revenue Fund of the State Treasury for  
12 the fiscal year ending June 30, 2006, the sum of Five Million Four  
13 Hundred Four Thousand Seven Hundred Ninety-one Dollars  
14 (\$5,404,791.00) or so much thereof as may be necessary for the  
15 general operating budget of the Administrative Offices of the  
16 Oklahoma State Regents for Higher Education.

17 SECTION 7. There is hereby appropriated to the Oklahoma State  
18 Regents for Higher Education from any monies not otherwise  
19 appropriated from the Special Cash Fund of the State Treasury, the  
20 sum of Eight Million Dollars (\$8,000,000.00) or so much thereof as  
21 may be necessary for expenditures in the Oklahoma Higher Learning  
22 Access Program.

23 SECTION 8. There is hereby appropriated to the Oklahoma State  
24 Regents for Higher Education from any monies not otherwise  
25 appropriated from the "Jobs and Growth Tax Relief Fund", otherwise  
26 designated as Fund 720 within the Office of State Finance, the sum  
27 of Seventeen Million Dollars (\$17,000,000.00) or so much thereof as  
28 may be necessary for the education and general operating budgets of  
29 the institutions and for other programs, construction, renovations  
30 or repairs administered by the Oklahoma State Regents for Higher  
31 Education.

1 SECTION 9. There is hereby appropriated to the Oklahoma State  
2 Regents for Higher Education from any monies not otherwise  
3 appropriated from the General Revenue Fund of the State Treasury for  
4 the fiscal year ending June 30, 2006, the sum of Eight Hundred Fifty  
5 Thousand One Hundred Twenty Dollars (\$850,120.00) or so much thereof  
6 as may be necessary for the Office of Accountability to perform the  
7 duties imposed upon the Office of Accountability by law.

8 SECTION 10. There is hereby appropriated to the State Board of  
9 Career and Technology Education from any monies not otherwise  
10 appropriated from the General Revenue Fund of the State Treasury for  
11 the fiscal year ending June 30, 2006, the sum of One Hundred Fifteen  
12 Million Two Hundred Seventy-seven Thousand One Hundred Ninety-six  
13 Dollars (\$115,277,196.00) or so much thereof as may be necessary to  
14 perform the duties imposed upon the State Board of Career and  
15 Technology Education by law.

16 SECTION 11. There is hereby appropriated to the State Board of  
17 Career and Technology Education from any monies not otherwise  
18 appropriated from the General Revenue Fund of the State Treasury for  
19 the fiscal year ending June 30, 2006, the sum of Six Million One  
20 Hundred Fifty-seven Thousand Two Hundred Fifteen Dollars  
21 (\$6,157,215.00) or so much thereof as may be necessary for the  
22 Certified Employee Health Benefit Allowance.

23 SECTION 12. There is hereby appropriated to the State Board of  
24 Career and Technology Education from any monies not otherwise  
25 appropriated from the General Revenue Fund of the State Treasury for  
26 the fiscal year ending June 30, 2006, the sum of Five Million Five  
27 Hundred Fifty-two Thousand Four Hundred Thirty-four Dollars  
28 (\$5,552,434.00) or so much thereof as may be necessary for the  
29 Support Personnel Health Benefit Allowance.

30 SECTION 13. There is hereby appropriated to the Oklahoma Arts  
31 Council from any monies not otherwise appropriated from the General  
32 Revenue Fund of the State Treasury for the fiscal year ending June

1 30, 2006, the sum of Four Million Ninety-three Thousand Three  
2 Hundred Thirty-eight Dollars (\$4,093,338.00) or so much thereof as  
3 may be necessary to perform the duties imposed upon the Oklahoma  
4 Arts Council by law.

5 SECTION 14. There is hereby appropriated to the Oklahoma  
6 Educational Television Authority from any monies not otherwise  
7 appropriated from the General Revenue Fund of the State Treasury for  
8 the fiscal year ending June 30, 2006, the sum of Four Million Two  
9 Hundred Ninety-eight Thousand Fifty-nine Dollars (\$4,298,059.00) or  
10 so much thereof as may be necessary to perform the duties imposed  
11 upon the Oklahoma Educational Television Authority by law.

12 SECTION 15. There is hereby appropriated to the Commissioners  
13 of the Land Office from any monies not otherwise appropriated from  
14 the Commissioners of the Land Office Fund of the State Treasury for  
15 the fiscal year ending June 30, 2006, the sum of Four Million Eight  
16 Hundred Forty-three Thousand Four Hundred Ninety-seven Dollars  
17 (\$4,843,497.00) or so much thereof as may be necessary to perform  
18 the duties imposed upon the Commissioners of the Land Office by law.

19 SECTION 16. There is hereby appropriated to the Oklahoma  
20 Department of Libraries from any monies not otherwise appropriated  
21 from the General Revenue Fund of the State Treasury for the fiscal  
22 year ending June 30, 2006, the sum of Six Million Seven Hundred  
23 Eighty-one Thousand Three Hundred Fifty-five Dollars (\$6,781,355.00)  
24 or so much thereof as may be necessary to perform the duties imposed  
25 upon the Oklahoma Department of Libraries by law.

26 SECTION 17. There is hereby appropriated to the Physician  
27 Manpower Training Commission from any monies not otherwise  
28 appropriated from the General Revenue Fund of the State Treasury for  
29 the fiscal year ending June 30, 2006, the sum of Five Million  
30 Thirty-four Thousand Four Hundred Ninety Dollars (\$5,034,490.00) or  
31 so much thereof as may be necessary to perform the duties imposed  
32 upon the Physician Manpower Training Commission by law.

1 SECTION 18. There is hereby appropriated to the Oklahoma Board  
2 of Private Vocational Schools from any monies not otherwise  
3 appropriated from the General Revenue Fund of the State Treasury for  
4 the fiscal year ending June 30, 2006, the sum of One Hundred Sixty-  
5 one Thousand Eight Hundred Seventy-nine Dollars (\$161,879.00) or so  
6 much thereof as may be necessary to perform the duties imposed upon  
7 the Oklahoma Board of Private Vocational Schools by law.

8 SECTION 19. There is hereby appropriated to the Board of  
9 Trustees of the Oklahoma School of Science and Mathematics from any  
10 monies not otherwise appropriated from the General Revenue Fund of  
11 the State Treasury for the fiscal year ending June 30, 2006, the sum  
12 of Seven Million Two Hundred Sixty-six Thousand Five Hundred  
13 Thirteen Dollars (\$7,266,513.00) or so much thereof as may be  
14 necessary to perform the duties imposed upon the Board of Trustees  
15 of the Oklahoma School of Science and Mathematics by law.

16 SECTION 20. There is hereby appropriated to the Oklahoma Center  
17 for the Advancement of Science and Technology from any monies not  
18 otherwise appropriated from the General Revenue Fund of the State  
19 Treasury for the fiscal year ending June 30, 2006, the sum of  
20 Sixteen Million Seven Hundred Thousand Nine Hundred Forty-two  
21 Dollars (\$16,700,942.00) or so much thereof as may be necessary to  
22 perform the duties imposed upon the Oklahoma Center for the  
23 Advancement of Science and Technology by law.

24 SECTION 21. There is hereby appropriated to the Oklahoma  
25 Commission for Teacher Preparation from any monies not otherwise  
26 appropriated from the General Revenue Fund of the State Treasury for  
27 the fiscal year ending June 30, 2006, the sum of Two Million Twenty-  
28 two Thousand Eight Hundred Seventy-five Dollars (\$2,022,875.00) or  
29 so much thereof as may be necessary to perform the duties imposed  
30 upon the Oklahoma Commission for Teacher Preparation by law.

31 SUBCOMMITTEE ON GENERAL GOVERNMENT AND TRANSPORTATION  
32

1 SECTION 22. There is hereby appropriated to the Office of the  
2 State Auditor and Inspector from any monies not otherwise  
3 appropriated from the General Revenue Fund of the State Treasury for  
4 the fiscal year ending June 30, 2006, the sum of Five Million Three  
5 Hundred Ten Thousand Seven Hundred Sixty-three Dollars  
6 (\$5,310,763.00) or so much thereof as may be necessary to perform  
7 the duties imposed upon the Office of the State Auditor and  
8 Inspector by law.

9 SECTION 23. There is hereby appropriated to the Office of the  
10 State Auditor and Inspector from any monies not otherwise  
11 appropriated from the General Revenue Fund of the State Treasury for  
12 the fiscal year ending June 30, 2006, the sum of Four Hundred  
13 Seventy-eight Thousand Twenty-three Dollars (\$478,023.00) or so much  
14 thereof as may be necessary to perform the duties imposed upon the  
15 Commission on County Government Personnel Education and Training.  
16 The appropriation made in this section shall be expended exclusively  
17 for the purpose so stated and shall not be transferable.

18 SECTION 24. There is hereby appropriated to the Office of the  
19 State Bond Advisor from any monies not otherwise appropriated from  
20 the General Revenue Fund of the State Treasury for the fiscal year  
21 ending June 30, 2006, the sum of One Hundred eighty-one Thousand Two  
22 Hundred Twelve Dollars (\$181,212.00) or so much thereof as may be  
23 necessary to perform the duties imposed upon the Office of the State  
24 Bond Advisor by law.

25 SECTION 25. There is hereby appropriated to the Department of  
26 Central Services from any monies not otherwise appropriated from the  
27 General Revenue Fund of the State Treasury for the fiscal year  
28 ending June 30, 2006, the sum of Nine Million Four Hundred Eleven  
29 Thousand Five Hundred Thirty-nine Dollars (\$9,411,539.00) or so much  
30 thereof as may be necessary to perform the duties imposed upon the  
31 Department of Central Services by law.

32

1 SECTION 26. There is hereby appropriated to the Department of  
2 Central Services from any monies not otherwise appropriated from the  
3 General Revenue of the State Treasury for the fiscal year ending  
4 June 30, 2006, the sum of One Million One Hundred Fifteen Thousand  
5 Four Hundred Forty-nine Dollars (\$1,115,449.00) to be transferred to  
6 the Building and Facility Revolving Fund created in Section 63.1 of  
7 Title 74 of the Oklahoma Statutes for the purpose of maintaining  
8 state buildings operated by the Department of Central Services.

9 SECTION 27. There is hereby appropriated to the Department of  
10 Central Services from any monies not otherwise appropriated from the  
11 Public Building Fund of the State Treasury for the fiscal year  
12 ending June 30, 2004, the sum of Five Hundred Seventy Thousand Four  
13 Hundred Ninety-four Dollars (\$570,494.00) to be transferred to the  
14 Building and Facility Revolving Fund created in Section 63.1 of  
15 Title 74 of the Oklahoma Statutes for the purpose of maintaining  
16 state buildings operated by the Department of Central Services.

17 SECTION 28. There is hereby appropriated to the Department of  
18 Central Services from any monies not otherwise appropriated from the  
19 Public Building Fund of the State Treasury for the fiscal year  
20 ending June 30, 2006, the sum of One Million Three Hundred Ten  
21 Thousand One Hundred Fifty-one Dollars (\$1,310,151.00) to be  
22 transferred to the Building and Facility Revolving Fund created in  
23 Section 63.1 of Title 74 of the Oklahoma Statutes for the purpose of  
24 maintaining state buildings operated by the Department of Central  
25 Services.

26 SECTION 29. There is hereby appropriated to the Department of  
27 Central Services from any monies not otherwise appropriated from the  
28 General Revenue Fund of the State Treasury for the fiscal year  
29 ending June 30, 2006, the sum of Three Thousand Eight Hundred  
30 Eighty-four Dollars (\$3,884.00) or so much thereof as may be  
31 necessary to perform maintenance on the Veterans Memorial within the  
32 Capitol complex.

1 SECTION 30. There is hereby appropriated to the Department of  
2 Central Services from any monies not otherwise appropriated from the  
3 General Revenue Fund of the State Treasury for the fiscal year  
4 ending June 30, 2006, the sum of One Hundred Fifty-one Thousand Five  
5 Hundred Eighteen Dollars (\$151,518.00) or so much thereof as may be  
6 necessary to maintain the Hissom Memorial Center.

7 SECTION 31. There is hereby appropriated to the Oklahoma  
8 Department of Emergency Management from any monies not otherwise  
9 appropriated from the General Revenue Fund of the State Treasury for  
10 the fiscal year ending June 30, 2006, the sum of Seven Hundred One  
11 Thousand Five Hundred Sixty-one Dollars (\$701,561.00) or so much  
12 thereof as may be necessary to perform the duties imposed upon the  
13 Oklahoma Department of Emergency Management by law.

14 SECTION 32. There is hereby appropriated to the State Election  
15 Board from any monies not otherwise appropriated from the General  
16 Revenue Fund of the State Treasury for the fiscal year ending June  
17 30, 2006, the sum of Six Million Four Hundred Forty-one Thousand  
18 Eight Hundred Thirty-nine Dollars (\$6,441,839.00) or so much thereof  
19 as may be necessary to perform the duties imposed upon the State  
20 Election Board by law.

21 SECTION 33. There is hereby appropriated to the Ethics  
22 Commission from any monies not otherwise appropriated from the  
23 General Revenue Fund of the State Treasury for the fiscal year  
24 ending June 30, 2006, the sum of Four Hundred Ninety-two Thousand  
25 Two Hundred Seventy-seven Dollars (\$492,277.00) or so much thereof  
26 as may be necessary to perform the duties imposed upon the Ethics  
27 Commission by law.

28 SECTION 34. There is hereby appropriated to the Office of State  
29 Finance from any monies not otherwise appropriated from the General  
30 Revenue Fund of the State Treasury for the fiscal year ending June  
31 30, 2006, the sum of Eighteen Million Seven Hundred Fifty-six  
32 Thousand Five Hundred Fifteen Dollars (\$18,756,515.00) or so much

1 thereof as may be necessary to perform the duties imposed upon the  
2 Office of State Finance by law.

3 SECTION 35. There is hereby appropriated to the Office of State  
4 Finance from any monies not otherwise appropriated from the Special  
5 Cash Fund, the sum of Six Million Dollars (\$6,000,000.00) or so much  
6 thereof as may be necessary to perform the duties imposed upon the  
7 Office of State Finance by law.

8 SECTION 36. There is hereby appropriated to the Office of the  
9 Governor from any monies not otherwise appropriated from the General  
10 Revenue Fund of the State Treasury for the fiscal year ending June  
11 30, 2006, the sum of Two Million Five Hundred Seventy-eight Thousand  
12 Seven Hundred Ten Dollars (\$2,578,710.00) or so much thereof as may  
13 be necessary to perform the duties imposed upon the Office of the  
14 Governor by law.

15 SECTION 37. There is hereby appropriated to the Oklahoma House  
16 of Representatives from any monies not otherwise appropriated from  
17 the General Revenue Fund of the State Treasury for the fiscal year  
18 ending June 30, 2006, the following amount, or so much thereof as  
19 may be necessary to pay monthly salaries, per diem, and expenses of  
20 the members of the House of Representatives and the salaries of its  
21 employees, and such contingent expenses as may be ordered paid  
22 therefrom, including the preparation and printing of the journals  
23 and calendars of the House of Representatives, and including the  
24 preparation and printing of the permanent journals thereof, in  
25 accordance with the following amount herein set forth:

26 For expenses of personnel services  
27 (including retirement and insurance  
28 costs), including those of members, and  
29 employees of the House of  
30 Representatives, and expenses of  
31 maintenance and operation, including  
32 travel expenses, supplies, materials,

1 printing, equipment, and printing of  
2 permanent journals; and for the  
3 renovation and modification of the  
4 House of Representatives area; and  
5 other necessary expenses \$18,629,154.00

6 Claims and payrolls filed against the appropriation made to the  
7 House of Representatives for the fiscal year ending June 30, 2006,  
8 shall be approved by the Speaker of the House of Representatives.

9 SECTION 38. There is hereby appropriated to the Legislative  
10 Service Bureau from any monies not otherwise appropriated from the  
11 General Revenue Fund of the State Treasury for the fiscal year  
12 ending June 30, 2006, the sum of One Million Seven Hundred Twenty-  
13 four Thousand Seven Hundred Eighty-eight Dollars (\$1,724,788.00) or  
14 so much thereof as may be necessary to perform the duties imposed  
15 upon the Legislative Service Bureau by law.

16 SECTION 39. There is hereby appropriated to the Legislative  
17 Service Bureau from any monies not otherwise appropriated from the  
18 General Revenue Fund of the State Treasury for the fiscal year  
19 ending June 30, 2006, the sum of Six Hundred Forty Thousand Nine  
20 Hundred Ninety-five Dollars (\$640,995.00) or so much thereof as may  
21 be necessary to perform the duties imposed upon the Oklahoma  
22 Criminal Justice Resource Center by law.

23 SECTION 40. There is hereby appropriated to the Office of the  
24 Lieutenant Governor from any monies not otherwise appropriated from  
25 the General Revenue Fund of the State Treasury for the fiscal year  
26 ending June 30, 2006, the sum of Five Hundred Thirty-six Thousand  
27 Four Hundred Thirty-six Dollars (\$536,436.00) or so much thereof as  
28 may be necessary to perform the duties imposed upon the Office of  
29 the Lieutenant Governor by law.

30 SECTION 41. There is hereby appropriated to the Oklahoma Merit  
31 Protection Commission from any monies not otherwise appropriated
