An Act relating to roads, bridges and ferries; designating a certain section of highway the Randy Littlefield Memorial Highway; requiring placement of markers; limiting naming or renaming sections of certain highway; designating a certain section of highway Harrah Road; designating a certain section of highway the Billy Fairl Morgan Memorial Highway; removing existing name on certain section of highway; requiring placement of markers; providing for codification; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 1674 of Title 69, unless there is created a duplication in numbering, reads as follows:

State Highway 20 from the junction of State Highway 10 and U.S. Highway 59 east of Jay, Oklahoma, up to the Missouri state line,

1 shall be designated the "Randy Littlefield Memorial Highway". The
2 Department of Transportation shall cause suitable permanent markers
3 be placed upon the highway bearing that name.

4 SECTION 2. NEW LAW A new section of law to be codified
5 in the Oklahoma Statutes as Section 1675 of Title 69, unless there
6 is created a duplication in numbering, reads as follows:

7 No section of State Highway 270 extending between N.E. 23rd
8 Street to the municipal limits of McLoud, Oklahoma, shall be named
9 or renamed, except as provided in this section. The section of
10 highway on State Highway 270 extending from Harrah, Oklahoma,
11 between N.E. 23rd Street to S.E. 29th Street shall be designated as
12 "Harrah Road". The section of highway on State Highway 270
13 extending from where the newly designated "Harrah Road" intersects
14 with S.E. 29th Street to the McLoud municipal limits shall be
15 designated as the "Billy Fairl Morgan Memorial Highway". Any
16 existing name on the section of highway between N.E. 23rd Street and
17 the municipal limits of McLoud shall be removed. The Department of
18 Transportation shall cause suitable permanent markers to be placed
19 on the section of highway between S.E. 29th Street and the municipal
20 limits of McLoud bearing the name "Billy Fairl Morgan Memorial
21 Highway".

22 SECTION 3. This act shall become effective November 1, 2005.
