House Bill No. 2155

ENGROSSED HOUSE BILL NO. 2155 - By: WRIGHT of the House and EASLEY of the Senate.

An Act relating to sunset; amending 53 O.S. 2001, Section 231, which relates to the Oklahoma Music Hall of Fame Board; re-creating the Board; amending 74 O.S. 2001, Sections 3907, as last amended by Section 6, Chapter 168, O.S.L. 2005 and 3908 (74 O.S. Supp. 2005, Section 3907), which relate to omnibus list of entities for sunset review; and updating termination date and list.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 53 O.S. 2001, Section 231, is amended to read as follows:

Section 231. A. There is hereby created until July 1, 2006 2012, in accordance with the provisions of the Oklahoma Sunset Law, a board to be designated as the "Oklahoma Music Hall of Fame Board". The Board shall be composed of seven (7) members who shall be appointed by the Governor with the advice and consent of the Senate. Of the initial members appointed, two shall serve for two (2) years, two shall serve for four (4) years, and three shall serve for six (6) years as the Governor may direct. After the initial appointment, all members shall serve six-year terms. Selection of

1 members shall be made from those individuals who have shown a  
2 sincere desire to recognize Oklahoma's contribution to music.

3 B. The Board shall elect a chair and vice-chair from among the  
4 membership to serve for one (1) year. Members of the Board shall  
5 not be compensated for their services, but each member shall be  
6 entitled to reimbursement in accordance with the State Travel  
7 Reimbursement Act for expenses incurred in attending Board meetings.  
8 The Board shall meet quarterly and at such other times as its rules  
9 may prescribe. A majority of the members appointed shall constitute  
10 a quorum for transaction of business. The Board may appoint and fix  
11 the salaries and duties of an executive secretary or director and  
12 such staff as may be necessary for the performance of its duties,  
13 purposes and functions.

14 C. It shall be the function and main purpose of the Board to  
15 honor those, living or dead, who, by achievement or service, have  
16 made outstanding and lasting contributions to music in Oklahoma or  
17 elsewhere. The Board may adopt such rules as may be needed to carry  
18 out its duties, purposes and functions. Also, it may conduct  
19 surveys and polls and may appoint such committees and  
20 representatives as it may determine necessary or desirable.

21 D. The Board shall be responsible for selecting a suitable site  
22 and/or facility in Muskogee, Oklahoma, which shall be dedicated to

1 the research, archiving and display of Oklahoma's musical heritage  
2 and the individuals contributing to such heritage.

3 E. The Board may:

4 1. Solicit and accept donations, contributions and gifts of  
5 money and property;

6 2. Expend funds donated or contributed for its support;

7 3. Acquire and hold real estate or interest therein or personal  
8 property in its own name; and

9 4. Charge admission fees.

10 SECTION 2. AMENDATORY 74 O.S. 2001, Section 3907, as
