BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 59 O.S. 2001, Section 199.14, as  
amended by Section 8, Chapter 56, O.S.L. 2003 (59 O.S. Supp. 2005,  
Section 199.14), is amended to read as follows:

Section 199.14 A. The following fees shall be charged by the  
State Board of Cosmetology:

9 B. In addition to the fees specified in subsection A of this  
10 section, the Board shall charge a total penalty of Ten Dollars  
11 (\$10.00), as provided for in Section 199.10 of this title.

12 C. Any person licensed as an advanced operator prior to July 1,  
13 1985, may renew the advanced cosmetologist license annually by  
14 payment of the fee required by this section and by being in  
15 compliance with the rules promulgated by the State Board of  
16 Cosmetology.

17 SECTION 2. This act shall become effective July 1, 2006.

18 SECTION 3. It being immediately necessary for the preservation  
19 of the public peace, health and safety, an emergency is hereby  
20 declared to exist, by reason whereof this act shall take effect and  
21 be in full force from and after its passage and approval.
