**[crimes and punishments - state of emergency -
emergency]**

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 21 O.S. 2001, Section 1321.4, is
amended to read as follows:

Section 1321.4 (a) The Governor during the existence of a
state of emergency, by proclamation, may, in the area described by
the proclamation, which said proclamation shall not cover any part
or portion of the state not affected by public disorder, disaster,
or riot at the time said proclamation is issued, prohibit:

(1) any person being on the public streets, or in the public
parks or at any other public place during the hours declared by the
Governor to be a period of curfew;

(2) a designated number of persons, as designated by the
Governor, from assembling or gathering on the public streets, parks,
or other open areas of this state, either public or private;

1 (3) the manufacture, transfer, use, possession or
2 transportation of a molotov cocktail or any other device, instrument
3 or object designed to explode or produce uncontained combustion;

4 (4) the transporting, possessing or using of gasoline,
5 kerosene, or combustible, flammable, or explosive liquids or
6 materials in a glass or uncapped container of any kind except in
7 connection with the normal operation of motor vehicles, normal home
8 use or legitimate commercial use;

9 ~~(5) the possession of firearms or any other deadly weapon by a~~
10 ~~person (other than a law enforcement officer) in a place other than~~
11 ~~that person's place of residence or business;~~

12 ~~(6)~~ the sale, purchase or dispensing of alcoholic beverages;

13 ~~(7)~~ (6) the sale, purchase or dispensing of other commodities
14 or goods, as he reasonably believes should be prohibited to help
15 preserve and maintain life, health, property or the public peace;

16 ~~(8)~~ (7) the use of certain streets, highways or public ways by
17 the public; and

18 ~~(9)~~ (8) such other activities as he reasonably believes should
19 be prohibited to help preserve and maintain life, health, property
20 or the public peace.

21 (b) In imposing the restrictions provided for by this act, the
22 Governor may impose them for such times, upon such conditions, with

1 such exceptions and in such areas of this state ~~he~~ the Governor from
2 time to time deems necessary.

3 SECTION 2. It being immediately necessary for the preservation
4 of the public peace, health and safety, an emergency is hereby
5 declared to exist, by reason whereof this act shall take effect and
6 be in full force from and after its passage and approval.
