4 SENATE BILL NO. 1405 - By: MORGAN and WILSON of the Senate and HIETT  
5 and LIOTTA of the House.

6 An Act relating to the State Capital and the Capitol  
7 Building; amending 73 O.S. 2001, Section 15.1, which relates  
8 to management and control of space in the State Capitol  
9 Building; requiring renovations to certain space to be made  
10 in certain manner; and providing an effective date.

11 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

12 SECTION 1. AMENDATORY 73 O.S. 2001, Section 15.1, is  
13 amended to read as follows:

14 Section 15.1 A. The Legislature shall have management and  
15 control of the following space in the State Capitol Building:

16 1. The space on the third, fourth, fifth and sixth floors;

17 2. The space in the basement that is occupied by the  
18 Legislature on June 1, 1995;

19 3. Approximately six thousand nine hundred thirty-nine (6,939)  
20 square feet of space in the west wing of the first floor that is  
21 occupied by the Department of Libraries on June 1, 1995;

22 4. Approximately six thousand six hundred ninety-one (6,691)  
23 square feet of space in the west wing of the basement that is  
24 occupied by the Department of Libraries and the Department of  
25 Central Services on June 1, 1995;

1           5. Approximately three thousand seven hundred seventy (3,770)  
2 square feet of space in the west wing of the basement that is  
3 occupied by the Department of Central Services on June 1, 1995;

4           6. Approximately two thousand one hundred (2,100) square feet  
5 of space in the center of the basement that is occupied by the  
6 Department of Central Services and the Office of State Finance on  
7 June 1, 1995;

8           7. Approximately six hundred (600) square feet of space in the  
9 center of the basement that is occupied by the Department of Central  
10 Services on June 1, 1995;

11          8. Approximately two thousand three hundred one (2,301) square  
12 feet of space in the center of the basement that is occupied by the  
13 Department of Central Services on June 1, 1995; and

14          9. Upon completion of the project authorized in Section ~~4~~ 321  
15 of this ~~act~~ title, approximately twelve thousand five hundred sixty  
16 (12,560) square feet of space in the west wing of the first floor  
17 that is occupied by the Office of the Attorney General on June 1,  
18 2001; provided, upon the Office of the Attorney General vacating  
19 such space, any renovations thereto shall be made in such a manner  
20 as to ensure preservation and maintenance of the cultural and  
21 historic integrity of the Capitol.

22          B. The authority of the Legislature to allot space may be  
23 delegated to the President Pro Tempore of the Senate and the Speaker

1 of the House of Representatives. Each House of the State  
2 Legislature shall have the exclusive charge of the purchase, use,  
3 allotment, and disposition of its respective chambers, committee  
4 rooms, fixtures, furniture, supplies, and apparatus, and shall be  
5 responsible for the use and preservation of same.

6 SECTION 2. This act shall become effective November 1, 2006.
