SENATE BILL NO. 1515 - By: LAWLER and CORN of the Senate and BRANNON and WINCHESTER of the House.

[agriculture - Oklahoma Farm to School Program Act -
codification - effective date]

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 5-60.1 of Title 2, unless there is created a duplication in numbering, reads as follows:

This act shall be known and may be cited as the "Oklahoma Farm to School Program Act".

SECTION 2. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 5-60.2 of Title 2, unless there is created a duplication in numbering, reads as follows:

A. The Legislature recognizes that:

1. Farm to School Programs link schools and Oklahoma farms in order to provide schools with fresh and minimally processed farm commodities for inclusion in school meals and snacks, to help children develop healthy eating habits, and to improve Oklahoma farmers' incomes and direct access to markets; and

1 2. The benefits of Farm to School Programs often include
2 activities that provide students with hands-on learning
3 opportunities, such as farm visits, cooking demonstrations, and
4 school gardening and composting programs, and integrate nutrition
5 and agriculture education into school curricula.

6 B. It is the intent of the Legislature that school districts
7 encourage the implementation of the Oklahoma Farm to School Program
8 which will emphasize the purchase of locally and regionally produced
9 foods in order to improve child nutrition and strengthen local and
10 regional farm economies.

11 C. A successful statewide Farm to School Program will require
12 the resources, expertise, and collaboration of a variety of state
13 agencies, including the State Department of Education, the State
14 Department of Health, and the Oklahoma Department of Agriculture,
15 Food, and Forestry, the Department of Human Services and a nonprofit
16 agency that has experience in Farm to School Programs.

17 SECTION 3. NEW LAW A new section of law to be codified
18 in the Oklahoma Statutes as Section 5-60.3 of Title 2, unless there
19 is created a duplication in numbering, reads as follows:

20 A. The Department of Agriculture shall be the lead agency for
21 the Program and shall employ an executive director to administer and
22 monitor the programs and activities related to the Oklahoma Farm to

1 School Program with the advice of and guidance of a nonprofit food
2 policy council.

3 B. The following agencies shall make staff available to the
4 Oklahoma Farm to School Program for the purpose of providing
5 professional consultation and staff support to assist the
6 implementation of this act:

- 7 1. Oklahoma Department of Agriculture, Food, and Forestry;
- 8 2. State Department of Health;
- 9 3. State Department of Education; and
- 10 4. Department of Human Services.

11 SECTION 4. NEW LAW A new section of law to be codified
12 in the Oklahoma Statutes as Section 5-60.4 of Title 2, unless there
13 is created a duplication in numbering, reads as follows:

14 The duties of the executive director shall include, but not be
15 limited to:

- 16 1. Identifying and promoting the critical components of
17 individual Farm to School Programs and advising the agencies on
18 needed actions and strategies to implement the Oklahoma Farm to
19 School Program;
- 20 2. Establishing a partnership with public and nonprofit sources
21 to implement a public engagement campaign and establish a structure
22 to facilitate communication between farmers and school districts;

1 3. Providing leadership at the state level to encourage school
2 districts to develop and improve school nutrition plans using
3 locally grown farm fresh products;

4 4. Conducting workshops, training sessions, and technical
5 assistance to school food services directors, personnel, farmers,
6 and produce distributors and processors regarding the demand for and
7 the availability of Oklahoma farm products; and

8 5. Developing a Farm to School Program website as provided for
9 in Section 5 of this act.

10 SECTION 5. NEW LAW A new section of law to be codified
11 in the Oklahoma Statutes as Section 5-60.5 of Title 2, unless there
12 is created a duplication in numbering, reads as follows:

13 A. The Oklahoma Department of Agriculture, Food, and Forestry
14 shall establish a Farm to School Program website for the State of
15 Oklahoma. A direct link to the Farm to School Program shall be
16 maintained on the State of Oklahoma Government website page.

17 B. The purpose of the Farm to School Program website shall be
18 to assist schools and farmers in the coordination of fresh food
19 procurement.

20 SECTION 6. NEW LAW A new section of law to be codified
21 in the Oklahoma Statutes as Section 5-60.6 of Title 2, unless there
22 is created a duplication in numbering, reads as follows:

1 The Oklahoma Department of Agriculture, Food, and Forestry is
2 authorized to promulgate rules as necessary to carry out the
3 provisions of this act.

4 SECTION 7. This act shall become effective November 1, 2006.
